Re: Request for Access to Records
Freedom of Information and Protection of Privacy Act (FOIPPA)

I am writing further to your request received by the Ministry of Transportation and Infrastructure. Your request is for:

Data usage on a per-month basis from no earlier than March 2013 through to as current as possible on any mobile phone or Internet service provided to the following individuals: Christy Clark, Mike De Jong, Rich Coleman, Todd Stone. Data usage includes: The bytes, megabytes, gigabytes, and so forth that were transferred on their mobile phones or Internet services paid by the government; Details on any data overages and what data limits they have; And if any changes had been made to said limits during this time frame. (Date Range for Record Search: From 03/01/2013 To 03/15/2016)

Minister Todd Stone has two accounts. The one account is a Data Flex Plan only associated with an IPAD. Rogers is only able to go back 18 months and Minister Stone has not gone over this Rogers plan; there is no overage data charge.

The other account Minister Todd Stone has is with Telus. There have been no plans on this account. He has a smartphone data plan of 3GB shared. Telus can go back 17 months. Minister Stone has not gone over his data plan and there are no overage data charges on his account.
