## Re: Request for Access to Records Freedom of Information and Protection of Privacy Act (FOIPPA)

I am writing further to your request received by the Ministry of Transportation and Infrastructure. Your request is for:

## A list of contracts, over \$200,000, with a start date within the time frame. (Date Range for Record Search: From 10/01/2014 To 10/17/2016)

Please find enclosed a copy of the records located in response to your request. These records are provided to you in their entirety. Please note that pages 1-65 of the Ministry of Transportation and Infrastructure's records package is a listing of construction contracts for the time period requested. This list also includes contracts under \$200,000 as well as over, up to October 27, 2016. Pages 66-69 of the records packages are consulting services up to March 31, 2016. The ministry is currently working to collate the current fiscal year records for consulting services contracts from April 1 to October 27, 2016; however, the records will not be available until the New Year. We recommend that you submit a separate FOI request for the remainder of the consulting services contracts records in the New Year. Your file is now closed.
