A copy of the mediation result/settlement between the Ministry and EGRT Construction/SNC Lavalin re: cost overruns and schedule delay of the Evergreen Line project. (Date Range for Record Search: From 03/01/2016 To 12/31/2016)

The Ministry advises the following with regards to the attached records relating to the EGRT Construction I SNC-Lavalin settlement, specifically, a copy of the Settlement Agreement between the Province and Evergreen Rapid Transit Holdings Inc., the Design Build Finance contractor (also known as EGRT):

As part of the public disclosure of the overall financials of the Evergreen Line Rapid Transit Project, the project team provided a technical briefing on project financials to media on November 29, 2016. The technical briefing including the disclosure of the details of the

The settlement, which totaled \$15 million, included \$13.5 million to address EGRT's supervening events claims (specifically in relation to geotechnical issues encountered adjacent to the Inlet Station, and access issues experienced where work was adjacent to the active heavy rail corridor- no compensation was paid in relation to tunnel boring related issues and delays); and \$1.5 million to resolve outstanding disputed change orders on condition that a number of third party issues are settled and owners provide waivers to the Province (which has been done). The Province also released \$150 million of the \$252 million holdback, as it was determined that the major project risks had passed and at that point it would be reasonable to retain approximately \$100 million to secure remaining project risks.

Separate from this settlement, the Province provided compensation of approximately \$2 million with respect to an separate supervening event in relation to undisclosed ground water contamination which was discovered during tunnel boring. Together with the settlement with EGRT, this makes up the \$17 million Province retained/shared risk outlined in the technical briefing.

Your file is now closed.
