*Historical records relating to Highway 16 - the Yellowhead Highway, sometimes also called Highway 16 East - between Prince George and McBride, including: Records of complaints about slow progress on this long-promised road during the years 1945-1960; Records related to planning its route; Correspondence from boards of trade, logging companies, and other parties that were interested in the construction of a modern highway through the Upper Fraser/Robson Valley region, but excluding: Construction contracts or highly detailed survey work, contracts, etc; Papers related to staffing, labour conditions, etc. (Date Range for Record Search: From 01/01/1945 To 12/31/1970)*
