Records on the original registration of Tucker Bay Road, Lasqueti Island, BC in the road registry – note - Tucker Bay Road was first recorded in the Annual Report of the Minister of Public Works in 1925-26 as Trail Reg. No. 103, then in 1926-27 as Road Reg. No. 103. (Date Range for Record Search: From 01/01/1924 To 12/31/1927)

Please find enclosed a copy of the records located in response to your request. These records are provided to you in their entirety.

Please be advised that the Ministry of Transportation and Infrastructures Road Registers begin in the late 1930's, and therefore they do not hold any responsive records with the date range of your FOI request. However, they have provided the related record the Ministry does hold, dating from the year 1935.
