All records regarding Semiahmoo Indian Reserve (Semiahmoo IR1) shown on plan M3187 and known as "Semiahmoo Park" related to the following: flooding, drainage and storm water management in Semiahmoo Park, environmental and geotechnical concerns in Semiahmoo Park, sewer facilities and infrastructure constructed in Semiahmoo Park, the use of Semiahmoo Park by the District of Surrey, the City of Surrey, the City of White Rock, or any associated entity or park commission, funding applied for and provided to the District of Surrey, the City of Surrey, the City of White Rock, or any associated entity or park commission for the use of Semiahmoo Park; All records regarding the inclusion or exclusion of the Semiahmoo Indian Reserve in the boundaries of the City of White Rock; All records regarding the dedication and boundaries of the municipal road immediately to the north of the Semiahmoo Indian Reserve (currently forming part of Marine Drive/8th avenue, formerly known as Campbell River Road). (Date Range for Record Search: From 01/01/1900 To 05/28/2018)
