Regarding a MVA of July 19, 2016 on Highway #5, 1/2 km South of Inks Lake turn off - the Accident Location: A history of accidents that have occurred at the same location and all documents relating to upgrades, embankments and/or drainage at the accident location from July 19, 2013 to present. All documents relating to all motor vehicle accidents on July 19, 2016 in British Columbia, including complaints, internal/external correspondence and memos about the accidents and the Ministry's responses from July 19, 2016 to present. All records from the company or companies responsible for maintenance, engineering, design and construction since the creation of the section of highway, studies or other investigation, including notes, reports, photographs, statements, emails or memos and other documents, considering the accident location from July 19, 2011 to present. (Date Range for Record Search: From 07/19/2011 To 10/10/2018)
