Freedom of Information and Protection of Privacy Act (FOIPPA)

I am writing further to your request received by the Ministry of Transportation and Infrastructure. Your request is for:

All records, including correspondence and documents, referring to an easement granted or proposed to Reum Holdings (also known as Mel Reeves or Melvin Reeves) for access to Skaha Point (also known as Sickle Point). (Date Range for Record Search: From 01/01/2015 To 10/31/2018)

The Ministry of Transportation & Infrastructure has advised that the subject of easement is a matter between the property owner and crown lands. As the Ministry of Forests, Lands, Natural Resource Operations and Rural Development (FLNR) is the administrator of the subject land and the lead on this easement, any records with the Ministry of Transportation & Infrastructure would be duplication of these records. Further, the program area has also advised that easement records are available for a fee through Land Titles (https://ltsa.ca/).

As FLNR has the greater interest in these records, and you have also directed your request to this Ministry, your request will be satisfied by response to your FOI request FNR-2018-87169.
