Records, including but not limited to research material, notes, reports and/or other road history information, that discuss or address road management and/or maintenance pertaining to roads on and within the Bella Bella Indian Reserve (No. 1), located on Campbell Island. Additionally, any records that the Ministry holds regarding road management and/or maintenance for roads which lead off of reserve, in particular Wabalislá Street, Tinkey Avenue, Wakas Drive, Nuda Drive, Koeys Street, Waglisla Street, and Ferry Ramp (This is the name of the road according to the map, it is the road that leads to the ferry in the middle of town). (Date Range for Record Search: From 09/01/1989 To 11/30/2018)
