Freedom of Information and Protection of Privacy Act (FOIPPA)

I am writing further to your request received by the Ministry of Transportation and Infrastructure. Your request is for:

Regarding construction on the Rosedale/Agassiz Bridge taking place on January 13, 2018: Start date and estimated end date of the project; name and contact information for the on-site project manager; the date the construction switched from the southbound to northbound lane; any pictures or diagrams relating to the set up of traffic control devices; engineer report for the traffic control; statements or reports from on-site personnel on scene at the time of the accident; copies of any construction video footage that may have been in place; confirmation of the amount of traffic flowing over the bridge in any given day or week, if this information is monitored; names of any on-site security; any other reports pertaining to a single vehicle accident which occurred on January 13, 2018 on the Rosedale/Agassiz Bridge during construction.

Please find enclosed a copy of the records located in response to your request. Some information has been withheld pursuant to section 22 (Disclosure harmful to personal privacy) of FOIPPA.
