The following records regarding a motor vehicle accident on Highway 20 near Bella Coola, BC, on June 29, 2019, a copy of the Ministry's file, including but not limited to the following: Incident reports; Photographs or video footage relating to the incident; A copy of any statement from [specified] or any third party witnesses or employees; A copy of the maintenance contract with the highway maintenance company; Any written policies regarding barrier walls; Any written policies regarding maintenance and inspection of the accident location; All maintenance records regarding the rock face in question; The details of when the RCMP first notified you of the rocks on the roadway.
