**Re: Request for Access to Records**  
***Freedom of Information and Protection of Privacy Act (FOIPPA)***

I am writing further to your request received by the Ministry of Transportation and Infrastructure. Your request is for:

*All original applications and materials in support of said applications that resulted in the issuance of the following motor carrier licences: Cantrail Coach Lines Ltd. (Motor Carrier Licence 59968); Quick Coach Lines Ltd. (Motor Carrier Licence 61871). In addition, any original applications and materials in support of said applications that resulted in the issuance of the following motor carrier licences: Greyhound Canada Transportation Corp. (Motor Carrier Licence 51380); Greyhound Lines Inc. (Motor Carrier Licence Unknown), which authorized a licence or special authorization for transportation services from Vancouver to the Washington State border. In addition, any original applications and materials in support of said applications that resulted in the issuance of a motor carrier licence, special authorization, or any other authorization, to Boltbus (which is exclusively owned and operated by Greyhound Lines, Inc.).*

*(Date Range for Record Search: From 1/1/1941 To 12/8/2019)*
