

# Decision Note Advice to Minister

**Date:** May 19, 2015 **Cliff #:** 98975

Issue: Authority to approve property acquisitions and disposals by public post-secondary institutions.

# **Recommendation / Next Steps:**

**Next steps:** The delegation can be effected by approving the recommended option in the signature box of this decision note.

# **Background / Facts:**

- Under section 50(2) of the University Act, universities require approval of the Minister of Advanced Education to dispose of property. Universities do not require approval of the Minister of Advanced Education to acquire property.
- Under section 50(2) of the *College and Institute Act*, colleges and institutes require the approval of the Minister of Advanced Education and the Minister of Finance to acquire or dispose of property.
- The DM has authority to approve acquisitions and dispositions under the *Interpretation Act*; no formal delegation is required.
- Current Ministry practice is that all requests for approval to acquire or dispose of property by public post-secondary institutions (PSIs) are decided by the Minister.
- Ministry of Finance practice is that all requests for approval to acquire or dispose of property by colleges and institutes are decided by the Deputy Minister.
- In 2014, the Ministry received 28 requests for approval to acquire or dispose of property.

### **Analysis:**

Based on Interpretation Act definitions of "acquire" and "dispose", the approval requirement for
acquisition or disposal of property includes not only sales and leases, but also statutory rights of way,

easements and other dispositions where the PSI retains ownership and possession of the land.

- PSIs have raised concerns that the length of time the Ministry takes to process approvals is hindering their ability to conduct day-to-day business and realize maximum value from real estate transactions.
- Approximately 80 percent of acquisitions and disposals are valued at \$15 million or less. Examples
  include grants of statutory rights of way to utility companies; the purchase and sale of residential
  properties by Northern Lights College for the purpose of its home building program (students build a
  residential home on bare land as part of their educational program and the profit realized on the sale
  is re-invested in the program); and routine sales and leases of property that have limited, if any,
  public policy implications or financial impact on government.

# University Act

### **Property**

- 50 (2) Subject to the approval of the minister and to the terms of any grant, conveyance, gift or devise of land, a university may
  - (a) mortgage, sell, transfer, lease for not more than 99 years, or otherwise dispose of its land, and
  - (b) lease for any term any of its land to a college affiliated with the university.

# College and Institute Act

# Institution is an agent of the government

50(2) An institution may, in its own name, carry out its powers and duties under this Act and, with the consent of the minister and the Minister of Finance, acquire and dispose of land or buildings.
