"1. Course and Program Approval

All training activities proposed as continuing education or contract services offerings will be reviewed and approved by the Vice President / Administration & Student Services or designate. This review will ensure that the activity falls within an approved category and is in compliance with the terms and conditions of University collective agreements. All programs and courses proposed within Category III will require the approval of the University Curriculum Committees."

Category III refers to contract training generally ("Courses, programs or special events developed in partnership with local Canada Employment Centers, business, industry or other agencies that meet specialized learning needs or respond to specific skills shortages. This category includes indirect purchases or training by contract with E.I.C., labour development boards, other funding agencies or extension courses offered in partnership with other departments of the University.") It's unlikely that this course was considered a Category III.

As pointed out in the article, the content of this course deals strictly with the existing and under-development regulations imposed by the federal government for operating as a licensed distributor of medical marijuana.
