Topic	Description
Labour Market Transfer Agreements (LMTA)	 Since 1996, the federal government has provided provinces and territories funding for employment and skills training programs and services via labour market transfer agreements (LMTA). Goal is to ensure the next generation of (LMTAs) are client-centered, outcomes focused, inclusive flexible and responsive, and evidence-based to meet the needs of Canadian workers and employers. To date Quebec, Alberta and Ontario have communicated that they have initiated bi-lateral discussions.
Forum of Labour Market Ministers (FLMM)	 Created in 1983 to promote discussion and cooperation on common labour market matters. Co- chaired by the federal government (Employment and Social Development) and a lead province (currently the Government of Saskatchewan). 2017/18 priorities: LMTA, LMI, demand-led training/best practices, labour mobility/foreign qualifications recognition and strengthening apprenticeships.
Council of Ministers of Education, Canada (CMEC)	 Education is a provincial responsibility under the Constitution. All provincial and territorial ministers responsible for education across Canada are members of CMEC. There is no federal government representation in this forum. The Council is a forum to discuss educational issues, represent Canadian education abroad, undertake various education-related programs, and consult and cooperate with the federal government and other national educational organizations.
Programme for International Student Assessment (PISA)	 Survey of 15 year old students in literacy, numeracy and science held every three years. Administered by the Organization for Economic Cooperation and Development (OECD). The federal government funds the cost of the survey in Canada.
Programme for the International Assessment of Adult Competencies (PIAAC)	 Survey of adults aged 16-65 in literacy, numeracy and problem solving in technology rich environments held every ten years. Administered by the OECD. The federal government funds the cost of a national level survey; provinces and territories can opt to fund oversampling to gain provincial level surveys.
StudentAidBC (SABC)	 Student financial assistance in BC operates as StudentAid BC (SABC). SABC administers both the provincial program and the federal component of the program on behalf of the Government of Canada. SABC provides a range of need-based repayable loans, and non-

	repayable assistance in the form of grants and debt reduction measures, with funding awards based on dual federal and provincial assessments of financial need. Total provincial and federal awards to B.C. applicants were \$666M in 15/16. Approximately 63,600 borrowers in total, including about 57,500 full-time and about 6,100 part-time students received assistance in 2015/16.
Indigenous Post- Secondary Education	The Post-Secondary Student Support Program is administered by Indian and Northern Affairs Canada (INAC), and provides financial support for eligible First Nations and Inuit learners attending post-secondary institutions. The funding levels for the program have been a longstanding concern; until this year, increases to the budget have been limited to 2%. As a result of the funding cap and significant increases to the cost of post-secondary education, the number of students supported annually decreased. The 2012 Aboriginal Post-Secondary Education and Training Policy Framework includes a specific action about advocating that the federal government increase the budget for the program. The Truth and Reconciliation of Canada report included a similar Call to Action. Based on comments made by the federal Minister of INAC, FNESC is concerned that the federal government may be moving away from non-repayable assistance for Indigenous learners, towards student loans.
Co-op Programs	In its 2016 budget, the Federal Government allocated \$73 million over four years to support new co-op placements and work-integrated learning opportunities for post-secondary students, focusing on science, technology, engineering, mathematics and business programs. Funding is being provided to national industry organizations.

Issue: Approach to restoring funding for tuition-free Adult Basic Education and English as a Second Language training at public post-secondary institutions, effective September 1, 2017

Background:

- Eighteen of the 25 public post-secondary institutions (PSIs) in BC deliver Adult Basic Education (ABE) and/or English as a Second Language (ESL) training. School districts also deliver ABE programs, but not ESL for adults.
- Effective January 1, 2015, provincial tuition policy changed, allowing public post-secondary
 institutions to charge tuition for ABE and ESL programs up to \$1,600 per full-time semester.
 Most institutions charge student fees in addition to tuition.
- ABE and ESL are pre-post-secondary programs designed to improve learners' literacy, numeracy, language and academic skills in order to continue into post-secondary education and find new or better employment.
- An ABE student may be missing one or more credits towards a secondary graduation diploma, or need a higher mark or new pre-requisite to enter a post-secondary program.
- ESL students in the public post-secondary system are typically immigrants and refugees who may
 have a post-secondary credential from another country and require higher English language skills
 for employment.
- The Adult Upgrading Grant (AUG) provides financial assistance to eligible low-income students in ABE, ESL and Adult Special Education¹ programs at public post-secondary institutions for wrap around supports such as student fees, books, transportation and childcare.

 Several institutions have policies that limit students to two registrations in the same course unless exceptional circumstances present.

Analysis:

A two phased approach is recommended for implementation of tuition-free ABE and ESL.

Phase 1: Initial Implementation

- Implementation of tuition-free ABE and ESL effective September 1, 2017
- No legislative or regulatory amendments or Orders-in-Council are required to implement this
 policy change. The Minister of Advanced Education, Skills and Training has legislative authority

Background / Facts:

It is the authoritative source for accurate and relevant information on education around the world. It provides data on the performance of the education systems in OECD's 34 member countries and a set of partner countries, including non-member G20 nations.
- Canada has volunteered to host the 2018 NESLI annual conference. It will take place
 March 12-14, 2018. As BC will be the Chair of CMEC, it has been suggested that the meeting be held
 in Vancouver.
- The CMEC Secretariat will manage all the logistics of the conference including meeting room and hotel accommodations. There will be about 40-50 delegates from OECD countries who are expected to attend.



Background / Facts:

- As indicated in a July 28, 2017 letter from the Deputy Minister of Finance on the Crown Service Plan Guidelines, updated mandate letters for Crown Corporations have been prepared for Minister and Board Chair signatures.
- On August 11, 2017, the Crown Agencies Resource Office (CARO) provided the Ministry with the updated Cabinet-approved Mandate Letters for BCCIE and the ITA.



Issue: Request from the University of Victoria (UVic) to fund operating and capital costs for a new

Indigenous Law Degree Program

Background / Facts:

- UVic is developing an Indigenous Law Degree Program (see Attachment 1) and is requesting operating funding:
 - \$1.8 million in on-going funding;
 - o Up to approximately \$20 million in support of the capital costs for an Indigenous Legal Lodge
- The program would train legal professionals who are able to work across Indigenous and non-Indigenous legal traditions.
- The 4-year program aims to produce 25 graduates annually, with a total enrolment of 100 full-time equivalent (FTE) student spaces at steady state.
- UVic has shared the proposal with the Minister of Finance and the Minister of Indigenous Relations and Reconciliation.
- The Ministry of Advanced Education, Skills and Training (AEST) became aware of the initiative in late 2016, when the President of UVic met with the former Deputy Minister on the issue.





Background:

- The Association of Professional Engineers and Geoscientists of the Province of British Columbia (APEGBC) is a self-regulating professional association constituted under the *Engineers and Geoscientists Act (Act)*, which is administered by the Ministry of Advanced Education, Skills and Training (Ministry).
- The association has recently rebranded itself with a new business name, Engineers and Geoscientists of British Columbia. This change does not affect the association's legal name, which is defined in the Act as the Association of Professional Engineers and Geoscientists of the Province of British Columbia.
- The Act requires APEGBC to uphold and protect the public interest in the practice of professional engineering and professional geoscience, and to establish, maintain, and enforce standards for the qualifications and practice of its 34,000 members and licensees.
- Members are entitled to use the designations "Professional Engineer" or "Professional Geoscientist" and membership is mandatory to practice the professions as they are defined in the Act. Both engineering and geoscience are professions with a restricted scope of practice as defined in the Act.

Governance:

- The Act dates to 1920 and has been amended many times, but not comprehensively.
 APEGBC has called for a substantial rewrite of the Act for several years. Understanding a new Act is not possible in the near future, APEGBC has sought smaller packages of legislative amendments to enable it to continue to uphold its public protection mandate.
- The last amendments were enacted in 2012, providing for additional disciplinary tools, permitting easier admission of qualified professionals from other jurisdictions, and governance changes.

- Government's role in the regulation of the professions of engineering and geoscience is to manage the enabling legislation and carry out several specific appointment and review functions provided in the *Act*.
- Four Council members are appointed by Lieutenant Governor in Council (LGiC) for two year terms.
- Any bylaw passed by APEGBC may be disallowed by the LGiC within 45 days of its filing with the Minister.

Student Housing

Background

• On Sep 5/16, the Alliance of BC Students (ABCS) released a white paper, entitled *Where's the Housing?*, calling for a provincial capital investment of \$18 million per year over 10 years to accelerate the construction of on-campus housing (10% of the estimated \$1.8 billion of investment required).

 ABCS representatives met with a former Minister of Advanced Education in March 2017 to discuss a number of issues, including student housing. However, no outcomes from the meeting were shared with Ministry staff and no formal Ministry response to the paper was issued.

Government Mandates

- The Ministry of Municipal Affairs and Housing has been mandated to build 114,000 affordable rental, non-profit and co-op units through partnerships over the next 10 years.
- This mandate includes the creation of new student housing and the removal of "unnecessary rules" that prevent universities and colleges from building affordable student housing:
 - Institutions have not been able to borrow funds to build new student housing because this
 would add to the provincial debt and affect BC's credit rating. Only the University of British
 Columbia and Simon Fraser University have been able to build new student housing
 residences in recent years due to their financial reserves and land development revenue.
 - Institutions have been restricted by accounting rules from using year-end surpluses for deferred capital contributions.
- Increasing the supply of affordable housing is part of the 2017 Confidence and Supply Agreement between the BC New Democrat Caucus and the BC Green Party Caucus.

Key messages:

Tenants' Rights: (With advice from the Office of Housing and Construction Standards) s.13

- Section 4(b) of the RTA states the Act "does not apply to accommodation owned or operated by an educational institution and provided by that institution to its students or employees." BC's legislation is similar to legislation in other provinces across Canada.
- Other possible types of accommodation exempt from the RTA include special purpose housing, such as transitional housing, vacation accommodation, and living accommodation in community care facilities.
- For student accommodations, only dorm-style housing was exempt up to 2002. After 2002, self-contained apartments and townhouses were also exempt due to a situation at UBC's Acadia residence where a student refused to leave after completion of their studies.
- In lieu of the Act, each institution with student housing requires students to enter into contracts outlining rights and responsibilities, which may differ by institution. Students can pursue resolution of disputes through the institution's appeal process or through the provincial court system.

Issue: Ontario Student Assistance Program (OSAP) Transformation Initiative

Background / Facts:

- The Province of Ontario's Budget 2016 announced several changes to its Student Financial Assistance (SFA) program including a re-profiling of existing SFA funds and the elimination of some provincial tax credits
- The changes were estimated to be cost-neutral through the re-allocation of previous provincial spending on SFA. However, Ontario has since publicly stated that their applications have risen by 20%.
- OSAP changes implemented in 2017/18 include:
 - Several student grant and loan reduction programs were consolidated into an up-front Ontario Student Grant (OSG) for full-time students.
 - With the recent 50% increase in federal grant funding, OSAP is able to offer combined federal/provincial grants equal to or greater than Ontario's average college or university tuition for students from families with incomes of \$50,000 or less (i.e., "free tuition").
 - Weekly provincial loan maximums were increased from \$155 to \$180/week for single students and from \$355 to \$450/week for married and sole-support students¹.
- OSAP has announced further changes for 2018/19 implementation, including:
 - Expanding the availability of loans for students from middle and high-income families by raising income thresholds for parental contribution to align with federal thresholds (i.e., from current \$68,000 to \$86,000 gross annual income).
 - Work with institutions to implement a Net Tuition Billing System which considers grant and other financial aid in the calculation of tuition fees. Students are billed for the remaining amount.

Background:
