

Q. Universities and colleges will be hard hit with the new employer health tax. Is there money in the budget to cover the shortfall?

- 1. The previous government downloaded regressive, unfair MSP premiums onto people.
- 2. We cut MSP premiums by 50% effective January 1st, 2018.
- 3. MSP premiums will be totally gone by January 1st, 2020.
- **4.** The transition period will allow us to have conversations with each of our 25 public post-secondary institutions on their own unique situation.
- 5. <image002.png>Cuts of \$50 million started in 2013.
- 6. Cuts of \$6.9 million for ABE started in 2014.
- 7. Cuts of \$17.1 million for ESL programs started in 2014.
- **8.** We will work through the changes to ensure we protect students by keeping post-secondary education accessible and affordable.
- **9.** In Budget 2018, we're allowing affordable housing to be built by universities and colleges. We're investing in more tech spaces as well as making it free for former youth in care to attend post-secondary education.
- 10. I'm proud to be part of a government that's investing in education.

Q. You met with Langford's mayor yesterday. Are there plans for increasing post-secondary education opportunities to the West Shore?

1. Our government wants people to be able to access the post-secondary education and training needed for good-paying jobs.

- 2. RRU is going to look at ways to improve access to post-secondary education in the West Shore in partnership with Camosun and UVic as well as municipalities and the school district.
- 3. It's way too early to speculate on the delivery, cost or type of programs.

Q. What are you doing to support B.C.'s booming tech sector?

- 1. Our post-secondary system produces world-class tech talent that supports a booming tech sector along with opening the doors to good-paying jobs. But there's been no significant investment in tech spaces for over a decade.
- 2. We're adding 2,900 tech spaces to produce 1,000 additional tech-grads a year by 2023. This includes the first full civil and environmental engineering program in the North at UNBC and the first full software engineering program in the Interior at TRU.
- 3. We're providing \$67.7 million over the next 3 years to support the techexpansion. This is expected to ramp up to \$42 million a year.

Q. Are you still committed to delivering a completion grant, scholarships for graduate students and scrapping loan interest?

- 1. Budget 2018 demonstrates our commitment to making life more affordable and delivering services people, including students, depend on. It includes:
 - Eliminating MSP premiums effective January 1st, 2020.
 - o Launching a comprehensive housing plan.
 - Making child care more affordable
 - o Bringing down the cost of prescription drugs.
 - Increasing support for former youth in care.
- 2. Work is underway on all of the mandate commitments to ensure we deliver programs that work for students and build the best B.C.
- 3. We've been quick to tackle affordability and accessibility of education with tuition free ABE, tuition waivers, cutting interest on student loans and investing in tech and trades seats.
- 4. Budget 2018 includes education and training investments:
 - o Confirmation of tuition-free ABE and ELL programs.
 - Hundreds more ECE spaces.

- More tech, computer science and engineering spaces.
- o Half-a-billion dollars for 5,000 new on campus student beds.
- 5. In February 2018, the ministry provided 17,000 students with \$32 million in loan reduction grants to reduce provincial loan debt based on financial need.

Q. How do you plan to address the shortage of skilled tradespeople?

- 1. I've been on the job for just 8 months, while skilled labour shortages are years in the making.
- 2. Apprenticeships are essential to our future workforce, that's why we're:
 - Increasing opportunities for apprentices to gain on the job experience and complete their training.
 - Making sure women, Indigenous groups have a fair opportunity.
 - Promoting local hiring for government projects.
- 3. We're working with industry and employers to determine an **effective apprenticeship ratio** for government construction projects. We will maximize our \$15.8 billion investment to train future construction workers.
- 4. We've launched a more flexible **Workforce Development Agreement** worth \$685 million. New programming will ensure **employers** benefit from investments in skills training, while **workers** benefit from support and training for good-paying jobs.
- 5. In August 2017, we announced \$1.67 million for 562 additional trades' seats to meet labour market demand.
- 6. Earlier this month, we announced \$5.4 million to replace outdated trades and tech equipment so student can learn on industry standard equipment.
- 7. Our government is committed to thoroughly **examining compulsory trades from all angles** and encouraging an ongoing dialogue amongst stakeholders.
- 8. Directives in the ITA mandate letter:
 - Build on the expansion of youth trades programs, and increase work experience opportunities for youth apprentices in high school.
 - Support a review of how compulsory designation could improve worker health and safety, consumer protection and environmental safety for certain trades.
- 9. We're investing \$1.8 million over the next two years to recruit, retain and advance women in the construction trades.

The B.C. government, through the Ministry of Municipal Affairs and Housing, and the Columbia Basin Trust are investing a combined \$220,000 in capital funding for the project. The Province is also providing interim financing of \$297,000.

Once rezoning and renovations are complete, people are expected to move into their units by June 2018. This will be just in time for any tenants who have signed up for summer courses at nearby Valemount College.

The Valemount Learning Society initially recognized a need for this type of housing in the community and is partnering with the Valemount Affordable Rentals Society to operate and manage the building and serve the tenants who will be living there.

This project is part of the Province's commitment to build 114,000 affordable homes, including market rental, non-profit, supported social housing, co-op and owner-purchase housing through partnerships.

Budget 2018 launched the biggest investment in housing affordability in B.C. history – more than \$7 billion over 10 years.
