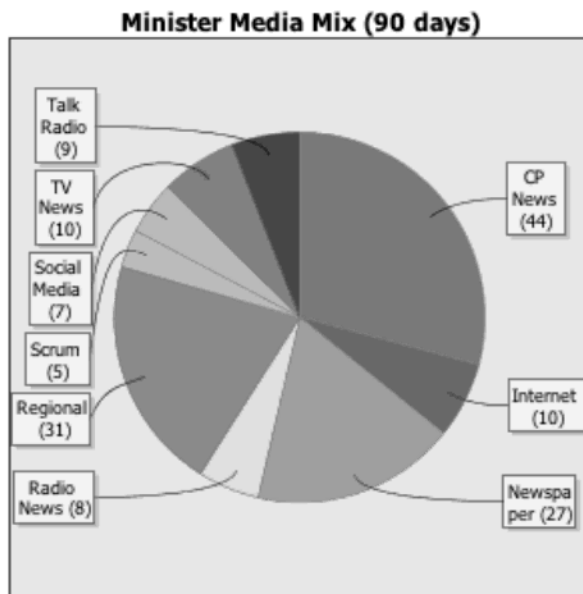

Statement on Supreme Court of Canada decision

VICTORIA – The following statement was issued by Advanced Education, Skills and Training Minister Melanie Mark in response to the decision released today by the Supreme Court of Canada.

“Government has been following this case as it worked its way through the courts. The decision just came down and we will be taking the time to carefully review the ruling but it appears consistent with our government’s values. 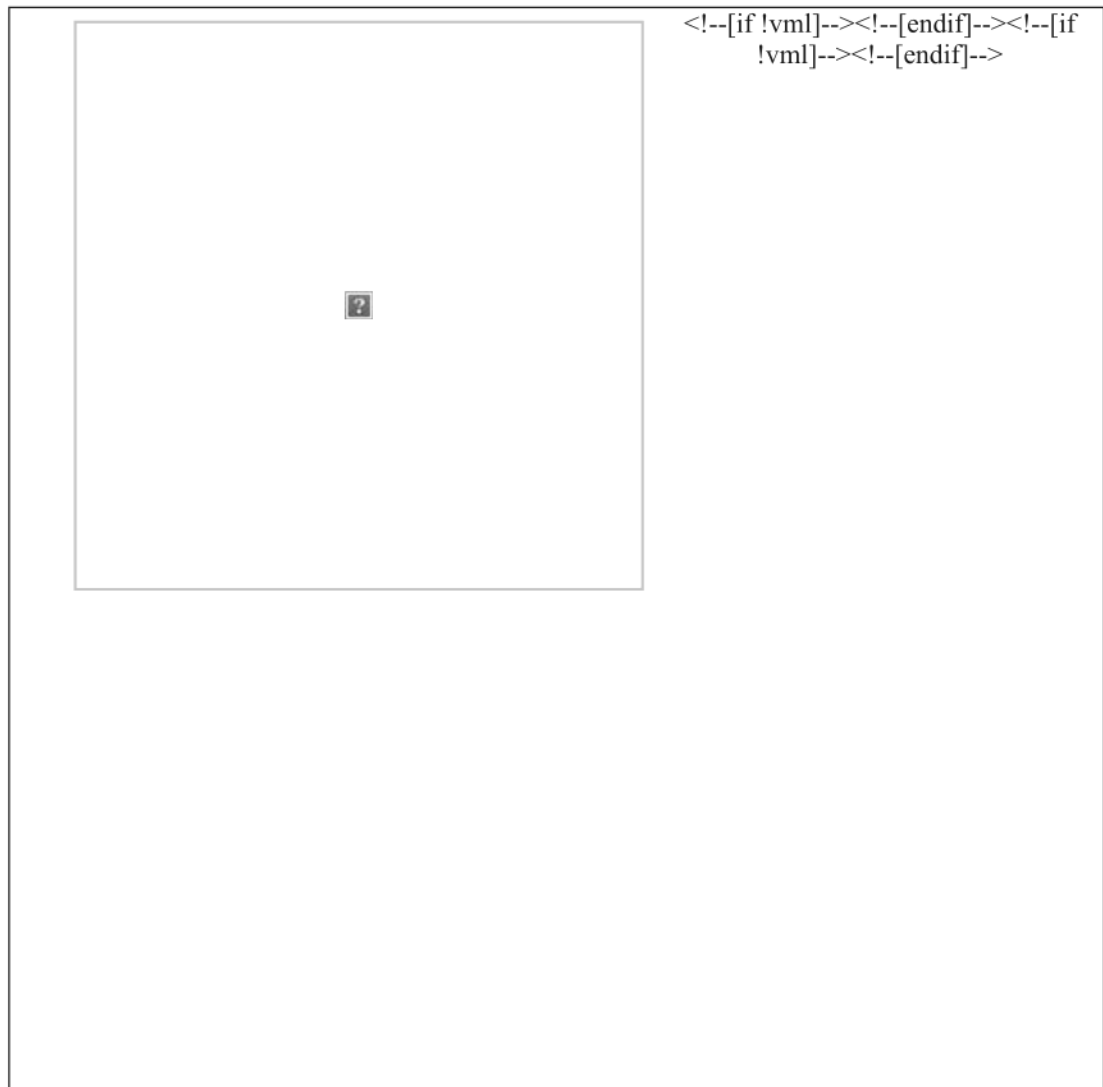

Hi – Ken called me this afternoon to give me/us a heads up that he will be making an announcement on Friday at the local School District's graduation ceremony. He's going to be announcing free tuition to every graduate from that SD for their first year at NVIT, provided they register by July 31st (e.g., make an immediate transition).
