Good morning – any concerns with providing this background information to BiV?

Hi Nelson; We're working on scheduling an interview for the week of Jan. 7 with Minister Mark. In the meantime, here's some background data.

- There are over 35,000 adult apprentices, over 5,000 youth program participants, and over 4,000 foundation students in B.C.
 - 9% of apprentices are women.
 - 7% of apprentices are Indigenous.
- Half of all apprentices were in one of the following trades: construction electrician, carpenter, heavy duty equipment technician or truck and transport mechanic.
- According to the 2018 edition of the B.C. Labour Market Outlook, 903,000 job openings are expected in B.C. by 2028 due to retirements and economic development. Approximately 8% - 70,908 - will be in the trades.
- High-demand trades occupations include millwrights, heavy duty mechanics and carpenters in industries such as construction, manufacturing and forestry. A lot of the skills are transferable to other industries such as LNG.
- Construction of the LNG Canada facility and the associated natural gas pipeline will generate additional demand for construction trades workers over the five-year construction period. The impact of this increase in demand on future job openings will be incorporated into the 2019 edition of the B.C. Labour Market Outlook.
- Government invests about \$97 million a year in trades seats through the Industry Training Authority (ITA).
- The ITA manages more than 100 trades programs in B.C. – from arborists to saw filers to welders – 49 of which are Red Seal programs.

- The ITA expects to fund more than 27,000 apprenticeship and foundation training seats this year at public and private institutions.
- The Ministry of Jobs, Trade and Technology is co-ordinating the Workforce Development Advisory Group. Participants include industry, labour groups, the ITA, trainers and First Nations. The group is working to ensure British Columbians are in line for construction and operations opportunities. The group includes representation from AEST. The group's immediate focus is on LNG but it also plans to consider other major projects.

Request

I am working on a piece about the new BC climate plan and how it may impact and be impacted by UBC research. Would it be possible to receive comment from the Minister on how she sees UBC and post-secondary institutions in general supporting the achievement of the plan's goals? Are there any areas of the plan that she feels UBC will be particularly vital to realizing?

Recommendation

Statement from a ministry spokesperson:

Climate change remains one of the greatest challenges of our generation. The 25 public post-secondary institutions in B.C. are up for the challenge and have the capacity to deliver. They are training the leaders of tomorrow in climate policy and climate research, and government is going to build up the next generation for the green economy.

The CleanBC strategy outlines the Province's first phase of actions to help meet the 2030 greenhouse gas reduction targets. A feature of the strategy is supporting new jobs and skills as we transition to a low-carbon economy.

While people have a wide range of education and training opportunities to support a low-carbon economy, we know more needs to be done.

Our gov't is developing a CleanBC Labour Readiness Plan with completion expected by October 2019 following extensive labour market research and public consultation. The plan will identify areas of job growth and what skills are needed to meet demand and ensure students and apprentices can access training programs.

Government will work with post-secondary partners such as UBC, Industry Training Authority and stakeholders to implement the CleanBC Labour Readiness Plan.
