

The proposed amendments apply the Private Training Regulation (PTR). They are minor changes primarily intended to correct errors, remove duplications, and clarify requirements

The *Private Training Act* and the PTR set out protections for students (such as the creation of a student tuition protection fund to reimburse students that have been misled) and obligations for private training institutions in British Columbia, including various notice and reporting requirements.

AEST's amendments to the PTR can all be made by Ministerial Order and do not require Cabinet approval or legislative amendment.

If approved by the Minister, they would be announced as part of Better Regulations for British Columbians Day – March 6, 2019.

Good Morning,

I'm checking in today from the community of Gitxaala and I wanted to update you on a few learnings that have had a really profound impact on some of the things to be aware of when teaching people to drive.

So far our classes and in car training has been dominated by women which I thought was interesting. Mostly it's been women on average 35 and up and many grandmothers in the car. We are just now seeing some young men and of course across the board we are having conversations about how many people are in fact driving without a license. This also applies to band owned vehicles and in some cases vehicles such as sand trucks which are contracted to BC Hydro are being driven on highways by people without a license which leaves the Nation very vulnerable to being sued and the driver doesn't have the experience. (I can explain on a call.)

What has been my biggest 'Ah-Ha" moment to date...

Older women are requesting to not learn to drive from a man because of the sexual abuse in the past. I thought this was really brave that they shared this. They also explained to me that during the 60's scoop when they were put into foster care the foster parents didn't want to let them use their car to drive and that driver training in these remote communities didn't exist or they didn't have the money to learn. So one day you wake up and you're 50 and you never learned to drive and then you didn't teach your kids. So we have a generational cycle of restricted mobility.

Yesterday it also hit me that for many their first memory of being taken from their family was being loaded into a car.

Right now we are seeing just how brave people are being by taking back control of this experience and what they are sharing is some days overwhelming. They know that as much as a vehicle was a tool of hurt and abuse it is also a tool of opportunity and it's having a much more profound effect than we originally thought when I hoped this would help people go to work.

Subject: Estimates process

Hi all,

With estimates slated to begin at the end of next week I wanted to give a brief run through of how it works and what we have scheduled.

Review of how it works:

For those that are unfamiliar with it, estimates it the main way in which opposition gets to question the government on its finances. Estimates in BC usually takes place in either the main chamber (also called Committee B / the Big House) or in the Douglas Fir Room (also called Committee A / the Little House). The opposition gets to nominate three estimates to take place in the big house while all others occur in the little house. During estimates, ministers will answer questions from the opposition on almost anything that refers to their ministry.

Your minister must be present for the duration of their estimates and you should coordinate with your DM's office to ensure they are appropriately briefed ahead of time and that the required ministry staff are present with them during estimates. If you have specific concerns about the order/timing of individual topics, crown corporations, etc, please reach out to your opposition critic to coordinate.

The schedule:

Estimates will begin in the afternoon on Feb 28th. The little house will begin that afternoon and continue meet until all estimates are complete. The big house may go between debating legislation or estimates depending on the schedule. In addition to the main budget estimates, this year we also have supplementary estimates and some ministers will therefore have two sets of estimates. **Supplementary estimates will take place in both the little house and big house starting next Thursday and likely finish by the end of day on Monday March 4**th. Below is a list of affected ministries and the order in which they will take place:

Supplementary estimates:

- 1. Advanced Education, Skills & Training
- 2. Attorney General
- 3. Children & Family Development
- 4. Citizens' Services
- 5. Energy, Mines & Petroleum Resources

- 6. Forests, Lands, Natural Resource Operations & Rural Development
- 7. Health
- 8. Municipal Affairs & Housing
- 9. Tourism, Arts & Culture

FYI – we found the document being referenced today by the Opposition critic

It is obscure – but – it looks at all funding (Operating and Capital combined) and compares budgeted to actual (a 15 month time period given that forecasts for forward budgets are made at Q3)

- <!--[if !supportLists]-->• <!--[endif]-->Our operating \$ is on track we used just over \$1M access to contingency (related to the Arts Umbrella / Emily Carr land transfer)
- <!--[if !supportLists]-->• <!--[endif]-->Our capital cash flow had a \$96M variance (downward trend) which is typical of capital as forecast schedules adjust to reality as the year goes along we adjust the cash flow as we go through the fiscal year so we aren't overspending capital cash flow.

There was no overspending and M3's statements on the record are correct.

The net effect is we are "under budget" by \$96M – the critic was likely trying to make the point that if we're under by \$96M why do we need to seek \$5.5M more? Can't we just manage within the \$96M?

But we can't mix capital and operating funds together – which this report unfortunately does as it gives an <u>overall accountability</u> – but in reality, there are different

performance accountabilities for operating and capital that are shown in a separate document (Public Accounts) published at the same time.

FYI – HLTH and EDUC show the same variance pattern – and it's the influence of their normal capital plan cash flow lags.

We are putting some summary bullets together to explain this in response to the Critic.

I'll have a print out of this report ready and at hand for the Main Estimates.


