Dear Melanie Mark,
You are my MLA and I would like a non-automated response to the following important message.

We are experiencing a crisis within British Columbia and call on the Members of the Legislative Assembly of the province to open a public inquiry and create a commission to investigate corruption, organized crime, and money laundering within our economy.

This public inquiry should investigate, but not be limited to:

- Finding those who have benefited,
- determining why our systems have been unable to regulate this, and
- identifying who in power has failed in their duties to stop this.

There should be focus on, but not limited to:

- Private land and real estate transactions,
- public land deals involving all levels of government,
- luxury economies such as high-end vehicles,
- the gambling industry and our casinos, and
- the various lawyers and brokers that facilitate transactions.

Recently a secret police report obtained by Global News Investigative reporters revealed a vast network of corruption, organized crime, and money laundering in our economy. We learned of over \$1 billion dollars in a single year being put into our real estate market by people with criminal backgrounds, much of which has come from the fentanyl drug trade and overseas gangs.

- **Canada's first Indigenous law program at the University of Victoria.** Program was launched on Sept. 25 at the First Peoples House.

- B.C.'s Budget 2018 includes \$900,000 in 2019-20 and \$1.35 million in 2020-21 as the program gets underway. The Province of B.C. will be increasing its investment up to a steady state of \$1.8 million a year in on-going funding.
- **A total of 2,900 tech-related spaces** will produce 1,000 additional tech grads a year by 2023. This includes 620 seats on Vancouver Island.
 - UVic: 500 additional spaces; 124 additional graduates a year
 - Camosun: 40 additional spaces; 40 additional graduates a year
 - VIU: 40 additional student spaces; 20 additional graduates a year
 - NIC: 40 additional student spaces; 40 additional graduates a year
- **687 former youth in care are benefiting from the provincial tuition waiver program** compared to 189 youth in 2016-17 under the initial voluntary program. This is a 250% increase.
 - Camosun: 76 students
 - UVic: 26 students
 - North Island College: 2 students
 - VIU: 83 students
- **Gov't funded an additional 1,165 homes at three post-secondary institutions in 2018** -including UVic – representing an 800% increase from 130 student homes funded over the previous 16 years.
 - UVic: 25% increase in student housing with 620 net new beds (total beds 782). The estimated cost of the total project is \$201 million. The Province is providing financing of \$123 million and the UVic Foundation is providing up to \$45 million. UVic will provide the balance. Provincial funding includes \$98 million from the BC Student Housing Loan Program for student housing and \$25 million from the ministry capital budget toward half the cost of the dining hall.
- **\$12-million post-graduate scholarship program for 10 post-secondary institutions in B.C.** that offer graduate degree programs, supporting 800 awards of \$15,000 each through 2021.
 - UVic: \$2.25 million
 - VIU: \$180,000
 - RRU: \$180,000

Are there any areas of the plan that she feels UBC will be particularly vital to realizing?

Recommendation

Statement from a ministry spokesperson:

Climate change remains one of the greatest challenges of our generation. The 25 public post-secondary institutions in B.C. are up for the challenge and have the capacity to deliver. They are training the leaders of tomorrow in climate policy and climate research, and government is going to build up the next generation for the green economy.

The CleanBC strategy outlines the Province's first phase of actions to help meet the 2030 greenhouse gas reduction targets. A feature of the strategy is supporting new jobs and skills as we transition to a low-carbon economy.

While people have a wide range of education and training opportunities to support a low-carbon economy, we know more needs to be done.

Our gov't is developing a CleanBC Labour Readiness Plan with completion expected by October 2019 following extensive labour market research and public consultation. The plan will identify areas of job growth and what skills are needed to meet demand and ensure students and apprentices can access training programs.

Government will work with post-secondary partners such as UBC, Industry Training Authority and stakeholders to implement the CleanBC Labour Readiness Plan.

I'm a reporter at The Ubyyssey writing a piece on international student tuition revenue, in light of the most recent mandate letter from the Ministry of Advanced Education, Skills and Training and the increasing weight this revenue stream occupies within the University of British Columbia's operating budget.

I'm basically interested in getting more information about what the ministry would consider "a balanced approach to international education." I would also like to know what is the ministry's perspective on UBC's revenue mix, considering the proportion occupied by government grants within the university's budget has remained flat over the past five years while that of international undergraduate student tuition has nearly doubled over the same period. Is there any concern that UBC has become too dependent on this source of revenue, as has been expressed by some members of its Board of Governors?

Please let me know if you're available to provide some information or comment on this matter, or connect me with

someone who could do so.

Background

On Dec. 4, 8 out of 21 UBC board members voted against domestic increases mainly due to revenues increases stemming from international student tuition. <https://www.ubyssey.ca/news/board-votes-for-tuition-increase-2018/>

UBC's operating grants from the Province is expected to increase to \$635 million in 2018-19 compared to \$586 million in 2013-14. Recent investments by the provincial government include \$6 million for graduate scholarships (announced July 25, 2018) at UBC plus funding for 624 additional spaces in computer science and biomedical and manufacturing engineering degrees (announced Jan. 16, 2018). The Province also lowered the interest on BC gov't student loans by 2.5% to Prime effective Aug. 1, 2017 as part of a commitment to eliminate provincial interest on loans.

In October 2018, the Ministry provided The Ubyyssey with background in response to a similar question asking for more details on a balanced approach to international education. The article was published on Oct. 21:

All B.C. public post-secondary institutions were asked to work closely with the Ministry to develop a balanced approach to international education.

The number of international students studying in B.C. has grown significantly over the past five years. We are focused on maintaining British Columbia as one of the leading destinations for international students. We are also focused on the primary mandate of our public post-secondary institutions, which is the educational, social, and economic development of B.C. students.

To support these goals, we are working with key partners on a renewed, balanced approach to international education that considers a number of factors, such as a positive student experience, opportunities for all regions of the province, and promotion of educational opportunities abroad for B.C. students and educators.

International education makes an important contribution to our education system as well as the B.C. economy. It enriches student development – of international students who come to B.C. and of B.C. students who travel abroad. We want to make sure the province continues to deliver the quality education experience students expect and deserve.

All B.C. public post-secondary institutions were asked to comply with government's two percent cap on tuition and mandatory fee increases. This policy does not apply to international students.
