Recommendations to Post-Secondary Institutions Regarding 2019 Novel Coronavirus (COVID-19)

Provincial Coronavirus Response Feb. 21, 2020

To Post-Secondary Institution Leadership and Administrators

We are writing to provide information on the novel coronavirus (COVID-19), a new virus causing respiratory illness.

There have been a small number of cases of COVID-19 in B.C. which are being very closely managed. Updated information regarding these cases can be found at bccdc.ca. All B.C. cases have a recent history of travel to affected areas or close contact with a traveller. There has been no sustained community transmission, and the risk to British Columbians at this point remains low.

As the areas affected by the outbreak changes and we learn more about the virus, we will provide updated public health recommendations. We are now aware that this virus can cause a range of mild to severe symptoms, and it is possible that people will not recognize symptoms that are mild. Given this new information, there are steps that people at risk of COVID-19 can take to reduce the chance of spread to others.

Advice for students, faculty, or staff on self-isolation

We now recommend that:

- Students, faculty, or staff returning from Hubei Province, China stay home or self-isolate in their dorm/room alone for 14 days after they left Hubei. They should monitor themselves daily for symptoms (fever, cough, muscle aches, difficulty breathing).
- Students, faculty, or staff who have been in close contact with someone who has been
 diagnosed with COVID-19 by laboratory testing should stay home or self-isolate in their
 dorm/room alone for 14 days after their last encounter. Individuals should monitor themselves
 daily for symptoms (fever, cough, muscle aches, difficulty breathing).

• Students, faculty, or staff who have been in other parts of mainland China (outside Hubei Province) should monitor themselves daily for symptoms (fever, cough, muscle aches, difficulty breathing) for 14 days after they left China. They do not need to self-isolate.

Those who develop symptoms during the 14-day monitoring period should immediately self-isolate (stay in a room that is not shared with anyone else) and call their health-care provider or 8-1-1 to discuss any need for testing and follow up.

While these recommendations are important, they are voluntary. University and college administrators, faculty and staff are not expected to enforce or monitor them.

The Provincial Health Officer asks the public and the post-secondary institution community not to make assumptions about the risk of students, faculty or staff based on their ethnicity or travel history.

Recommendations for Post-Secondary Institutions to Facilitate Self-Isolation

Given that students, faculty, or staff who are self-isolating may rely on post-secondary services (for example housing or food), institutions should plan for how they will support those in self-isolation. If your institution has a pre-existing plan for pandemic influenza, it may have protocols and guidance that can be adapted.

Those who are self-isolating are doing so for the benefit of others. Please support continuing instruction (e.g. deadline extension or alternative coursework that can be completed from self-isolation) and create a non-punitive environment for those who are self-isolating.

Advice on Cleaning and Disinfecting

Cleaning and disinfecting objects and surfaces that are frequently touched by multiple students or staff (e.g., high touch surfaces such as doorknobs, faucet handles, computer keyboards, etc.) will help to prevent the transmission of viruses from person to person through contaminated hands. If household or commercial disinfection products are not readily available, hard surfaces can be cleaned of visible dirt and then disinfected using a mixture of 1-part bleach and 9-parts water.

Institutions should also consider increasing the number of hand wash stations (or alcohol-based sanitizer stations) around the institution, as well as providing tissues and waste receptacles.

Advice on School Events, Outings and Trips

It is not necessary to cancel classes, school events, outings or field trips to public locations. Trips including educational exchanges or student rotations to China are not recommended at this time. Up-to-

Please be advised that:

- The Provincial Health Officer (PHO) is not recommending closure of any post-secondary institutions at this time.
- The PHO is recommending no gatherings of 250 people or more. Social distancing is encouraged so we all help prevent the spread of the coronavirus. Travel outside of Canada is discouraged (including the US). Those returning from travel outside Canada are to self-isolate for 14 days.

We are focused on slowing the spread of COVID-19 in our communities.

A sudden increase in people becoming infected with COVID-19 may impact the capacity of our health system to provide care to everyone who needs it.

By slowing the spread of the virus, our most vulnerable will be able to access care when and where they need it.

WHAT BUSINESSES CAN DO TO SLOW TRANSMISSION

80% of people who are infected will have mild symptoms that will not require care outside of the home.

Around 1 out of 6 people who get COVID-19 may become seriously ill and develop difficulty breathing.

Older people, and those with preexisting medical conditions such as high blood pressure, heart problems or diabetes, are more likely to develop serious illness.

Support hand washing, social distancing, and adopt flexible sick-leave policies to allow

people who are sick to stay home.

WHAT YOU CAN DO TO SLOW TRANSMISSION

Take care of others by taking care of yourself.

Wash your hands, don't touch your face, and stay home if you are sick.

Monitor yourself.

If you have a fever, a new cough or difficulty breathing, call 8-1-1 for guidance.

Clean and disinfect frequently touched surfaces using routine practices and consider cleaning and disinfecting twice a day if possible.

COVID-19 and Determination of Return to Work of Essential Service Workers Who Have Traveled Out of Canada

The definition of what constitutes essential services, and which workers in those essential service are critical for business continuity, varies between organizations in the public and private sector. Generally essential services are those considered critical to preserving life, health and basic societal functioning. For example, this includes first responders to life threatening events, health care workers who are essential to delivering patient care and life-saving services, critical infrastructure workers such as drinking water, hydro, internet and natural gas and workers who are essential to supply society with critical goods such as food and medicines.


Primary prevention is key so essential service workers should not travel outside Canada unless travel is part of the essential service that they provide.

Principles to determine whether a worker in an essential service should return to work earlier than 14 days after returning from essential travel outside of Canada include:

- Preventing new introductions of SARS-CoV-2, the virus that causes COVID-19, into BC is of paramount importance to limiting the spread of the virus.
- As a baseline, ALL travellers from outside of Canada are considered potential carriers of the virus and must self-isolate at home or a similar place in which to stay.










- To preserve essential services, it is key to consider the risk that a returning worker could pose by endangering
 the health of multiple other essential service staff, which could jeopardize the ability to provide essential
 services.
- Leadership of essential service should follow the recommended 14-day self-isolation after travel guidance as far
 as practical and establish thresholds where the delivery of the essential services can no longer be delivered and
 then, and only then, make decisions to waive individual workers from the self-isolation protocol based on an
 overall risk assessment of:
 - Where the person travelled, recognizing that many countries in the world are experiencing significant community transmission of the virus
 - Duration and type of activity while away (family visit versus large gathering events)
 - Current symptoms of the individual or household. If there are any symptoms demonstrated by the individual or those they live with, they should be assessed by a health professional before returning to work.
 - o Essential service type and overall risk of reduced or minimal staffing
 - Work environment of the individual e.g. whether they work independently, outside or in a group setting.
- Essential services must establish a protocol to prevent risk of transmission by an essential service worker with a
 travel history, support rapid response to an essential service worker with a travel history who develops
 symptoms while at work and maintain high levels of hygiene. Key elements of such a protocol, which are to be
 modified depending on the work site are:
 - Workers who return from travel and are critical to the delivery of an essential service may return to work if approved by their leadership but must take the following additional precautions to reduce the risk to their clients, colleagues, and the public should they become symptomatic:
 - Self-monitor daily for signs and symptoms of illness
 - Follow infection prevention and control protocols including diligent hand hygiene
 - Reduce close contact with other workers i.e., maintain a two metre separation and avoid shared spaces where possible
 - Avoid close contact with others when travelling to and from work and between shifts
 - Self-isolate at home on days when not required at their workplace
 - Avoid any unnecessary public establishments
 - Implement an organization-wide, self-distancing policy for all employees requiring a minimum physical distance of 1-2 meters between individuals. This includes avoiding standard greetings that require physical contact such as shaking hands.
 - Increase regularly scheduled cleaning with a disinfecting agent such as antimicrobial disposable wipes or a diluted bleach solution
 - Require workers to self-declare to dispatch and to 811 or their health care practitioner, if they
 have come in contact with anyone who has COVID-19 and self-isolate if instructed by a health
 practitioner.







 Require workers, if they exhibit symptoms of COVID-19 (e.g., fever, dry cough, etc.) to call 811 or their health practitioner, and self-isolate for 14 days unless instructed otherwise by a health practitioner

Please note the following three COVID-19 updates:

1. Federal Economic Response Plan

The federal government announced an \$82 billion <u>COVID-19 Economic Response Plan</u>. Highlights include:

- Canada Student Loan repayments and interest accrual will be suspended for six months. The Ministry of Advanced Education, Skills and Training is working with the Ministry of Finance on a strategy for BC Student Loans, which are integrated with Canada Student Loans, as part of BC's COVID-19 response plan.
- New Emergency Support Benefits for workers facing unemployment who are ineligible for EI, as well as a new Indigenous Community Support Fund.
- All non-essential travel across the Canada-US border is temporarily restricted.

2. On-campus Child Care

The Provincial Health Officer is currently not recommending child care closures for the prevention of COVID-19. A variety of options are being considered to support access to child care services for essential service workers. The Ministry of Children and Family Development is monitoring the situation closely and reviewing child care funding policies to support both childcare providers and families.

3. First Responders

The Provincial Health Officer issued advice on self-isolation precautions for first responders (see attached).

To: First Responders

I'm writing to provide clear advice to your departments and members regarding self-isolation precautions related to the current COVID-19 pandemic.

In the course of your daily duties, you may come across citizens who are experiencing cold or flu-like symptoms. It is important to continue using appropriate personal protective equipment in line with established best practices. Citizens with cold or flu-like symptoms are being advised to contact their health care provider or 8-1-1 to determine if their additional risk factors constitute testing for COVID-19. If these citizens become patients in the health system, they will be assessed for testing for COVID-19.

Should these citizen test positive for COVID-19, public health will follow up with contacts of those citizen – this includes household contacts, first responders, and others that may have been in close proximity while they were experiencing symptoms. Public health will advise that these contacts, including first responders, self-isolate for a period of 14 days.

This process means that you do not need to self-isolate if you assist a citizen who is experiencing symptoms, unless you are directed to by public health, or unless you begin to exhibit symptoms. Your department members do not have to self-isolate or cease operations if you think you or another member have been exposed. As COVID-19 begins to spread in our communities, members may be advised to monitor yourself daily for symptoms. The most important thing you can do to protect others is stay home if you become sick.

Testing is available for all who need it, but not everyone requires a test. If you develop symptoms, use the BC COVID-19 Self-Assessment Tool (https://covid19.thrive.health/).

Your departments have received advice on how to increase common sense practices to prevention infection and transmission in your workplace. This includes increasing the frequency of cleaning and disinfecting frequently touched surfaces with products already used for this purpose, ensuring soap is stocked, and putting measures in place that supports social distancing.

I will issue advice to you as the situation evolves. Please visit www.bccdc.ca/covid19 regularly for information and updates. Thank you for continuing to keep British Columbians safe.

Federal Supports for Post-Secondary Students and Recent Graduates Affected by COVID-19

The federal government has announced a package of new and enhanced financial <u>supports for post-secondary students</u>:

- Targeted supports for students who are ineligible for the Canada Emergency Response Benefit;
- Increased and expanded eligibility for student financial aid;
- Targeted supports for Indigenous students; and,
- Expanded supports for graduate students.

Federal Change to International Student Work Hour Limits

Immigration, Refugees and Citizenship Canada has announced that effective immediately and until August 31, 2020, international students may work more than the 20 hours/week during their regular academic session to assist with delivering essential services or functions to protect life and property, such as the health care sector.

Good afternoon,

I am writing in follow up to the letter sent to all certified private training institutions on Friday, May 8th from Tony Loughran, Executive Lead, Ministry of Advanced Education, Skills and Training. That letter advised institutions that a COVID-19 safe operating plan is being developed to guide the post-secondary sector. The plan will likely not be available for several weeks. Tony also pointed out that businesses and organizations that are not covered by a Provincial Health Office order may re-open or continue to operate, but they will be expected to adopt and implement sector safety plans as they are finalized. Worksafe BC guidelines (linked below) also stipulate that employers need to develop a plan to reduce the risk of exposure.

While the broader post-secondary sector plan is being developed, we are advising institutions that are moving forward and working on their own protocols to do so in alignment with:

- 1. The Public Health Officer's orders and guidelines
- 2. WorkSafe BC's guidelines for returning to safe operation
- 3. Any industry specific guidelines established by regulatory authorities or industry associations.

The expectation is that, once the post-secondary sector safe operating plan is available, you will either use it as a framework for your plan or incorporate anything you may have missed into the plan you already created.

Please be aware that PTIB is not reviewing or approving your plans. Rather, it is up to the individual institution to create the plan. Ultimately, you will be accountable to both the PHO and Worksafe for its implementation.
