As Minister of Agriculture I am writing to you today in regard to yesterday's announcement concerning a change in the leadership of the Agricultural Land Commission. I would like to thank the panelists and vice chairs for their service to agriculture and British Columbia. I would also like to take this opportunity to thank Richard Bullock for his five years of service.

I know from personal experience that changes such as this can be difficult.
