





Opportunity to invest in the long-term growth and sustainability of the Agrifood Sector

"What would you guess is the single most important ingredient in modern food production? Good seeds? Rainfall? Fertilizer? The surprising answer is that, around the world, the scarcest and most precious resource for producing food is trust."

— Globe and Mail (July 20, 2016) in, "With natural capital and trust, Canada can become an agrifood powerhouse"

In October, the BC Agriculture Council (BCAC) presented the Select Standing Committee on Finance and Government Services with an opportunity to partner with the farmers, ranchers and food processors of BC and help them fill the increasing global demand for high quality, healthy and sustainable food. This \$15 million dollar investment by the province over the next three years will help launch a long-term initiative to build public trust in BC's agrifood sector and help achieve the Agrifood and Seafood Strategic Growth Plan.

The Super Natural BC brand is at the core of who we are as BC residents and businesses, including BC ranchers and farmers. However, according to recent research by the Canadian Centre for Food Integrity (CCFI), only 30% of today's consumers think the Canadian food system is headed in the right direction. Consumers are losing trust in the food system, the methods used to raise animals (including fish), the safety of the food we produce, and how we maintain the BC environment—despite most knowing little to nothing about Canadian food production practices.

Unfortunately there are too many examples today, even here in BC, where an economic opportunity is passed over because the public perceives the cost to be greater than the benefit (i.e. new pipelines & expansion of the aquaculture sector).

BC farmers (including aquaculture), ranchers and food processors believe that by investing in how we grow and raise our food, ensuring that we are doing the "right things", and encouraging engagement between the general public and the agrifood sector, we can reverse the emerging trend of mistrust and continue growing a healthy and sustainable industry.

Can you imagine a future where the production practices of BC farm and ranch families are actively supported by every BC resident? We see BC agri-businesses as the foundation for an ever-growing sector that will continue to employ many residents and contribute to the economic wellbeing of the province. The current BC Agrifood Strategic Growth Plan to be a \$15 billion sector by 2020 is only the tip of what is possible.

We are inviting the BC Government to strategically invest \$15 million over the next three years to ensure that the agrifood sector continues to be an economic driver of the province.

Desired Outcome




Figure 1: Basis for privilege to operate

BC public and international buyers who trust the food they eat and actively support the processes and practices of the agrifood industry. In addition, British Columbians have confidence in the provincial agrifood system, have a basic understanding of how it functions and support continued expansion (Figure 1).

Approach

Use the National Trust Framework (Figure 2) as a guide to define roles and responsibilities and create structure for a public trust program in BC.

The businesses that actually grow and prepare agrifood products have the most to gain and lose and will take a leading role. But success depends on engagement with all

advocates of the BC food system (e.g. BC Ag in the Classroom, Ag More than Ever, academia, consumer and environmental organizations etc.) who are committed to collaborative improvement.

1. Foundation

The agrifood system will operate in such a way so that consumers may see what actions are performed and have their concerns addressed openly and honestly. Those in the agrifood system must demonstrate that while production methods have changed and the use of technology has increased, the commitment to doing what's right has never been stronger. It focuses on coordinating a two-way conversation between those within the food system and consumers.

The framework acknowledges that product and corporate differentiation is good, but not at the expense of endorsed practices. The premise is that the standards agreed to in this framework realistically meet the expectations of the majority of society. Those wanting additional, or more specific standards, may not cast doubt on or harm the basic standard.

2. Coordination - the Hub

Keeping with the underlying principle of simple and inexpensive, we are using the existing sector organizations, not creating another new entity. The Hub—the coordination and governance arm facilitated by BCAC—will be the link to all activities, including current government and industry initiatives both provincially and nationally (i.e. Environmental Farm Plan, food safety initiatives, ProAction, Verified Beef Production).

While it is important that the proposed BC public trust program operates with its local context in mind, collaborating with national value chains and amplifiers improves efficiency and effectiveness and allows for greater cost containment and integration with the national food system. The Provincial Coordinator will champion the BC public trust program through the Hub.

3. Pillar 1 - "Doing the Right Thing"

Building on Continuous Improvement assumes that the agrifood system has a set of standards that it is striving to meet. Defining specific measures and actions for the right things will be led by individual commodity value chains (farmers, processors, and retailers) as societal standards and expectations change over time.

4. Pillar 2 - Develop Trusted Verification Systems

A commitment to Transparency requires the industry to be willing to have external parties verify that what is said to be happening actually is happening. Each value chain will have an assurance

system that is specific to the sector (applicable). Canada already has one of the safest food systems in the world and a robust base regulatory framework to monitor issues like pollution, animal health and worker safety. Government and academia will play a key role to ensure that there are processes in place that verify what producers said they would do is being done.

5. Pillar 3 – Improve Communications

Pillar three is centered on all food system stakeholders collaboratively working together to tackle tough issues through strong, consistent communication. This requires establishing coordinated communication channels that facilitate two-way discussions (fork-to-farm and farm-to-fork) in two priority areas: within the industry and with consumers.

While individual value chains are responsible for their own communications, the Hub will lead pan-agrifood system communications.

From Fork to Farm

As societal expectations continue to grow and evolve, there needs to be a way for businesses in the value chain to continually learn from consumers and each other. Peers need to communicate in an open and ongoing manner and hold each other accountable for doing the right thing and building public trust.

Many existing programs already support pillar one and two activities, but the approach is fragmented and, as a result, these programs are perceived by value chain members as adding additional paperwork with little return. Communications will focus on enhancing awareness about trusted assurance/verification programs, their importance, and the benefits of implementing them.

Improved industry communication will facilitate peer learning within and between value chains and showcase Continuous Improvements being implemented throughout the system.

From Farm to Fork

Canadians want to know more about the food they eat—and the food system has much to gain from well-informed consumers who engage with those who grow and prepare their food.

Farmers enjoy the most favourable impression as a source of food and farming information: 69% of Canadians surveyed viewed farmers favourably. This is a significantly better rating than retailers (39%), government (35%), and food industry associations (30%).

Additionally, according to the CCFI, leading communication with shared values is three to five times more important to building trust than sharing facts or demonstrating technical skills/expertise.

Consumer communication will primarily come from the farmer voice and be focused on shared values rather than facts. Priority will be given to addressing consumer perceptions, attitudes, trends, and hot topics that are identified in an annual benchmarking study. It is also important that the communication strategy be informed by current research to ensure it is built on a strong, evidential foundation.

However, it's not enough for the system to have confidence in itself and tell its own story. The BC agrifood system needs outside advocates to say that it is on the right track. To leverage consumer trust in secondary groups who are also viewed favourably as sources of food and farming information, we will facilitate communications with health professionals, scientific/academic researchers, and educators.

Governments' Role

1. Public support to the process

Robustly promote the established and proven regulatory systems (e.g., CFIA, PMRA). Support the food system's efforts to improve processes and practices (pillars one and two).

2. Guidance

Offer a key guiding role when parts of the value chain require additional assistance in implementing improvements.

3. Funding

Commit to provide ongoing base and/or matching funds to activities related to the three pillars and the Hub (refer to the budget for additional details).

4. Federal/provincial alignment

Maximize collaboration across the country by aligning provincial programs and initiatives with national strategies as much as possible for consistency, speed, and efficiency (e.g., food safety standards and traceability programs).

Other Roles:

1. Value chains

As the actual businesses that deliver our food, value chain members have the most to gain (or lose) in this discussion and, in the end, are the only ones who can earn public trust. They must demonstrate commitment to Transparency and Continuous Improvement by establishing standards and programs within pillars one and two.

2. Amplifiers

Participants in the food system not directly involved in bringing food to the table (e.g., Ag in the Classroom) inform consumers and producers, facilitate the exchange of ideas, and help build shared values. This initiative will not replace work currently done by these groups; but, by sharing ideas and collaborating where possible, the reach of current work may be extended.

3. Academia

The academic community researches, develops and tests new technologies. It has an important role to play in advising on consumer perceptions, attitudes and behaviours. Academics can educate the trusted educators and consumer influencers including teachers, pediatricians, nutritionists, etc. and offer a credible voice when speaking with the media and influencers.

4. Hub Steering Committee

A group of leaders, from a cross sector of the BC food system, will guide and govern BC's public trust journey. This includes providing direction to the Provincial Coordinator. The formation of this committee will be facilitated by BCAC.

The Hub Steering Committee is likely to meet a couple of times a year to approve annual work plans, assess opportunities, and review progress of activities. Steering committee members will also facilitate communications back through their respective groups.

Recommended members include: farmers (2-3 BCAC Members), processors (1-2), retailers (1-2), food service representatives (1-2), an agriculture academic (1), a consumer group representative (1), government (1), and an amplifier representative (1).

5. Provincial Coordinator

An individual with the primary responsibility of advancing and supporting recommendations from the Hub Steering Committee. They are also responsible for developing and executing the public trust program plan approved by the Steering Committee. A key short-term priority will include establishing sustainable long-term funding.

The Provincial Coordinator will also provide a link to national public trust work and ongoing work in other provinces. This will facilitate information-sharing and access to potential funding and resources.

Short-term Priorities

The Hub Steering Committee will work with the Provincial Coordinator to develop a comprehensive strategic plan. The components included in the final plan will depend on additional input provided by groups and the level of financial support provided.

The following chart outlines first year activities for discussion/illustration purposes.

Budget & Financial Ask

Many sectors of the agrifood industry are already making considerable investments into building public trust in a wide variety of areas (animal care, food safety, environmental impact). BCAC and its members believe that as public trust may have the biggest impact—both positive and negative—on farmers and ranchers, we should lead the investment in the new initiative.

BCAC members are committing \$100,000 per year for three years as core funding primarily for Hub activities. The goal is to have this amount matched by the food processing sector and augmented by the seafood sector.

The core budget outlined below will enable launching the initiative with a part-time Provincial Coordinator. The additional industry support would make this a full-time position. This core funding will provide only limited support activities within the Pillars.

Government Financial Support

Given how this initiative could help BC achieve the growth outlined in the current BC Agrifood Strategic Growth Plan and more, we are asking the Province commit \$15M over the next three years to support the launch of what we hope will become a long-term way of operating for the sector.

Federal and provincial governments have identified building Public Trust as an important initiative for the sector. Public Trust is one of the six principles identified in the "Calgary Statement" which will serve as a foundation for the Next Ag Policy ("GF3").

Government can help and support industry develop Public Trust, but cannot lead it.

BCAC has asked the Province to commit \$5M for all of the industry (agriculture, food processing, and seafood) in each of the next three years to help launch this initiative.
