**Title**: Premier John Horgan meeting with Marine Harvest (MH) Chief Executive Officer (CEO) Alf-Helge Aarskog and Marine Harvest Canada (MHC) Managing Director, Vincent Erenst.

**Issue**: Discussion on MHC's long term viability of Atlantic salmon aquaculture in British Columbia's economy and MHC's future plan with respect to First Nations and related activities in the Broughton Archipelago.

**Background:** Marine Harvest is the largest producer of farmed salmon in the world, with a production (2016) of 380,621 metric tonnes and revenue of 3.13 billion EURO (~ CDN \$4.89 billion). The company operates in 10 countries with primary farming operations in Norway, Scotland, Canada and Chile. Globally it employs 12,717 full time equivalents (FTE). In B.C., production in 2016 was 43,349 tonnes (11.4% of global production) from 40 sites of which 25-30 are in operation at any one time. MHC's workforce in B.C. is approximately 550 FTEs employed in farming and processing operations (4.3% of global work force).

MHC has invested approximately \$120 million in B.C. in recent years on hatchery upgrades, a processing plant in Surrey, farm and feeding systems. The company has also invested approximately \$50 million in integrated pest management for sea lice control in an effort to mitigate environmental impacts. While MHC's investment in B.C. has been significant, the company also has recently invested \$185 million in aquaculture operations in Newfoundland and New Brunswick.

The management of aquaculture in Canada is primarily the responsibility of the federal government under the Department of Fisheries and Oceans Canada (DFO). The province works in partnership with DFO. The following more specifically outlines the roles and responsibilities of the federal government and the Province:

Note there was a previous meeting in January 2018 between the Premier John Horgan and CEOs from Mitsubishi and Marine Harvest regarding B.C.'s positions on salmon farming.

Recent developments in the Washington state, United States have also attracted attention towards the Atlantic salmon farming industry in the Pacific Northwest. The state of Washington recently announced that it will be phasing out all Atlantic salmon farming operations by 2022 - largely in part to concerns regarding risks to wild salmon populations.

**First Nations Considerations:** Salmon farms are currently located in the traditional territories of at least 28 B.C. First Nations (taking into account overlap of territories). Twenty First Nations have economic and social partnerships in place with B.C. salmon farmers, accounting for approximately 78% of B.C. farmed salmon production. First Nations communities provide approximately 30% of the workforce on the farms of B.C.'s four largest salmon farming companies. There are several farms operating without agreements or consent from adjacent First Nations.

Dear Minister Popham;

I am writing today in order to share our organization's perspective about the report and recommendations from the Minister of Agriculture's Advisory Committee on Finfish Aquaculture. I was an active member of this committee and am proud of the work we accomplished. While we did not find consensus on the risks of the potential harm associated with salmon aquaculture in B.C., we were able to agree on the principles of six key recommendations.

I am confident this report will be instrumental in our \$1.5-billion industry's continued evolution. We agree with many of the strategic recommendations and recommended actions contained in the report, and in fact have already implemented many of them. We look forward to working with you and your ministry, all levels of government, coastal communities and First Nations to implement them where they are workable as drafted, and refine them where needed.

I believe it is important that you have my unfiltered thoughts, which echo the sentiments of the BCSFA's 52 members, as you consider your response and how you might act on the recommendations and the impact that may have on this industry and the 6,600 good jobs it supports. Jobs supported by marine-based salmon farming are extremely important to rural coastal B.C.

One key passage from the report's introduction is worth highlighting:

"Despite the differences within MAACFA on the risk that farms pose, members share a common vision on the importance of sustaining wild Pacific salmon, the need for salmon farm practices to better align with this primary goal, and the importance for government and the industry to build greater trust among British Columbians."

The BC Salmon Farmers Association agrees with that statement. Our perspective is that with an average of 70 per cent of salmon harvested in B.C. and more than half of the fish harvested globally coming from farms, the industry plays a key role in both meeting our demand for healthy fish to eat and in reducing the strain on wild fish stocks. While any farming, on land or water, has an environmental impact it can be done responsibly and with wild animals top-of-mind. That is our goal.



It is noteworthy that the report highlights the great strides our industry has made in key areas over the last 30 years, including fish health, environmental protection, and developing relationships with Indigenous governments. We will continue to actively pursue honing our craft through best practices in husbandry; adaptation of innovative technology supported by good science; and in collaboration with First Nations, all levels of government, and other stakeholders. This report will contribute to that important work.

Unfortunately, these facts are often ignored by industry critics, though we would welcome their collaboration in addressing their concerns, so we can continue to meet the growing demand for fish to eat in B.C. and around the world while continuing to minimize our environmental impact.

I would like to add that the report contains some recommended actions that we agree with in principle, but which would prove unworkable in practice. In particular, while we agree collaborating with First Nations when using Crown land is crucial, and we have a long track record of doing so, the recommendation that would require holders of long-standing Crown tenures to acquire First Nations agreement as a condition of continuing operations at existing sites is unclear and, as drafted, unworkable. We cannot support it as written but would be pleased to collaborate with the provincial government and First Nations to address that.

It is key to note that making a recommendation on existing sites sits outside the mandate of this panel, which was charged in 2016 with offering the government advice on issuing new tenures – not existing sites. Regardless, the recommendation was made and thus we need to address it.

More on that below.

I would like to briefly share our perspective on all six strategic recommendations:

#### Salmon Farm Locations:

We agree that an area-based approach to managing salmon farms is the right approach and have been moving that way as an industry for some time. However, we could do more. Our greatest challenge in moving to full area-based management has been an unwillingness by government and some First Nations to amend and re-locate existing sites to designated areas.

We believe greater flexibility of farming allowing for maximum allowable biomass in a particular area (rather than on a site-specific basis) will result in a higher degree of environmental



performance, and better fish health.

Siting a farm today is a much more exact science than it was 30 years ago. Through advances in technology, science, and expertise we are able to choose better farm sites that provide an optimal rearing location, promote a high degree of fish health, minimize any potential risks to wild salmon, and significantly minimize environmental impacts that have been associated with farms sited decades ago. Allowing for flexibility in relocating farms, with full participation of First Nations partners, will further the modernization of the industry in B.C.

#### Aboriginal Rights and Title:

We agree entirely with the principle that it is crucial to consult with local First Nations when establishing a new operation on Crown land. Indeed, our industry has not proposed a new site for more than a decade without first securing the support of local First Nations through open dialogue and collaboration, and currently has agreement with 20 B.C. First Nations.

Many of the 6,600 jobs supported by salmon farming in B.C. are held by people of First Nations heritage. We partner with many businesses owned by First Nations and their members. Overall, B.C.'s salmon farming industry has a mutually-productive relationship with First Nations.

However, the report exceeds the committee's mandate and looks at existing tenures, suggesting salmon farmers should have to secure First Nations support to renew licenses of occupation at existing sites. It fails to offer clarity on the process for that consultation or a requirement that all participate in a meaningful dialogue about those sites. That lack of clarity would be unworkable on the ground, and benefit neither First Nations governments nor businesses operating in B.C.

Some salmon farms have been in place for 30 years, and are key employers in their communities. While all our members who hold existing licenses have reached out to all local First Nations and in most cases secured agreements through open dialogues, in a handful of cases a local community has refused to even speak with us. We would welcome consultation and collaboration and to develop equitable partnerships but can only do so when all parties will show up, in good faith.

Clarity about the process for consultation on existing sites and the need for all parties to productively sit at the table together are necessary for this recommendation to be effective in practice.

The report's recommendation for the application of the United Nations Declaration on the Rights of Indigenous Peoples (UNDRIP) is in the right direction. Across B.C., many difficult issues



will need to be resolved as business and other stakeholders learn to apply the principles of the UNDRIP to new businesses and new sites. But the magnitude of the challenge increases exponentially when we start to apply the concept of "prior" consent to existing businesses.

#### **Marine Planning and Community Engagement:**

We agree with the Council that the long history of public debate, continued controversy and public trust issues associated with salmon farming warrants creating more opportunities for community, public and local government consultation and communication. Marine planning processes have provided an important forum for this engagement and provided guidance to salmon farming companies when looking at potential sites. We agree with the principles expressed in these recommendations and look forward to working with government and all stakeholders to further to increase community engagement and build greater public trust.

#### Pathogens and Disease:

We agree with the council that risk of pathogen transfer is perhaps the most controversial topic we currently face in salmon farming. We also note that through its 18 months of deliberations the council heard from numerous speakers strongly opposed to aquaculture, but "the council did not receive definitive data on the harm produced to wild salmon populations by pathogens. Instead it heard perspectives on the risks."

We believe that the information presented to this council, and published in scientific literature and by Fisheries and Oceans Canada, supports the view that the risk to wild Pacific salmon from pathogen transfer from farmed salmon is low, especially when farms are appropriately sited. Further, the \$35-million Cohen Commission of Inquiry into the Decline of Sockeye Salmon in the Fraser River (2012) found sea lice are not a serious threat to wild salmon, and salmon farmers continue to manage sea lice levels on their fish to low levels.

However, we know there are many people who disagree with this for their own reasons, which is why we are supportive of Canada's Chief Scientific Advisor being asked to appoint an independent science panel to provide recommendations on the appropriate use and consideration of scientific evidence in protecting the marine environment in decision-making on aquaculture. We believe this satisfies MAACFA recommended action 4.1. Scientific discovery must be expedited in this area, funding increased, and additional wet lab space established to enable this important work.

#### Alternate Technologies and Approaches:

Aquaculture has always been driven by science and innovation. This is as true today as it has been over the last three decades. The council heard how Norway is using policy to drive



innovation as it seeks to increase its annual farmed fish production from 1.2-million tonnes to 5million tonnes to meet the growing demand for fish. The council learned that this policy includes specific marine sites designated for innovative pilot projects to test new technology. We believe this may be an appropriate option for B.C. to explore. Some people believe the answer for B.C. is to move production to exclusively land-based operations. As we have discussed with you previously, while some land-based salmon farming is certainly an option in B.C. for a small portion of the province's production, moving to that as the only option simply does not make business or practical sense. That said, it is important such discussions occur and be wellinformed, and we believe moving forward with recommended action 5.2 will provide this important information and context to the conversation. We also believe the government should continue to encourage the development of aquaculture technology through good policy, and remove any barriers to land-based production uncovered in discussion. Our members agree 100% with Johan Andresasen, CEO of Atlantic Sapphire, which is developing a major land-based salmon farm south of Miami Florida, that "Every fish grown in a tank on land doesn't mean one less fish grown in a net pen. This is about growing more seafood and providing better nutrition. It's not a competition." (Undercurrent News, Feb. 5, 2018)

#### **Transparency and Information Gaps:**

We support the recommendations on enhancing transparency and filling information gaps. Regionally, DFO currently publishes 20 different reports on finfish aquaculture activities containing significant amounts of data. However, it remains cumbersome to navigate and updates are often behind schedule. As previously communicated to both DFO and your government, we agree that creating a website similar to Norway's barentswatch site would be productive. To that end, we have completed a review of what DFO currently reports regarding salmon aquaculture in B.C. and made some recommendations on how we could proceed in collaboration.

Our industry also has a direct responsibility to be transparent and communicate, and has taken a number of steps in that regard. Since 2015 we have published an annual Sustainability Progress Report and our farmers are all participants in robust third-party certification programs that necessitate a high degree of information transparency. We believe an advanced reporting model should be developed and launched in B.C. as quickly as possible.

I think we can agree that while not everyone has the same views about B.C.'s salmon farms, they are an important industry. Salmon farming in B.C. supports 6,600 jobs, many in remote communities, and generates \$1.5 billion in economic benefit for the province each year. It provides an average of 70 per cent of the salmon harvested in B.C. annually, and is both the



province's highest valued seafood product and highest-valued agricultural export.

I trust this letter has been helpful, and look forward to speaking with you further in the near future.

#### **BC Sustainable Aquaculture Pathway**

Canada has a world class aquaculture industry on both coasts. On the one hand, we have expert advice that recognizes Canada's great potential and that recommends that we should grow production. On the other hand, we hear ongoing concerns that the industry might be posing an unacceptable risk to wild salmon.

We have heard that some Canadians have a desire for a land-based salmon farming sector. While there are some small facilities with small production, some say there is great potential. Industry and financial experts argue that the technology is in its infancy and has a long way to go before we see significant production, and this may not be in B.C. or Canada because we are far away from major markets.

We are told that some Indigenous nations do not want farms in their territories. But there are also Indigenous nations that want these farms.

These are complex issues, and there are many thousands of good jobs hanging in the balance. There is also great concern over the future that lies ahead for our wild pacific salmon.

We propose a comprehensive plan to undertake considerable work over the next four years that will provide answers regarding a future pathway for sustainable aquaculture in B.C.

We will answer key questions about the risk net-pen farms may pose to wild salmon. We are making a considerable investment in scientific capacity and research. We have developed an investment incentive plan to accelerate research and development on next generation aquaculture technology, particularly closed-containment aquaculture. We're also partnering with all salmon producers and fishers to make investments to continue to better understand all pressures on wild salmon stocks and enhance the habitat of our wild salmon stocks through a levy assessed to every salmon fisher or farmer on the west coast.

#### **Proposed Pathway Forward**

A pathway forward that addresses concerns, develops a new framework for involvement of Indigenous peoples, and seeks to create business certainty to foster investment and innovation in British Columbia.

# Broughton Area Finfish Aquaculture Tenure Recommendations Industry Engagement Roles and Responsibilities

#### Purpose & Scope:

The general purpose for the finfish aquaculture industry's engagement is to provide advice and feedback on recommendations from the G2G process, as outlined in the Letter of Understanding (LoU) (attachment 1), on specific finfish aquaculture tenures through application of their individual and collective knowledge on the aquaculture industry . Responsibilities include:

- a) Review accuracy and completeness of information and data being used and provide specific industry information, as required. Information may include, but not be limited to:
  - a. Fallowing schedules and broodstock sites;
  - b. Production schedules and timing of harvest on a tenure by tenure basis;
  - c. Hatchery production schedules;
  - d. Processing plant supply arrangements; and,
  - e. Employee statistics by community
- b) Review and provide timely feedback and advice on recommendations from the G2G process;
- c) Review and provide advice on public communications, as appropriate.

#### Membership:

Consists of the two operators who have applied for tenure renewals, identified under the LoU, and broader salmon farming industry representation. Alternate members can participate in meeting discussions only when they are acting as the representative. This includes:

#### 1. Cermag

• 2 members; 1 alternate

#### 2. Marine Harvest

2 members; 1 alternate

#### 3. British Columbia Salmon Farmers Association

• 1 member; 1 alternate

#### Responsibilities:

Industry representatives and alternates will:

- Collaborate on advice and recommendations to the G2G table, as required;
- Develop advice that considers relevant government policies and programs, First Nations rights, interests and knowledge, other jurisdictional best practices and supporting data and documentation;
- Make best efforts to attend and participate in meetings set out is the schedule in this document;
   and,

d) Advise the G2G co-chairs if unable to attend a meeting, and ensure the designated alternate is available for the meeting.

Provincial government and First Nations representatives will:

- a) Lead and participate in discussion topics and agenda items; and,
- b) Maintain the confidentiality of any information received by industry that has been identified as confidential or sensitive by industry.
  - Sensitive and/or proprietary industry information may be subject to non-disclosure agreements, as appropriate.

#### **Meeting Procedures:**

Meetings will be co-chaired by one First Nation and one Provincial government representative. The co-chairs may choose to engage independent facilitation for meetings if considered appropriate. The role of the co-chairs is to:

- a) Provide good meeting management, including adherence to agendas and timelines; and,
- b) Summarize advice heard and acknowledge key points and action items and/or next steps and report out to industry in a timely manner.

The co-chairs will be responsible for agendas, background materials, technical presentations, venues, and other meeting details. The co-chairs will seek to ensure meeting agendas and review materials are circulated at least one week in advance of a meeting to provide adequate review time.

The co-chairs will not force consensus, but will seek consensus where possible through the collaboration of all participants. This means that all participants may not always agree with the final advice or recommendations. Disagreement or conflicting opinions with respect to the recommendations will be captured in summary notes.

Summaries will be circulated after the meeting and industry representatives will be given five business days to review and comment.

Meeting discussions and summary reporting are to be conducted without prejudice.

Meetings are not public and will not be advertised.



#### RESPECTING INDIGENOUS PEOPLES

#### What are the concerns?

Indigenous peoples have historically been marginalized in most countries, including in Norway, Chile, and Canada. While the situation for indigenous people varies substantially in the countries where Cermaq operates, circumstances around our use of sea and land areas for salmon farming have been and will be evolving as civil rights, international conventions and political and cultural conditions change. In BC, Canada, there are substantial tensions which involve the roles and responsibilities of Federal, Provincial and Indigenous Governments.

The concerns mainly relate to the rights and title of land and water.

#### Cermaq's approach

Cermaq respects indigenous peoples' rights and engages in developing mutual beneficiary relations within the scope of international conventions, governance and regulations in each country.

Cermaq **Canada** operates in the traditional territory of multiple **First Nations** in BC and is committed to developing and maintaining positive relationships with indigenous peoples. The company follows a set of guiding principles for these relationships. Appropriate consultation and consent is central to the debate in BC and is very complex. Whereas consultation is generally a process between Governments (involving Federal and Provincial Governments and each First Nation) though industry can be invited to participate, a Protocol Agreement between a company and the First Nation is seen as an important step in doing business in BC.

When Cermaq acquired the operations in Canada (Pacific National Group, Prime Pacific Seafarms and Heritage) a simple agreement was in place with the Ahousaht First Nation. Today, we have a comprehensive Protocol Agreement with Ahousaht First Nation in whose territory half of Cermaq's operations are located.

Cermaq's goal is to have Protocol Agreements with local First Nations for all its operations, but every First Nation is different and has different views on Salmon farming. The situation is further complicated as many of our sites are in areas claimed by more than one Nation. Cermaq continues to seek to engage and build relationships with local First Nations.


Cermaq engages actively in finding solutions that can be mutually acceptable and beneficially.

In **Chile**, the indigenous communities and peoples (of which **Mapuche** is the main group) rights have been strengthened over the recent years, and several claims will be assessed by the authorities over the coming years. Consequently, Cermaq is addressing the new situation and potential new requirements to continue developing robust relations to indigenous communities in the regions where we operate.

The **Sami people** have special rights in **Norway** linked to reindeer husbandry. In spatial planning and other planning e.g. of industry development and use of land, the Sami people is a stakeholder with defined rights. The potential areas where Cermaq's interest may be in conflict with the reindeer husbandry traditions are few, and mainly related to location of fresh water facilities.

Our statements and messages on this topic

- We are committed to developing and maintaining positive relationships with indigenous peoples.
- We respect the diversity of interests and cultures among indigenous people.
- Approximately 30% of Cermaq Canada employees are Indigenous.

Thank you for your emails of July 31, 2018, regarding the Government to Government (G2G) process related to the Letter of Understanding (LOU) between the Province of B.C. and three First Nations located in the Broughton Archipelago area.

We have received your questions and concerns through your respective written comments and through the verbal discussions at the meeting on August 3 in Nanaimo. We thank you for your attendance and participation and as a result of your input we provided you with a revised industry engagement document. Further clarification to some of your written feedback is provided below:

#### With regards to statutory decision making and tenure renewals:

The recommendations coming out of the G2G process may result in decisions that may inform or influence the Statutory Decision Makers' decisions on tenure replacements. The role of the Statutory Decision Maker as it relates to tenure replacements remains in place and current provincial policies for tenure decisions still apply. In the case of provincial Statutory Decision Makers, the provincial government has issued policy direction that no decisions should be made at this time on tenures listed in the LOU and that these should move to a month-to-month basis until the G2G table has completed its recommendations and decisions are made by the respective parties.

#### With regards to claims about salmon farming impacts and other language in the LOU:

The language used in the LOU is based on principles of Reconciliation and an understanding of how the signatory First Nations and the Province of B.C. can work together under a G2G process. The purpose of engaging the salmon farming industry within the G2G process is to provide an opportunity for companies to communicate their own perspectives and inform the development of recommendations. This is expected to include perspectives from industry that are different from the perspectives stated in the understanding of the parties to the LOU.

#### With regards to what best practices have been considered in the G2G process:

The province and the First Nation parties to the LOU each have their own experiences in reviewing best practices and other information on this topic. Notably, the province received this year a multi-stakeholder report and recommendations from the Minister of Agriculture's Advisory Committee on Finfish Aquaculture. The BC Salmon Farmers Association was a member of that committee and companies had the opportunity to make presentations to that process.

### With regards to the role of other parties (e.g., Fisheries and Oceans Canada and other First Nations) in the G2G process:

The G2G process is between the Province of B.C. and three First Nations. The role of DFO is acknowledged in the LOU and they will be engaged in the process. The Province does recognize the claims of other First Nations in this area and will consult with them on the G2G process. The provincial Statutory Decision Makers will also consult with appropriate First Nations as part of their consultation process.

With regards to the role of industry and private information used in the G2G process: Information provided by industry will be treated confidentially during the development of recommendations, but will be considered as part of the record of the proceedings. The table can meet individually with each of the companies to avoid any inappropriate information sharing. The table can also provide a non-disclosure agreement for any specific information that companies need to remain protected.

#### With regards to the logistics of future industry involvement in the G2G process:

It is the responsibility of the co-chairs of the G2G table to lead the process and ensure a respectful and productive process. The table is willing to discuss with industry the use of a facilitator for specific elements of this process. The table will consider suggestions relating to timelines and formats of meetings to ensure participation is maximized.
