Hello Minister: I must commend you on the work on this file to date. I know you have a keen interest in making this work. I contacted my constituent, who is on your list of responsible breeders, to see how things were going, and she said they were going great – until last week. Apparently things kind of fell off the rails about the definitions between a commercial breeder and a preservation breeder (eg hobby in their home). Her points below do seem a bit ridiculous, and obviously making a hobby breeder of standard poodles install flame resistant walls in her home seems a bit over the top. She is suggesting a dual registration process. s.22 really wants to make a difference in this legislation, she agrees whole-heartedly about its intent, but feels the points below are counterproductive to the entire goal of the legislation – to shut down puppy mills. Here is an excerpt of her follow up email to me:

Jane, I just want to say (again) that we really appreciate your support on this! I truly believe that you have a clear understanding of what a reputable breeder does. My email last night was a result of going line by line through the Breed Standards Document. Since then I have had time to think about what is missing in the document. And I would like to address it here and now...... thank you!

I am not sure that the current Policy Makers at the Ministry of Agriculture truly understood the scope of what a reputable breeder has to go through to create a litter. We put Championship titles on our potential dams and sires to know they are worthy of being bred. That can cost thousands of dollars We do health screens - many of those tests we have to repeat annually - easily a thousand dollars. We do DNA testing to rule out, or to breed away from genetic diseases. These health tests can also cost hundreds and hundreds of dollars. Our standard poodle stud fees range from \$2500.00 to \$10,000.00 for a championed, health tested sire. Then there can be many additional costs associated with breeding and whelping. Finally, there are further costs to raise the litter properly. Additionally, we are involved or give support to the new puppy family for the rest of the puppy's life. And if the puppy can no longer stay in that home - it must be returned to us - at any age. As well, we have to document, record and register

all of this information - at a further cost to us.

The commercial breeder usually does not do any health testing, they are not available for support and they do not take the puppy back if the pup can not stay with the new family. A reputable breeder is lucky from a monetary perspective - if we break even or lose less than \$3000.00 per litter. I never once came close to **only** losing \$3000.00 on any litter.

This is why it is actually insulting that a preservation breeder has to abide by the same rules as a commercial breeder who is living off the sales of their puppies. They are in it for the money. Preservation Breeders are involved because of our love and commitment to our chosen breed. It is not a business to us - we are not living off the income generated by the sales of puppies.

Really, shouldn't the commercial breeders be abiding by what the preservation breeders are doing? Health testing, only breeding from structurally sound animals with correct temperament and a pleasing disposition? Raising them in safe and motivating environment, offering health guarantees and the option of taking the puppy back if the new owner's situation changes?

There is a huge emotional difference between a preservation breeder and a commercial breeder. The preservation breeder is passionate about their chosen breed, they want to create healthy, well socialized puppies with correct temperament - that are better examples of the breed than what they started with. A commercial breeder is only doing it to make money. So why not make it more cost prohibitive for the commercial breeder and not pass on new burdens to the preservation breeders? Make the new rules and regulations only applicable to commercial breeders Using our classification of what defines a commercial breeder. This way the majority of hobby/preservation breeders will not be ill affected by the new policy.

Hi Jane.

Thank you for staying on top of this incredibly important issue!

Terri Giacomazzi, is the Senior Policy Analyst with BC Ministry of Agriculture who I have spoken and met with the most. To be fair, Terri has listened very well and asked good questions. But she also doesn't really know what a reputable dog breeder does. In our last conversation, she said that we can not make a policy that applies to one group of people because of the size of the operation - so most likely every reputable breeder - no matter how small will be classified as a commercial breeder. This was very disappointing to hear because in our previous conversation, Terri indicated that the Ministry really liked our definition and wanted to move forward with using it.

This is what we submitted for the **Classification or Definition of a Commercial Breeder**:

a) five or more intact animals that are over the age of eight months, or

- b) whelped four or more litters in one calendar year, or
- c) sold. transferred, traded or leased 30 or more animals in one calendar year, or
- d) if a breeder has bred a dam that has whelped more than three litters in one calendar year

They are wanting to change it to:

- a) change it to **four** (not five)or more intact animals that are over the age of eight months
- b) change it to **three** or more litters in one calendar year
- c) change it to 20 (not 30) animals in one year
- d) remove qualifier 'd' and place it into the breeding section of the document Jane, if every breeder is considered "commercial" then technically we would have to abide by all the proposed rules and regulations. Is there enough money in the budget and enough available trained personnel to monitor and enforce the new rules and regulations on every breeder in BC?

The balance of this email will be regarding points that are just down right ridiculous for a home based hobby or preservation breeder to have to adhere to..... Additionally, how will they monitor and enforce this? As has been mentioned many times in the past - a puppy miller is not going to voluntarily register. Although the Ministry keeps stating this is just a minimum Standards of Care and not really a doctrine to shut down puppy mills

1.1 Food

Mark food storage bins. For a breeder that only has one or two dogs - this is
just not necessary.

4. Environment and Housing

- Ensure exterior walls of housing facility are fire-resistant and impervious to moisture. Most homes do not even have fire-resistant siding for the human occupants
- Ensure interior walls and partitions are constructed of washable and sanitizable building materials. Most reputable breeders home interiors are made of drywall - not vinyl or stainless steel - which would truly be able to withstand daily sanitizing and disinfecting
- Regulate the ambient temperature of the housing facility with a heating and cooling system suitable to the breed, coat length, age and condition of the animals. Many homes in BC do not have air conditioning so there is no cooling system

9. Health Care Protocol

Post information for contacting the veterinary clinic/hospital, emergency care
facility, kennel or cattery operator, local fire/police and alarm company in a
location readily accessible to facility staff. Some breeders do not have any
family living with them or any staff - so posting information seems a bit over
the top......

10. Transportation

 Not permit an animal to be transported, unless the animal is being transported for the purposes of receiving the assistance of a licensed veterinarian, if the animal:

- a) Is displaying any sign of shock, exhaustion, fever, dehydration or an injury or illness
- b) Is a female that
 - i. Is within one week of her anticipated whelping/queening date; or
 - ii. Has whelped/queened within 2 weeks before the date of transport.

Our pregnant dams want to be with us - going to work with us or even going to the grocery store. In some cases it would cause the dam to have more stress if she was not allowed to be with us:

11. Plans

An operator must carefully consider, develop, and execute plans for each animal to ensure the animal's minimum needs are met during all of its life stages:

- Develop and make available plans for:
 - i. Life Cycle (puppies-birth to sale, breeding stock-birth to death);
 - ii. Health and Behaviour;
 - iii. Socialization;
 - iv. Emergency/Crisis (flood, fire, power outages, animal escape); and
 - v. Euthanasia (under the advice and instruction of a licensed veterinarian).

For most reputable breeders - our dogs are our companions - family members. We don't document what we are going to do with them next week or for next year.....

- 13. Responsibilities of the Operator
- Maintain premise maintenance records including:
 - i. Cleaning schedules noting dates/times the facility was cleaned, by whom, and with what
 - ii. Equipment and or building maintenance/repair/replacement/renovation schedules (i.e. fire extinguisher maintenance, electrical repairs, replacement of outdated/destroyed building components)

This is just not necessary for the reputable breeder who only has one or two dogs and no staff.

- 14.1 Kennel-Specific Additional Requirements
- Ensure the kennel facility has sufficient land to accommodate the building and

outside exercise runs. Not all breeders have runs - but still have an area for the dogs to get exercise

Additionally the following items were discussed with Terry - although they were not in the original Rules and Regulations Document. These are some points that other stakeholders raised and they want them to be added into the new Rules and Regs.

Crates or building will have to be insulated with noise control paneling or insulation They want to set a noise level of 80 decibels. So all breeders will have to buy a decibel monitor - even if they only have one dam or sire. Insulate crates or walls with noise proofing insulation.

Dogs must always be transported in a crate. There are times when a dog should not be in a crate for it's emotional well being.

Other stakeholders want to see all breeders (even if only one litter) be inspected and registered. There are not enough resources (person hours or financially) for this to happen.

Ban the use of e-collars, prong collars and choke collars. Vets, groomers, vettechs, handlers all use choke or slip collars - they are easy, fast and safe to put onto a dog.

Anyone breeding will have to register. Their thinking is that if you are not registered you might be at an unfair disadvantage - so everybody has to register - to level the playing field. Reputable, pure bred dog breeders are already registered with the CKC. This takes time and it costs a lot of money. So CKC registered breeders would not want to have to pay to register with another Registry. Jane, attached is the most up to date Rules and Regulation document that I submitted to the Ministry. It was submitted prior to my last conversation with Terri - so the last 5 points are not addressed in the document.

VICTORIA – More than 2,300 British Columbians have contributed their ideas to preserve farmland and encourage farming through consultation efforts to shape the revitalization of the Agricultural Land Reserve and the Agricultural Land Commission.

The consultation took place from February 5 to April 30 and was led by an independent committee made up of volunteers with diverse agricultural backgrounds and experiences that heard from British Columbians through meetings with stakeholders, written submissions and on-line consultation. 2,366 people from across the province participated in the consultation at engage.gov.bc.ca that included more than 750 farmers, 115 agriculture

specialists and more than 1400 responses from people who identified as the general public, and 240 responses from people who identified as being part of or representing an agricultural industry or interest group. 1,400 British Columbians who identified as the general public also participated. South Coast residents completed 900 surveys, while submissions from the Island topped 800, with close to 200 from the Okanagan and more than 100 from each of the North, Kootenay and Interior Regions.

The top three themes identified during the consultation were:

- A Defensible and Defended ALR identified by 1,203 British Columbians
- Food Security and B.C.'s Agricultural Contribution identified by 1,146 British Columbians
- Residential uses in the ALR identified by 866 British Columbians
 The committee also held meetings in nine communities in key agriculture producing regions of B.C. to hear the views of farm and ranch associations and agricultural organisations and local governments. The input the Committee received will help frame their recommendations for an ALR that will serve future generations of British Columbians, which will be provided to B.C. Agriculture Minister Lana Popham this summer.

The City of Abbotsford recently sent the province a letter regarding the ALR, suggesting "the ALC should take on a more prominent primary role with respect to enforcement of activities within the ALR, in coordination with City supports. The City of Abbotsford is unable to continue to sustain the enforcement of ALC regulations as the primary agency."

Obvious question is: what is the province doing to increase enforcement of ALC rules? How many compliance officers does the ALC currently employ, and how has that number changed over the last few years?

The letter also asks for changes to farm tax policy. Any comments on that would be great.

 The Ministry of Agriculture supports the ALC through annual operational funding, of \$4.6 million in 2018/19, slightly higher than each of the two previous years, about \$1 million more than 14/15 and 15/16 (\$3.4M
