Dear Chief Constable Fisher and Deputy Chief Constable Thom,

On Monday, December 2nd at approximately 4:20pm, my partner and I witnessed a deer being hit by a car on Cadboro Bay Rd, across from the Uplands Golf Course. She was a female, approximately 1 year-old and was still alive after impact. Conservation Officers were not available and the Oak Bay police were called to the scene.

While I understand there were competing priorities at the time, we waited with this injured and suffering doe for nearly an hour (officers arrived around 5:10pm). When the police arrived, she was shot in the heart/chest. The Supervising Officer told us it would be another 20 minutes or (after being shot) that she would eventually die.

Police being forced to shoot deer is not a rare occurrence as often times Conservation Officers/provincial support is not available.

To minimize as much animal suffering as possible, I am wondering what we can do to help support officers in their response time? Is it possible to have a specific person in the community that can be designated to be "on call" for such situations (ie. retired RCMP officer)?

Also, it is my understanding in that situation, deer should be shot in the head, between the eyes. (See attached - See page 82:)

S7.6.3.2.2 Physical Methods "Gunshot targeted to the heart (chest) or to the neck (vertebrae, with the intent of severing the spinal cord) presents challenges for accurate placement, but may be the best option for free-ranging or other settings where close approach is not possible or where the head must be preserved for disease testing (rabies, Chronic Wasting, or other suspected neurologic diseases). Based on domestic animal models (see section of the Guidelines addressing Farmed Animals Used for Food and Fiber), gunshot to the chest or neck may not result in rapid death and may be considered humane killing, rather than euthanasia."

Why was this animal shot in the heart?

Lastly, I am inquiring as to what type of training Oak Bay Police have been provided with to help them handle and dispatch wild animals including deer? If no comprehensive training or information manual have been provided, would you be open to having your officers be provided with such training?







I have reviewed our file pertaining to the incident you have described. My understanding is that the officer that attended this scene did not feel that it would be safe to attempt a shot to the head of the animal in the position it was in with the backdrop that was available at the time. He did subsequently remove the animal to a location where it was safer to discharge his firearm at the head of the deer as depicted in the diagram that you e-mailed to me in your second e-mail message. This officer has received training in preferred methods of dispatching seriously injured animals. This training was provided during his basic recruit training. Another key component of the training is to be aware of your backdrop that you are shooting towards or against. If shooting towards pavement or rock we often run the risk of the bullet ricocheting which can cause additional damage to bystanders and property.

You are correct that the response time in this instance was delayed. The delay was due to the officer's dealing with a suicidal female who had to be safely detained and then transported to our local hospital. In the majority of instances our response time is much quicker however this aforementioned incident did require the full complement of officers on duty for a short period of time to ensure the safe apprehension of the suicidal person.

I have reviewed the information that you sent me and will discuss it with our members as a refresher from their initial training that they received.

Subject: Response needed: Police training for dispatching deer

Dear Chief Constable Fisher and Deputy Chief Constable Thom,

On Monday, December 2nd at approximately 4:20pm, my partner and I witnessed a deer being hit by a car on Cadboro Bay Rd, across from the Uplands Golf Course. She was a female, approximately 1 year-old and was still alive after impact. Conservation Officers were not available and the Oak Bay police were called to the scene.

While I understand there were competing priorities at the time, we waited with this injured and suffering doe for nearly an hour (officers arrived around 5:10pm). When the police arrived, she was shot in the heart/chest. The Supervising Officer told us it would be another 20 minutes or (after being shot) that she would eventually die.

Police being forced to shoot deer is not a rare occurrence as often times Conservation Officers/provincial support is not available.

To minimize as much animal suffering as possible, I am wondering what we can do to help support officers in their response time? Is it possible to have a specific person in the community that can be designated to be "on call" for such situations (ie. retired RCMP officer)?

Also, it is my understanding in that situation, deer should be shot in the head, between the eyes. (See attached - See page 82:)

S7.6.3.2.2 Physical Methods "Gunshot targeted to the heart (chest) or to the neck (vertebrae, with the intent of severing the spinal cord) presents challenges for accurate placement, but may be the best option for free-ranging or other settings where close approach is not possible or where the head must be preserved for disease testing (rabies, Chronic Wasting, or other suspected neurologic diseases). Based on domestic animal models (see section of the Guidelines addressing Farmed Animals Used for Food and Fiber), gunshot to the chest or neck may not result in rapid death and may be considered humane killing, rather than euthanasia."

Why was this animal shot in the heart?

Lastly, I am inquiring as to what type of training Oak Bay Police have been provided with to help them handle and dispatch wild animals including deer? If no comprehensive training or information manual have been provided, would you be open to having your officers be provided with such training?
