Good morning Sarah,

The following response has come back from our Ministry staff regarding your constituent's casework.

1. *The Ministry does not hold historical records related to this issue. The Ministry further advises that the length of time that has passed will present challenges with respect to obtaining historical records, or limitations with regard to formal complaints/claims.*
2. *The Ministry recommends that the family generate the supporting paperwork that a first payment was received for this matter & specific details as to what & why this payment was being made.*
3. *The Ministry recommends that this information be presented to the Milk Board and the Farm Industry Review Board (FIRB) with a request for a formal response from them on this matter.*

I know that your constituent had asked for any options besides going to the Milk Board, and this was passed on to Ministry staff. However, it appears they believe that presenting this to the Milk Board, in addition to the Farm Industry Review Board, would be the best course of action. If your constituent has already done this or doesn't believe this will be feasible please let me know and I can see if we have any other options available, but it seems that the Ministry believes this would be the best way to go.
