Hello Heather

Thank you for your reply regarding my request for an appointment with Mr. Shapitka. Our non profit community club, the Bull River Bbq Ranchers Society has applied to the Columbia Trust Grant for funding to rebuild our community riding arena and a small multi use paved area. The arena currently lies on owned community club property and on a Crown Land Tenure. The rebuilding of the arena is required as this structure is over 30 years old and yearly maintenance has now become to the point of a total reconstruction. Almost most of the reconstruction is on our Crown Land Tenure. We have decided to rebuild a smaller structure to reduce building and

future maintenance costs. With that in mind we realize that our community club has now property freed up that we would like to put a small piece of pavement on to have multi use of. This would include the use for farmers market, yard sales or string a net across it for pickleball or tennis etc. I contacted our RDEK and somehow they latched into the language of tennis court and said that through them that we did not require permitting or rezoning of our property for pavement but suggested that I contact the Agricultural Land Commission in regards to placing pavement on our lots in Bull River for multi use. These lots used to be residential lots years ago here in the townsite of Bull River and in fact do lie in the ALR. The lots in question are # 20, 21, 22, and 23. I contacted the ALC Dec 19, 2018 just after the applications for Columbia Trust Grant funding became available. You can see the response from them after I call Mike Bandy friday January 11 as I had not heard anything more from the Land Commission.

You can see his response which is a bit vague. It is my understanding that we need to apply to have the portion of our community property in question for the pavement be applied for as non agricultural use. Depending on the application type this is an application fee of either \$900.00 or \$1500.00 which we do not have as a small non profit society. The due date for Columbia Trust Finding is January 21. 2 pm, 2019.

I am now seeking intervention and assistance in overcoming this late received information in order that we can meet our application deadline. This request for a multi use space of pavement of approximately 100' x 50' appears to be ludicrous when theoretically the community property could sold and a home and outbuildings could be built on it in the Bull River townsite. I am available to come in and meet with you if needed.

Dear Mr. Bandy

In reference to Lot 1 PPlan NEP 16522 located in Bull River BC and owned by Bull River Bbq Ranchers Society which is non profit.

We currently have a small community hall, gazebo, small children's playground and large riding arena. We are planning on reducing the size of our arena to reduce maintenance costs thereby freeing up a small space in which to add diversity to what our non profit community association can offer to its community.

We are interested in putting some some hard surface ( pavement) onto this lot. Size would be approximately 100x 50 feet at the north end. This would be utilized as a small multi court for (tennis/pickleball and zone shooting for basketball). Current use is small bleacher area at the north end of our community riding arena. The hard surface can also be used for farm marketing as well, either on a weekly or monthly basis throughout the summer. This would further enable our non profit community club to raise additional funds to help keep our playground, riding arena and hall maintained. Please advise if we require a permit to undertake this endeavor. We are hoping to secure some Columbia trust funding for our projects this year and our application needs to be in place no later than Jan. 21, 2019 by 2 pm. Your earliest response is of essence for our application for funding and ideally by the end of the first week in January. This will enable us to still gather quotes etc for our upcoming application for CT funding.
