MLA Dean met with a group of constituents who are concerned with the BC SPCA and its responsibility to dogs. The following are their meeting points:

[&]quot; Good Morning Chris,

"Conflicting Roles: They lobby, educate, are a charity, certify and endorse businesses, enforce and investigate animal cruelty, and now are inspectors for breeding laws. Their advocacy work and their enforcement show a conflict of interest. They should not write legislation that they then enforce and profit from. They have a huge amount of unchecked power, under the assumption that they are experts in everything animal, which they are not.

They Endorse and Certify Businesses of Dog Training, Farming, Pest Control, and inspect for the Breeding Law requirements, yet they are not Dog Trainers, Pest Control experts, Farmers, nor breeders. They are making profit from this certification process, as businesses must pay to join and go through their process. Their requirements for dog-trainers make it impossible to train dogs, and hundreds of dog trainers wrote saying as much. Many got a form email back, thanking them for their input, but it didn't align with their values so the concerns would be ignored.

They write and push their laws for municipalitites, which shows their bias and lack of experience in said areas. Recently they had an ad campaign for 'help the black bears in your neighbourhood'. When you clicked on the link, it was a form letter to send to your own mayor and council, pushing their Model Animal Bylaw which is to do with dog training, and tethering, among other things. https://spca.bc.ca/news/bylaws-bc-wildlife-attractants/ Yet the link had nothing to do with protecting wildlife other than a PDF on tips and suggestions. They are garnering support with broad topics like "Be a voice for wildlife" because we all want to help wildlife, but unknowingly, you are supporting a ban on tethering of dogs, which will make dogs in rural communities have a much lower quality of care than at present.

Currently they are exempt from having to provide Freedom of Information. They are able to search, seize and investigate, with no transparency about their process.
