Vancouver Green City Grant: Up to \$100,000 for projects and programs by registered charities/societies that aim to establish, test, or build on ideas or actions that support Greenest City targets (which includes "Healthy Ecosystems", which in turn includes "local food", "lighter footprint" and "clean air" among others; I think there's certainly a case to be made that their project could fit under several of these) https://vancouver.ca/people-programs/green-grants.aspx

Vancity Partnership Funding Programs: Up to \$10,000 for supporting projects under a number of categories, including "environmental sustainability", which includes "build[ing] and protect[ing] natural habitat" and "grow local and sustainable food" https://www.vancity.com/AboutVancity/InvestingInCommunities/Grants/CommunityPartnershipProgram/ProgramGuidelinesAndCriteria/

**Vancouver Foundation:** Couldn't find a specific grant here per se, but I know these folks have a ton of money; it could be worth checking out the Participatory Action Research Grants (first link below)? I've also included a link to the 20 successful grants categorized as "environment" from 2017. The grant value varies from less than \$10,000 to over \$200,000, but most appear to be in the \$15,000-45,000 range

Dear Ms. Boyum

Thank you for your email of September 12, 2018, regarding your concerns about the use of glyphosate. I apologize for the lengthy delay in responding.

The role of the Ministry of Environment and Climate Change Strategy (ENV) is to ensure that pesticides are used properly and responsibly. The need to achieve "free to grow" status is an obligation under the Forests and Range Practices Act, which is regulated by the Ministry of Forests, Lands, Natural Resource Operations and Rural Development.

The sale and use of all pesticides in Canada is regulated by Health Canada's Pest Management Regulatory Agency. Health Canada conducts rigorous evaluations of pesticides prior to approval, and then re-evaluates all pesticides on a regular basis to factor in new information. A recent re-evaluation of glyphosate was conducted by Health Canada in 2017, and they concluded that glyphosate was unlikely to pose a human cancer risk and that dietary (food and drinking water) exposure is not expected to pose a risk of concern to human health. A summary of this re-evaluation is available on <u>Health Canada's website</u>.

My ministry works closely with Health Canada on pesticide issues. In addition to re-evaluations conducted at the federal level, ENV further regulates the use of pesticides through the Integrated Pest Management Regulation. Use of these products on public land, and commercial use of these products as a service, requires an authorization and a certificate of training from my ministry.

The Integrated Pest Management Act (IPMA) requires that Integrated Pest Management be the overarching principle when applying pesticides under an authorization. Integrated Pest Management is a practical decision-making process that aims to reduce any unnecessary use of pesticides and promote the use of non-chemical techniques to manage pests. A summary of the IPMA and Regulation is available online.

I can assure you that ministry staff seek to stay current on potential risks from pesticide use and monitor the evolving understanding of potential impacts of glyphosate and other pesticides on human and environmental health. These activities include monitoring for developments in pesticide evaluation activities conducted at the federal level and reviewing new findings in peer reviewed scientific publications. If new information is discovered that indicates further activities conducted at the federal level and reviewing new findings in peer reviewed scientific publications. If new information is discovered that indicates further actions are required to help protect the health of people and the environment, my ministry may modify applicator training material, create hest management practices, initiate discussions with Health Canada or modify the requirements in the IPMA and Regulation. Ministry staff are currently reviewing literature for any new or recent information and findings, and will report to me.

Thank you again for writing and communicating your concerns regarding responsible pesticide use.
