- Bill 52, the Agricultural Land Commission Amendment Act protects farmland in B.C. to support farmers.
- Right now, people who live in the ALR and want to build additional homes on farmland to support their farming operations can do so with permission from their local government and the ALC.
- Under the previous government's legislation ALR landowners in Zone 1 were allowed either one carriage home, or a mobile home, not both.
- The new process has the ALC, who has the technical expertise on farming, making decisions together with local governments
- The Ministry of Agriculture's first step in revitalizing the ALR was to get a legislative framework in place.
- As the Ministry continues to work on regulations to support Bill 52, they
 are working with local governments, the ALC and interested stakeholders.
- The Ministry of Agriculture has heard from people regarding manufactured homes and additional dwellings for non-farming purposes, and is exploring opportunities that minimize impact to the ALR while supporting the diverse needs of family farms in the ALR.

As a reminder, after AGRI's regulation implementation that $\frac{s.15}{s.19}$ supported in BDD, much of the work shifted to BDD. In the response below I didn't mention the JTT-related work done by $\frac{s.15}{s.19}$ which I believe was a one-off, or mention $\frac{s.15}{s.19}$.

vs.15; s.19 Cannabis Secretariat will connect in as needed, and we will continue to connect across AGRI as different eApps and needs are identified. Once the recent ALC and UBCM issues respecting cannabis are completed (and the items in eApps proceed to s.15; s.19 and my team can prepare short guidance for AGRI BDD staff.

In the fall we hosted monthly cannabis implementation sessions across the Ministry. Post-Bill 52 we had calls or meetings with AGRI's strengthening farming team and the regional agrologists. We will do this on Bill 15 as well and as a precursor to the larger guidance and support we will provide to external audiences on the new legislative framework (now that the bills are passed in the Legislature and likely to support Bill 15 coming into force.

For clarification, we did not provide wording, we just clarified for Chris what the rules actually were vis a vis additional residence (including manufactured home) and clarified what was linked to farm use and what was linked to family. Specifically:

- Additional residences required permission in both zones and needed to be linked to farming
- Exception was in Zone 2 for parcels over 50ha, where a second single family dwelling was permitted (i.e. no required link to farm use)
- Both zones also permitted a secondary suite AND either a manufactured home for immediate family OR a
 accommodation constructed above an existing building.

I don't actually understand what they were trying to say in that bullet, so cannot propose wording, although very happy to review draft language.

Chris Gailus: A provincial rule change affecting ALR land in Langley has left a number of families with big plans in limbo.

Sophie Lui: In the past, the township could issue permits for secondary dwelling if a certain farming criteria had been met. But now critics say those rules have changed, and with little warning.

Brian Fichter: This is it. This was the pathway which was going to be done in brick that would lead to grandma's house.

Aaron McArthur: What was supposed to be home is now an empty field. According to the rules, it has to stay that way.

Cathy and Brian Fichter's retirement plans evaporated when the government changed the law surrounding the agricultural land reserve.

Fichter: The legislation is so flawed. So flawed. There's just no other word to explain it.

McArthur: The Fichters and their daughter's family fought the property to better meet their multi-generational needs. The five acres will be home to a hobby farm. The legislation was changed the prevent megahomes from being built on the ALR. But caught in the middle are people like the Fichters who can't afford to build a new home and can't build a small second home either.

Cathy Fichter: It's beyond frustrating right now. It's so stressful.

Alana Fuduric: We look at the size of the modular home that my parent's purchased and the footprint that our home here takes up. It's considerably less than a lot of the larger homes that we see going in.

McArthur: The Liberal opposition has been arguing for months. The legislation is too rigid and doesn't allow for reasonable exceptions.

Jas Johal: The NDP said that they would consult with farmers. They said that they would finally make a decision in November of 2019. They pushed their legislation through in February. That's why the farming community is so angry.

McArthur: The Minster of Agriculture couldn't do an on-camera interview but said in a statement, we expect soon to allow a grandfathering period for manufactured homes for immediate family members in order to better balance the protection of the ALR with the diverse needs of the people who call it home.

Cathy Fichter: Right now it's definitely stuck, from our point of view. There are many, many families that are fighting this as well.

McArthur: The township has issued a permit for a secondary home. The manufactured home is ready to go. The only thing missing is provincial government approval.

Despite the reported claims by the MLA from Vernon-Monashee, people will, in fact, still be able to have secondary homes, detached suites and mobile homes on land in the Agricultural Land Reserve. The only change is that they will now require approval from the Agricultural Land Commission, instead of their local government.

There is also a path forward at the ALC for farming and ranching families that need homes larger than 500 square metres [about 5,400 square feet], provided they receive support from their local government.

I'm a former farmer myself. I know farmers are up at the crack of dawn, in all kinds of weather to put food on our plates. They are some of the hardest working people I know. We're making changes across the board to support them. We've relaunched the popular Buy BC program to help farmers market their products to reach more people looking for made-in-B.C. products. And we've kicked off a Feed B.C. pilot program in the Interior to increase the amount of B.C. food in our hospitals. We're going to continue to support farmers and ranchers so they can keep creating good jobs in B.C.

Hi Geoff and James, in discussion with policy and legislation staff today, we arrived at a proposed end date of February 1, 2020 for the draft regulation.

This date will go into the draft regulation today to meet the deadline to leg counsel of 3pm tomorrow. The rationale for this date, and not the current grandfather deadline for primary residences of Nov 5 2019, includes the following:

- Provide ALR families with sufficient time to seek permits and approvals from their local governments where families had ordered or purchased or otherwise prepared their ALR properties for manufactured houses but were caught by the Feb 22 2019 regulation change that did not provide grandfathering for manufactured houses
- Provide sufficient time for local governments to review/consider applications and requests for permits within their regular internal permitting timelines (from 3 weeks to 6 months

- depending on municipality)
- Ensure there is no run on manufactured homes beyond what can be reasonably accommodated by manufactured home builders
- Not pick a Dec 2019 or early Jan 2020 date that would increase frustration due to impacts to local governments and ALR families from the holiday season
- Connection to new homeplate policy development, unclear homeplate timeline, but expectation that engagement requirements will push that proposed regulatory matter well into the new year
- Ensure some parity with the grandfathering provisions granted to those building a principal residence of greater than 500m2
- Ensure where it is farming families that are bringing a manufactured home onto the ALR for non-farming purposes, that the permitting and preparation does not impact the farm season (summer/fall)

I had my information analyst conduct a search in CLIFF and the Minister's inbox:

Bill 15 - We have received two letters to date on this topic. Both are against the bill.

The first one (190046) takes issue with dictating what "persons" can and cannot do on their land: "As a PERSON, you are stripping my rights from land I OWN. Not You, not the government and not any other governing bodies. ... I call for a change of Bill 15 and a consultation of all agricultural affected land owners."

The second (190052) takes issue with putting in force a bill that applies to all land, even if it is unproductive: s.22

s.22 And now I

find.. you want to take all our rights on the land we have left...really...this land has not produced anything in almost 20 years now...why is it even in the ALR...and now.. I don't have any options left ??? Not all land in the ALR...should be in the ALR...You can't just put a Bill over all this land...it makes no sense....you are just making more unproductive land..even more so."

Bill 52 - 46 letters have been received to date and the majority are in support. Limited "mega mansions" is the most written-in about topic and many are supportive of restricting the size.

There is one letter we received from the City of Chilliwack regarding Official Community Plan's not being considered when applications are being approved/denied by the ALC. (CLIFF 190073)

Hon. L. Popham: I think we can all agree that the highest and best use for agricultural land is for farming and for ranching. As we work to protect the ALR, we want to ensure that we are also supporting farming families. We know how important multigenerational farming families are to our vibrant farming sector. I also know some of them may need houses that are larger than 5,400 square feet to accommodate their families and support their farming operations.

We are a government that truly listens. We have had very good representation from our Surrey MLAs, who brought forward a number of concerns to my attention over the last couple of weeks. This amendment is in response to those concerns, and it ensures fairness for people.

This amendment will mean that people who have their permits and authorizations in place when the regulations are approved in the new year will be grandfathered under the old system. They will have until November 5, 2019 — a full year from the date that this bill was introduced — to begin the construction work. They will no longer be required to have a substantially started construction of the foundation.

Regardless of this amendment, it is also important to emphasize that farming families, no matter what stage of application or planning they're at, will be fine. We have ensured that all farming families who need the extra space to farm and to support their farming operations have a path forward at the ALC for them to build a house larger than 5,400 square feet. That is in the legislation.

In response to concerns I've heard from my colleagues, I spoke to the chair of the Agricultural Land Commission. She told me that those applications for houses larger than 5,400 square feet will be decided quickly, less than 90 days, on average. The ALC will treat people fairly, transparently and will make decisions in a timely manner, based on straightforward criteria.

We are working on those criteria right now to come in the new year through regulation. We are looking at including things like the importance of multigenerational housing, good-faith investments that have been made, and applications and permits in process.

Most importantly, the criteria will be specific, and it will be designed to ensure there's a path forward for farming families that need extra space to support their farming work. We're committed to making sure this process works for multigenerational farming families who need extra space, and we will continue to listen to the people of British Columbia

м. **Hunt:** Let me just give a couple thoughts here and get the true or false, sort of, back from the minister.

Under this amendment, if you're a legitimate farmer, and you've been farming for years, you can actually build a bigger house, and there are no restrictions on how big that house is.

- Hon. L. Popham: What this amendment states is that anybody who has gone through their local government process and has their building permit in place by the time this comes into force in early 2019 will be able to proceed. They must have their construction started by November of 2019.
- M. Hunt: Let me give this as a quote. True or false. "If you are a legitimate farmer, if you are doing farming for many years and you are a joint family, you can actually build a bigger house. There is no restriction on you." True or false?
- **Hon. L. Popham:** I'm not going to do true-false. I think that I'd rather give you my interpretation of it.

[3:55 p.m.]

If a farming family is not captured by this amendment that's been put forward, if they're outside of that amendment.... We have recognized that multigenerational farm families may need a bigger house to live in. Because of that, we've made a clear path forward for farm families who are farming and need more space to support their farming activities. We have made a clear path. They will go through local government, as they always have, and then they will go to the Agricultural Land Commission to be approved for a larger home. There will be an assessment whether or not they're legitimate farmers, but that's not too hard to prove. If you really are a legitimate farmer, I think it's pretty clear.

What you won't be able to do.... If you are a speculator or a large developer, and you want to build a home that's larger than 5,400 square feet on the agricultural land reserve, you will not have the opportunity to build a larger home.

M. Hunt: Then let's deal with the situation where the person has a preload on their property at this moment in time. If they have preload on their property, this amendment then gives them a year to get their building permit and actually pour the

foundation — or simply to get their building permit, and then they can build the larger house? We're dealing here with larger houses rather than being under, just to be clear.

- Hon. L. Popham: If you're a farming family that requires a home that's larger for farming purposes, if you have preloaded or if you've started your application, you have a clear path forward to get approval from the Agricultural Land Commission. If you want to be captured by this amendment, then you have to have all of your building permits in place when this legislation comes into force. But if you're a farming family, there's no deadline. You can continue your plans to have a larger home.
- M. Hunt: That is with going through the process of getting local approval and the ALC approval for that, correct?
- Hon. L. Popham: You will always have to go through local government to get your permits in place. Local government will forward, if you are a farming family that requires a larger home for farming purposes, your application to the Agricultural Land Commission, who will, within 90 days, make a decision whether or not you're a legitimate farming family who requires a larger house.

Let's be clear. This legislation is made to support farmers. Some of the criticism that has come forward from the official opposition is that you can protect the land base, but you don't support the farmers. This legislation is specifically to support farmers and farming families. It is not to support development and speculation on farmland.

M. Hunt: Okay. Now just to flip that over, we're not going to deal with the farmer. We're going to deal with the bad guys, okay?

Interjections.

M. Hunt: Well, whoever the bad guys are. So the bad guy has bought a piece of property in the agricultural land reserve and has already started his or her preloading on that site. Can they continue to build? Under this amendment, do they have the year to, in fact, get building that site? Or does this amendment not allow them to build as of the royal assent to this bill?

[4:00 p.m.]

Hon. L. Popham: Anyone who has gotten their building permit finalized by the time this legislation comes into force will have one year to start their building.

I. Paton: I want to go on record with this amendment as saying I am in no way in favour of what has happened in Richmond over the years — massive mega-homes, over 30,000 square feet, plunked in the middle of farms. What I'm asking is....

We put forward an amendment to limit the first floor to 350 metres squared, which was going to take up less farmland with a smaller first-floor foundation plate. But saving farmland and making this a very, very useful amendment to the legislation doesn't go far enough, unless, in the regulations, we're willing to put in a home plate and a siting of the home plate, like we've done in Delta. If we continue to allow 5,400-square-foot farmhouses plunked in the middle of a piece of land that someone built with a great long driveway that goes in 200 feet, it's defeating the purpose of this.

I'm asking: what will go into the regulations, as far as limiting the home plate to 40 metres by 40 metres, which is roughly what...? Or 60 by 60, 3,600 square metres.

- **Hon. L. Popham:** We will be addressing siting in the regulations, and I would welcome the member's input. We know that Delta is an excellent example of that. Chilliwack has just also enacted bylaws that address the siting of a home on the ALR. So yes, we'll be addressing that, and I welcome the member's input.
- I. Paton: I appreciate those comments, because I think we're moving in the right direction here. However, as I said before, it's so important to get to the regulations and make sure that we have the home plate siting on a farm that makes sense so that we're not using up valuable farmland.

Anyone who's farmed will know that if a new home is plunked in the corner of a farm next to the road, within 60 metres of the road, it's quite easy to farm around that. But if you've ever tried to farm with hydro towers and different things in the middle of a farm, it's very, very difficult. This is a good thing to make sure we that bring in to the regulations once this is passed.

Grandfathering extended for manufactured homes for immediate family in ALR

VICTORIA - The grandfathering period for manufactured homes for immediate family members in the Agricultural Land Reserve (ALR) has been extended to February 2020.

This is a result of a regulatory change brought into force July 4, 2019, as work continues to protect farmland and support farmers.

"Less than 5% of B.C.'s land is in the ALR. We need to protect this farmland to support farmers, encourage agriculture jobs and strengthen food security in B.C.," said Lana Popham, Minister of Agriculture. "As we've worked to make long-overdue changes to help farmers farm, we heard from people living in the ALR, many who said they aren't farming but purchased ALR land for residential use. We understand that some have been caught in the transition. We've listened and have given people a bit more time to get their permits in place."

Landowners in the ALR will now have until Feb. 22, 2020, to obtain all the required permits and authorizations to place a manufactured home for immediate family on their property.

"We are happy about this change as it gives our son and his family the opportunity to have a home on our ALR property," said Kris Welk of the Comox Valley, "It provides us with the flexibility we need so we can age in place with our family."

Government will engage with B.C. farmers, agricultural associations and local governments as work continues to help B.C. farmers farm.

"We appreciate the Ministry of Agriculture listening to the township's concerns regarding recent changes to the Agricultural Land Commission regulations," said Christine Fraser, mayor, Township of Spallumcheen. "This interim plan will help families who were already in process with their second residence when the changes occurred. We look forward to consulting with the ministry next year on future regulations that will provide more flexibility for families that are farming in our community."

The change is part of ongoing work on regulations for Bill 52-2018 and Bill 15-2019 to protect farmland and support farmers. Farmers in the ALR continue to be able to build additional residences to support farm use, including manufactured homes, by application to the Agricultural Land Commission.

"When the old government made changes to the ALR, they took a piecemeal approach that hurt our producers," said Popham. "The ALR has been around for over 40 years, and there's a lot of work to do to modernize it so it works for farmers today.
