Hi James

The agreement does not specify when during a quarter each quarterly payment needs to be made – so we just have to make the first quarterly payment before June 30<sup>th</sup>.

James, as discussed, here is a breakdown on the current and planned staffing changes underway in CGPL. I've broken this down by unit.

**Policy:**

- Backfill of s.22 (27) will proceed – likely for 9 mo. or 1 yr. TA.
- There was talk of advancing another 24 with the expectation that s.22 s.22
- **NOTE:** I may advance a request for further staff in this unit (e.g., another 27). I will need some time to better understand the files and workload.

**Corporate Information and Reporting and Stats:**

- s.22 will be getting a salary bump to accommodate the joining of these two units.
- ECON 27 position is live to backfill s.22 on a TA basis of 1 yr.
- New ECON 30 hiring request went forward. This will be a new team lead position.
- New Project manager 21 (funded from BCSRIF).
- **NOTE:** s.22 lift and the 30 are funded from salary that was formerly s.22 Band 2. That Band 2 position will be cancelled.

**Legislation:**

- No changes or hiring at this time.

**Intergovernmental Relations, Seafood and Trade:**

- s.22 is on temporary assignment into a new Band 3 position to support ALR engagement work. She will be reporting directly to you so I'm unsure of whether she is in CGPL or ADMO.
- I will be seeking to backfill s.22 Band 2 on a TA basis. Likely will seek to appoint s.22 s.22 on a 7 mo. TA. Will not seek to further backfill s.22 position at this time.
- Hiring 3 Senior PA 27s on seafood – one is a replacement for s.22 two are new and funded through BCSRIF.
- **NOTE:** Will be seeking to NOT fill s.22 previous Band 4 position. Salary dollars can be used against 50 pressures. s.22 will report directly to me. This will streamline the reporting structure in the branch (i.e., there will only be one layer of management across all units).

**Admin:**

- The Office Manager TA is coming to an end shortly. I will be looking to run a new permanent competition for this s.22 has been informed of this and welcomed to apply, noting that it will be an open, competitive process.

As discussed at DMC on March 15<sup>th</sup>, the Ministry of Citizens' Services is initiating a call for new actions to incorporate into the *B.C. Procurement Strategy*. The Strategy was launched in June 2018, and aims to modernize and transform government's procurement system to allow it to more effectively support government's goals of making life more affordable, delivering better services for families, and investing in a strong, sustainable economy that works for people.

The 20 initial commitments to action made by the Strategy are underway with some recently reaching completion. To continue building on this momentum, we are seeking input on additional actions that your ministry is taking, or contemplating, that could be included in the update to the Strategy targeted for June 2019.

Action proposals should be aligned with one of the four goals of the Strategy and may vary in size from large policy changes to smaller benefit realization projects.

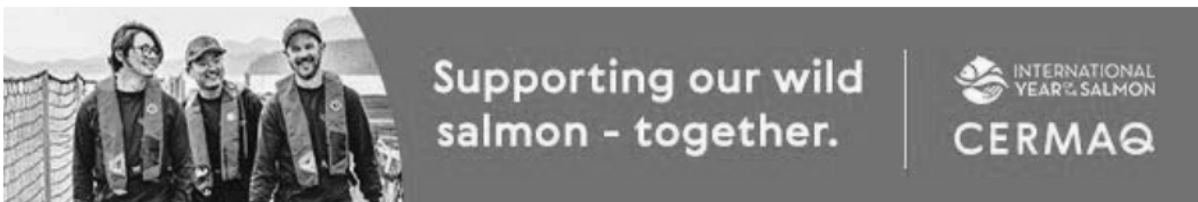

In regards to Cermaq's tenures, Maude #1405739, Simmonds # 1407730 & Wehlis #1407731, these tenures were scoped out of the Broughton area government-to-government process. As such, they are subject to the new provincial policy announced on June 20, 2018:

Specifically, I draw your attention to the following sections:

- *Effective June 2022, the Province will grant Land Act tenures only to fish farm operators who have satisfied Fisheries and Oceans Canada (DFO) that their operations will not adversely impact wild salmon stocks, and who have negotiated agreements with the First Nation(s) in whose territory they propose to operate.*
- *The year 2022 aligns with the current renewal date of the substantial majority of fish licences issued by DFO. Operations with expired provincial tenures, or tenures that expire before June 2022, may operate with month-to-month tenures.*

Our current approach is to leave tenures in the month-to-month tenancy; however, if you still wish to pursue a tenure replacement, we are able to review a replacement with a term ending in 2022. If you can demonstrate that the two conditions can be met, it may be possible to consider a longer term replacement. The application review will be subject to consultation with First Nations.

We were working with s.22 and s.22 in May 2017 to assist s.22 in meeting the organic requirements of s.22 certifying body SOOPA so that s.22 could take his birds there for processing. The last we heard was that they were working on it. Apparently, s.22 was not able to achieve certification for organic slaughter. Meanwhile, s.22 Class E licence expired. If he cannot get the specialized organic slaughter service he requires from s.22 for whatever reason, then he could have applied for renewal of his own Class E. I don't know why he didn't apply to the Health Authority but we almost certainly would have recommended a licence for him.
