VANCOUVER – Families in British Columbia can add a blueberry milkshake or blueberry pie to their orders at over 100 White Spot and Triple O's participating locations this summer, as part of a new Buy BC partnership with the popular restaurants to promote B.C. blueberries.

"This partnership means more support for our agricultural industry and reaching new markets and consumers all over the province," said Lana Popham, Minister of Agriculture. "Working alongside White Spot and Triple O's will help highlight the Buy BC brand, which encourages British Columbians to purchase products grown or produced here at home."

On the weekend of July 12, 2019, BMO will be upgrading their card processing platform and rolling out new features and changes to the card program.

BMO Spend Dynamics online will be unavailable between Saturday July 13th, 2019 @ 9pm and Monday July 15th @ 9pm.

Please review the attached documents which outline the updates:

- 1) **Guidebook** with all of the changes to the Travel card program. Please note there are changes noted in this guidebook that apply to the BMO purchase card and BTA, please disregard.
- 2) **Corporate Travel Entertainment Program Insurance Certificate** – This is a new Certificate of Insurance for all Travel cardholders.

There were a few questions that BMO has answered:

Q: Will new and existing BMO Travel cardholders have this new insurance?

A: Yes, effective July 12/19, the current travel insurance changes to the "Corporate Travel & Entertainment Program" Insurance

Q: Will cardholders be using Mobile Wallets?

A: This is in the works at BMO and they are exploring what the implications are for the Province of BC.

Q: For the new PIN reset feature by phone, what questions will BMO ask the cardholder to confirm identity?

A:

- Cardholders full name,
- Name of Corporation and Activation code (this is the information you would have used to activate your card)
- Your address on file with BMO (where you receive your monthly statements)

Q: How does a cardholder go about making a claim with the new Insurance?

A: Cardholders will phone the Insurance provider – phone number on the back of the card. They will assist with processing the claim and if the claim is valid, they would apply the credit back to your card/account.
