We are working in partnership with Fisheries and Oceans Canada to protect the health of wild salmon, and support the First Nations, communities and industries that rely on them."

"Wild salmon are a part of who we are in this province. Over the past 20 months, our government has been working with First Nations and industry to develop a path forward towards a sustainable B.C. fishery

that supports wild salmon. By dedicating resources to habitat restoration and salmon runs, this fund will build on that work to make sure wild salmon stocks thrive in B.C.

Governments of Canada and British Columbia now accepting proposals to help restore Pacific salmon and boost the province's fish and seafood sector

Wild Pacific salmon is integral to the economic and social fabric of coastal communities, and is fundamental to Indigenous communities across British Columbia. The protection of our wild fish stocks is vital to the environmental and economic sustainability of the province. Today, the Minister of Fisheries, Oceans and the Canadian Coast Guard, the Honourable Jonathan Wilkinson and B.C. Premier, the Honourable John Horgan officially launched the British Columbia Salmon Restoration and Innovation Fund at Fisherman's Wharf in Victoria. This fund is a federal-provincial collaboration that will invest in projects to support good middle-class jobs in the fishery while protecting and restoring the habitat of our wild fish stocks in communities across British Columbia. The fund will also support fisheries innovation, science and infrastructure so that B.C. fish stocks can be harvested efficiently and sustainably into the future. These investments support the protection of B.C.'s wild fisheries and a sustainable seafood sector – including a much needed boost to help protect and restore wild Pacific salmon.

The Fund is now open to proposals from Indigenous groups, conservation groups, commercial organizations in the wild fisheries and seafood sector and industry associations, recreational fisheries, as well as non-commercial organizations such as universities and academia, industry associations and research institutions.

To be eligible, projects must focus on one or more of the following three areas:

- Innovation – to encourage the development of technologies that help meet conservation and sustainability objectives, including the protection and restoration of wild BC stocks, including salmon, as well as new products that will increase sustainability and productivity in the wild fisheries and seafood sector;
- Infrastructure – to encourage capital investments in new products, processes or technologies to support the advancement of sustainable fishing practices and to support the protection and restoration of habitats important to wild BC stocks, including wild Pacific salmon;
- Science Partnerships – to support collaborations with academia and other research institutions to improve our knowledge and understanding of impacts to wild stocks and to develop sustainable fishing practices.

The investments from the British Columbia Salmon Restoration and Innovation Fund will ensure B.C.'s wild fisheries are environmentally and economically sustainable for the long-term and that jobs in the fishery are resilient to the challenges of climate change and evolving economic conditions. The fund will also help protect and restore priority wild B.C. fish stocks, including Pacific salmon. Consumers will also benefit from high-quality, sustainably sourced, Canadian fish and seafood products.

Hi Jessica,

There is no problem whatsoever about postponing our visit until May. In fact, talking with Mica last night, he thought May would be a better time for the Minister to visit his oyster farm.

Mica and I have a great working relationship. Together we share a common purpose even though our specific needs are rather different. For example, as a primary producer, Mica needs a Federally approved and inspected processing facility in this area so he doesn't need to truck all his product to the mainland for processing. Codfather, on the other hand, can operate adequately with just Provincial approval until we reach capacity and are ready to export from BC.

Until recently Codfather was licensed by the Ministry of Agriculture - Fisheries. This severely limited our offerings to that of a primary non-shellfish processor. However, we just received approval from Island Health to commence production of value-added products such as smoked oysters, smoked mussels, Salmeroni (that's pepperoni that uses salmon instead of beef and pork), salmon sausages and smokies, and so forth. This is very exciting as we recently won a people's choice award for the Best Seafood despite the fact we aren't even a restaurant (attached).

I'll be Victoria on Wednesday of this week. I realize this is short notice so I would assume the Minister is otherwise engaged but I'm pleased to drop off some samples in a cooler for your office to enjoy.
