The following situation report is being shared to update you on the ongoing response to the outbreak of Covid-19 at a mink farm in the lower mainland.

- Work continues with responding agencies and organizations to finalize and approve safe operating
  procedures to enable the producer to safely provide animal care and complete harvesting activities
- Operations Section is addressing the need for authorization to allow for fuel delivery and garbage pickup on the impacted farm (as it is currently under quarantine)
- The Producer on the impacted farm has reported the loss of operation of one of the farm freezers
  - We are working to determine the impact of this on the farmer's current plan to euthanize and store harvested mink for future processing (as the farm is not currently permitted to undertake pelting operations)
- Planning and Logistics Sections are working to ensure required materials are available to support the surveillance plan that is being finalized
  - o Planning Section is also liaising with FLNRO staff regarding the wildlife surveillance component
- Incident Command is liaising with the Fraser Health EOC Director to ensure strong ongoing coordination and communications between the human health and animal disease response to this incident
  - AGRI responders have been actively engaged with Fraser Health staff on the response since the beginning of the incident

The following situation report is being shared to update you on the ongoing response to the outbreak of Covid-19 at a mink farm in the lower mainland.

- Discussions occurred today with the impacted producer to discuss options for the acquisition and submission of mink samples
  - Exploring options for safe sample collection that would eliminate the need for the producer to provide the entire mink carcass for sampling
    - This would reduce the potential financial impacts to the producer by allowing him to retain the pelts for future sale
- Approval has been given for the producer to undertake pelting of the remaining mink that are ready for harvest
  - Currently the producer is euthanizing and freezing the harvested mink for future pelting due to staffing challenges
- The producer has reported that they were able to repair the farm freezer that broke down on Thursday
  - The producer is using on farm freezers to store the mortalities that were previously collected and for storage of the harvested mink for future pelting
- AGRI is working to identify and activate a responder to assist with the development of biosecurity protocols for the impacted farm
  - CFIA is assisting with subject matter expertise and advice with respect to biosecurity (as well as other areas of the response)
- Liaising with the Provincial Wildlife Veterinarian (FLNRORD) to coordinate on wildlife surveillance planning
  - Wildlife surveillance will monitor for the potential spread of the virus from the farmed mink into local area wildlife populations
  - Need to address sample collection and submission, biosecurity and quarantine implications, and Covid safety protocols

Only essential response activities will continue through the weekend. The next incident update will be sent on Monday, December 21<sup>st</sup> unless there are significant developments to report over the course of the weekend.

The following situation report is being shared to update you on the ongoing response to the outbreak of Covid-19 at a mink farm in the lower mainland.

- A mink sample submitted on Monday to the Animal Health Center in Abbottsford from one of the noninfected mink farms has resulted in a non-negative test result for Covid-19
  - A sample was sent to the National Center for Foreign Animal Disease (NCFAD) in Winnipeg on Tuesday for testing and official confirmation
    - A media release and background information have been prepared in the event of a confirmed positive test result from the NCFAD
    - A sample will also be submitted to the BC CDC
  - The farm was placed under quarantine by the provincial Chief Veterinarian to prevent the potential for disease transmission from this farm
  - The Producer has reported a number of mink mortalities and recent signs of illness (diarrhea) in mink on the farm over recent days
  - This farm has completed their mink harvesting activities for the year and have approximately 950 breeder mink remaining on farm at this time
  - We have not received any reports of workers being diagnosed with Covid-19 on this farm to date, however Fraser Health initiated Covid-19 testing of all mink farm workers in the province last week
  - Work Safe visited the farm on Tuesday and advised the producer that they will need to update their Covid-19 safe operating protocols
    - The producer is allowed to continue with critical animal care activities at this time
- The BC Mink Producers Association provided an update on harvesting activities at the active mink farms in the province
  - 3 of the 6 mink farms have now completed their harvesting activities and only have breeder mink remaining on farm at this time
  - The 3 remaining mink farms (including Infected Premises #1) are expected to complete their harvesting activities over this week or next
- Advanced Planning continues to develop a contingency plan for depopulation of mink based on 5 potential scenarios (note there is no current requirement to depopulate)
  - A decision matrix for euthanasia is being developed along with a resource list of required materials and personnel
  - o CFIA staff are providing technical advice and input on depopulation planning

- Wildlife surveillance for Covid-19 in wildlife populations in the vicinity of the infected premises is being planned by the provincial Wildlife Veterinarian (FLNRO)
  - Background information regarding estimated escapement of mink from farms and on-farm containment measures have been shared for planning purposes
  - Responders received an offer of support and a copy of a draft wildlife surveillance plan from a wildlife scientist with the Ontario Ministry of Natural Resources and Forestry that has been passed on to the provincial Wildlife Veterinarian
- The BC CDC has now posted information on their <u>website</u> regarding the results of whole genome sequencing
  of the virus in 5 mink and 5 worker samples from Infected Premises #1
  - o The results show the people and animals were infected with an identical or nearly identical strain
  - The strain detected has been circulating in people in B.C., indicating COVID-19 spread from people to animals and not the other way around
  - o One common mutation was detected in both the animals and farm workers
  - BC CDC states that neither the mutation nor the outbreak present an increased risk to human health at this time

The following situation report is being shared to update you on the ongoing response to the outbreak of Covid-19 at a mink farm in the lower mainland.

- Infected Premises #2 made a business decision to euthanize all of the remaining mink on the farm including their breeding stock
  - o Remaining mink (breeders) on the farm were euthanized between December 24<sup>th</sup> and 26<sup>th</sup>
  - The farm remains under quarantine at this time and will remain so until all required follow-up activities are completed (example: cleaning and disinfection)
  - The required World Organization for Animal Health (OIE) report has been completed and was submitted today
- Infected Premises #1 has advised that they require some additional Personal Protective Equipment (PPE) to continue safe operations on the farm
  - AGRI staff are checking on available PPE supplies at the Animal Health Center in Abbottsford which
    may be able to provide some PPE on an interim basis while the farm identifies a suitable supplier
    - AGRI staff are also looking into other sources of PPE that the farm may be able to source additional PPE from
- The BC Mink Producers Association advised this week that they would like to schedule a townhall event with incident response officials next week
  - The Mink Producers have a number of question and concerns they would like to discuss with AGRI and Health agencies
  - AGRI is developing a list of potential participants and an agenda for the event that will be discussed with the association to ensure it meets their needs
  - AGRI has reached out to Fraser Health and BC CDC representatives to select a date and time for the townhall during the week of January 4<sup>th</sup>
- Information Officer reports that there was some reporting on the incident following last Thursday's media release announcing a second infected mink farm in the province
  - An additional media interview request has been received and is being scheduled next week with the Chief Veterinarian
- Command Staff are actively reviewing staffing and incident response needs over the coming weeks
  - Key areas of ongoing activity include surveillance, epidemiology, protocols for mink breeding season (late February – early March)

Greetings,

The following situation report is being shared to update you on the ongoing response to the outbreak of Covid-19 at two mink farms in the lower mainland.

- Mink samples collected as part of the ongoing disease surveillance from one of the non-infected mink farms were analyzed and came back negative for Covid
  - All of the non-infected premises will be providing deadstock (some ongoing mortality is normal) on an ongoing basis for continued disease surveillance at these farms
- The Incident Commander met with ENV staff this week to discuss and address outstanding questions around the handling of waste materials at the infected premises
  - o Currently no known concerns with the handling of the existing waste materials (Covid infected material are deemed to be hazardous waste based under ENV legislation) at the infected premises
- A cross agency meeting was held today with the various agencies involved in the response, BC mink farmers and other mink industry representatives
  - The objective of the meeting was to:
    - Provide an update on the current situation in BC
    - Provide an opportunity for BC mink farmers and industry representatives to ask questions and share their concerns with the responding agencies, and
    - Provide an opportunity for responding agencies to increase their understanding of the mink sector and how it operates to enable us to better support them through the response
  - Participants included representatives from AGRI, FLNRO, ENV, Work Safe BC, Fraser Health, BC CDC, CFIA, Agriculture and Agri-Food Canada, BC mink farmers, BC Mink Producer's Association, and the Canadian Mink Breeders Association
  - Key issues discussed included: human, animal and wildlife disease surveillance; safe operating
    protocols; financial recovery and supports; process for lifting quarantines at infected premises;
    disease information, and the sale and export of mink pelts
- Deputy Incident Commander (Ursula Viney) and the Provincial Chief Veterinarian (Rayna Gunvaldsen) provided a presentation to the agriculture FPT Regulatory ADMs Committee on the topic of SARS Covid-19 and mink today
  - The presentation provided an overview of the provincial response to the ongoing incident in BC, use of the Incident Command System for the response, key issues and initials learnings
  - The Public Health Agency of Canada and the Canadian Food Inspection Agency provided additional presentations on their respective roles in regards to the BC incident, their related work and research

into the risks associated with Covid in mink and other animals, and information they have gathered from other jurisdictions (9 countries) where similar outbreaks of Covid in mink farms has occurred

- FLNRO Wildlife Veterinarian is continuing to work to finalize wildlife surveillance plans in order to commence sampling of wildlife in the vicinity of the two infected premises
  - Establishment of safe working protocols and PPE requirements for contract trappers (including consultation with Work Safe BC) to obtain samples for analysis
  - Securing appropriate permissions from the Chief Veterinarian to allow for access to the quarantine zones and from the owners of the two infected premises to access their private property
  - Key focus of wildlife surveillance is to monitor for transmission of Covid to wildlife from the infected premises and address concerns over the potential for a disease reservoir to be established among wildlife populations

The following situation report is being shared to update you on the ongoing response to the outbreak of Covid-19 at two mink farms in the lower mainland.

- Discussions are underway with regards to the lifting of the current animal health quarantine at Infected Premises #1
  - A critical factor in this decision will be the results of additional mink testing on this farm that is currently underway
- An inspection is scheduled for tomorrow (January 15<sup>th</sup>) at Infected Premises #2
  - Based on the inspection results the quarantine for this farm may be partially lifted with the exception of the mink production area and mink pelts (including any unpelted frozen mink carcasses)
  - o This outcome would also be beneficial for the operation of a secondary business located at this farm
- Agriculture, Food and Fisheries (AFF) and BC Ministry of Environment and Climate Change (ENV) continue to work on the site specific disposal plans and protocols for the 2 Infected Premises
  - Signoff on the plans and protocols is anticipated to occur as early as tomorrow (January 15<sup>th</sup>)
  - ENV anticipates that the required hazardous waste regulatory sign off could occur either tomorrow or Monday (January 18<sup>th</sup>)
  - Disposal plans and protocols also require review by Work Safe BC (who are actively engaged) to ensure worker safety which could impact the above noted timing
- Fraser Health Authority (FHA) continues to work with the BC mink producers and AFF to address current issues and the restrictions implemented in order to protect public safety and human health
  - The AFF Incident and Deputy Incident Commanders met with the FHA's agency lead for the mink farm incident on Wednesday to discuss last week's multi-agency meeting with the mink producers, ongoing issues, and share information as we work to respectively to address both the animal and human health components
  - FHA has advised the operators of the uninfected mink farms in the province that they are now permitted to proceed with the sale and off farm movement of their harvested mink pelts
    - This has been a major concern for these producers since there are limited windows of opportunity to sell their pelts during the year
    - Producers were also extremely concerned that if their farms were to experience a Covid outbreak among their mink that the existing harvested pelts on their farms would be quarantined

- FHA continues to assess the request from mink producers regarding prioritizing of Covid vaccinations for mink farm workers to reduce the potential risks to human health from any infected mink
- AFF continues to work with FHA to clarify ongoing disease surveillance and scheduling of mink sample delivery to the AFF Animal Health Center for testing
- AFF has received additional epidemiological staff support from the Canadian Food Inspection Agency (CFIA) in addition to the support the CFIA is already providing to the response (mink specialists, etc.)
- The President of the BC Mink Producers Association (BCMPA) raised a concern this week with regards to the timing of sampling results they are receiving
  - A new system has been put in place to provide results by email and phone follow-up to ensure results received
- The AFF Incident and Deputy Incident Commanders met with the President of the BCMPA on Monday to discuss last week's multi-agency meeting with the mink producers to address outstanding concerns and issues

The following situation report is being shared to update you on the ongoing response to the outbreak of Covid-19 at two mink farms in the lower mainland.

- Infected Premises #1 has begun submitting samples for testing that is necessary for Agriculture, Food and Fisheries (AFF) to make a determination of disease free status among the mink on the farm
  - o 65 mink samples were submitted this week to the Animal Health Center for testing
  - o A second cohort of mink samples (approximately another 65) will be submitted for testing in 2 weeks
  - If none of the samples test positive for Covid, AFF will be able to move forward with making the declaration
  - Required cleaning and disinfection of the premises will also need to occur
  - Once disease free status is attained the farm will continue to submit samples as part of ongoing disease surveillance (i.e. same protocol that the uninfected mink farms are currently following)
- Infected Premises #2 was inspected on Friday, January 8<sup>th</sup>
  - Good progress has been made on this farm towards completing the required cleaning and disinfection (no live mink remain on this farm)
  - The quarantine order has been adjusted and is now restricted to the mink production areas (ex: areas where remaining carcasses and pelts are being stored)
  - The operator of the farm is now able to fully resume the operations of a secondary business located on the farm
- Work continues to determine the necessary measures required to allow for the release of mink pelts from the two infected premises
  - One option is to send the pelts to a processor in the United State who is willing and able to receive these pelts
  - The other option is for the pelts to remain in Canada for processing which would require testing to confirm the pelts are disease free, or be treated to eliminate disease, prior to sending them to a Canadian processor
    - Treatment options being explored (if the pelts are <u>not</u> found to be disease free) include heat treatment, ozone treatment, or another cleaning method that does not degrade the quality and value of the pelts

- Representatives from AFF, FHA and Work Safe met with the President of the BC Mink Producers Association (BCMPA) today to discuss the current situation
  - BCMPA raised concerns about how they would feed and care for mink during the upcoming breeding and whelping season in the event of a new Covid outbreak on a farm if off farm workers access is restricted
    - FHA committed to working with the mink producers to address this concern
  - A concern was raised about the impact of an outbreak at one of the farms that provides a "feed kitchen" service for some of the other mink farms which would have impacts on the ongoing feeding of mink
    - BCMPA is working on protocols to mitigate this type of impact and will submit them to AFF once completed for further review
  - FHA has proposed the use of self-administered gargle tests for ongoing surveillance and early detection of Covid among mink farm workers
    - This proposal was well received by the BCMPA
- Provincial Wildlife Veterinarian (Helen Schwantje, Forests, Lands and Natural Resource Operations) provided an update on the planning for wildlife surveillance for Covid in the area of the two infected premises
  - The wildlife surveillance plan was developed based on advice from officials in Ontario and the United States (4 states have experienced Covid outbreaks on mink farms)
  - Two local trappers have been contracted to trap targeted species (including mink, other mustelids, and feral cats) for testing at the Animal Health Center, and at the federal lab in Winnipeg as necessary for genome testing
  - The trapping program is anticipated to begin soon and occur over a two week period (which will be modified as necessary)

The following situation report is being shared to update you on the ongoing response to the outbreak of Covid-19 at two mink farms in the lower mainland.

- Testing to declare Infected Premises (IP) #1 disease free continues
  - o Some live animal and environmental testing have now been completed
  - o No non-negative results were found through this testing
  - Additional samples and <u>non-negative</u> test results are still required for IP#1 to achieve disease free status
  - When disease free status is declared, IP#1 will then move to the Cleaning and Disinfection stage
  - No objections have been raised by the responding agencies to upcoming planned mink breeding activities at this premises
- The BC Ministry of Environment and Climate Change Strategy has provided draft approval (required under the Hazardous Waste Regulation for the handling for infected hazardous waste generated at the IP#1) for the producer's review prior to finalization
- The quarantine in place for IP#2 has been amended to apply only to the mink enclosures and manure storage areas
  - Cleaning and Disinfection of the other areas of IP#2 has been completed and AFF sign-off has occurred
- IP#1 and IP#2 have both indicated that they wish to proceed with the sale and export of their harvested pelts to the U.S.
  - AFF is following up with all relevant agencies (provincial, federal, U.S. state and federal) for any consultation and additional information that may be required
  - Work is also being done to assess the need for disinfection of the pelts prior to sale and export and how this would be carried out if required
- Uninfected mink farms in the province are seeking Fraser Health Authority (FHA) approval for the movement of harvested pelts between some of the uninfected farms (this occurs in some cases for additional processing of the pelts)
- Uninfected farms have also indicated that they are working on enhanced biosecurity protocols for their operations to further mitigate the risks of disease transmission on their farms
  - AFF has committed to review these protocols when they are ready to submit (Work Safe will also be consulted)

 AFF is working to secure additional internal or external capacity to review biosecurity plans and conduct cleaning and disinfection inspections

- Infected Premises #1 (IP#1) and IP#2 remain under quarantine at this time until testing requirements to demonstrate disease free status are met and cleaning and disinfection requirements are satisfied
  - IP#1 will undergo its next mink herd testing on Friday, February 5<sup>th</sup> as part of these requirements
- Both IP#1 and IP#2 also have waste management requirements still to be addressed for their farms
  - Once waste handling decisions are made by the producers and information is submitted for the remaining waste materials, the Ministry of Environment will review and issue approvals as appropriate
- The ability of the Infected Premises to export their harvested pelts to the United States is still being evaluated by state and federal agencies

- Ministry of Agriculture, Food and Fisheries (AFF) is discussing ongoing human, mink and environmental surveillance at the Uninfected Premises with Fraser Health Authority (FHA)
  - The process for ongoing mink and environmental testing at these farms is being discussed including the respective roles of AFF, FHA and the mink producers
  - Ongoing human surveillance for Covid among farm workers on these farms is also being discussed (FHA previously required all mink farm workers to be tested)
- AFF has submitted a request to Health and BC Center for Disease Control for additional information on the level of risk mink farming represents vis a vis Covid
- The wildlife surveillance program for Covid in wild animals in the vicinity of the two Infected Premises has now completed its second full week
  - Trappers have been successful in trapping a number of animals in multiple areas, including
     4-5 mink, 2 muskrats, 2 possums, a rat and a feral cat

- While only a few test results have been received to date from the trapped animals submitted for testing, all results received to date have been negative for Covid
- AFF Business Risk Management Branch staff continue to monitor the situation for any extra expenses or losses incurred by the producers which could allow for compensation under the AgriStabilty program

#### KEY MESSAGES. SARS-CoV-2 positive mink on second mink farm in BC

DRAFT: December 24, 2020

- Between December 19 to 21, increased mortalities of mink were reported to the BC Ministry of Agriculture, Food and Fisheries (BC MAFF) at a second mink farm in the Fraser Health Authority region in British Columbia (BC), Canada.
- No human illnesses of workers associated with this premises have been reported. Fraser Health
  Authority conducted testing of mink workers at this premises on December 16<sup>th</sup> as part of a
  public health order for mandatory testing of mink workers and mink. There were no positive
  human cases of COVID-19 detected at this time. Fraser Health is conducting a public health
  investigation, including additional testing, of farm workers and their contacts at the affected
  premises.
- On December 21 samples from dead mink were tested by Real Time RT-PCR for SARS-CoV-2 at the BC Animal Health Centre (BC MAFF) and had a non-negative result.
- On Dec 21 samples from these dead mink were sent to the Canadian Food Inspection Agency's (CFIA) National Centre for Foreign Animal Diseases (NCFAD) laboratory in Winnipeg for confirmatory testing by Real Time RT-PCR (E and RdRp) for SARS-CoV-2. On Dec 24, the NCFAD confirmed SARS-CoV-2 in 21 mink specimens. The CFIA will report these confirmed cases in mink to the World Organisation for Animal Health (OIE) in accordance with international protocol.
- Genetic sequencing of viruses detected in these mink will be conducted at the BCCDC Public Health Laboratory and the National Microbiology Laboratory to monitor changes in the virus and compare with SARS-CoV-2 virus detected in people.
- BC MAFF is responsible for animal health management in farmed mink and has applied a
  quarantine order onto the infected premises to prevent movement of animals and animal
  products onto and off the property and to restrict movement of equipment associated with
  mink production on the premises.
- BC MAFF is working together with Fraser Health Authority and WorkSafe BC to apply enhanced public and animal health measures and monitoring on the affected premises.
- On December 14, the Fraser Health Authority, under the Public Health Act, put a class order on all mink farms in its region to assess if there was evidence of COVID-19 infections in association with other mink farms. This assessment, carried out in collaboration with the BC Ministry of Agriculture, Food and Fisheries (BC MAFF), the BC Center for Disease Control and WorkSafe BC, is ongoing.

### **Supporting messages**

- As a precautionary measure, people who have COVID-19 symptoms or are self-isolating because of contact with a COVID-19 case should avoid close contact with animals, including mink.
- It is important to remember that, while some animal species can become infected with COVID-19, this pandemic is being driven by human-to-human transmission.
- New information on COVID-19 emerges every day. Researchers and scientists in Canada and around the world are working hard to better understand the virus, and its impacts on people, communities, and animals.

as discussed yesterday, attached is a draft letter that could be sent to mink producers to recommend enhancing their COVID-19 safety plans taking into accound the recent recommendations, as well as WorkSafe requirement.
I would appreciate feedback ASAP, in the next hour if at all possible.
I am not sure if the intend to release the FH outbreak bulletin at 2 still stands or not. But if it still stands, it does not leave us much time to finalize that letter for the industry to receive it at the same time as the bulletin goes public.
As it was discussed that FH would be leading public health communication with the farms, should this letter come from FH while being distributed by the Ministry of Agriculture?
The only mention about a potential surveillance program while logistics are bieng sorted out is: BC CDC in collaboration with Fraser Health intends to facilitate testing for mink farm workers starting as soon as possible. Details of this program are being finalized and information will be shared when available.
Even if we do not set up a full surveillance program, we can facilitate testing with the pre-populated requisitions we have discussed in the past, enabling testing to the extend we judge adequate through regular testing sites.
