• The BCSFVNP was evaluated in 2018, the evaluation results can be accessed online: BCSFVNP evaluation summary report Final 2018.pdf (bcaitc.ca)

- o 98% of teachers and coordinators indicated that they believed their school benefited from the program and that they enjoyed having the program at their school.
- Evaluation results related to agriculture objectives were positive:
  - o 70% of teachers and coordinators indicated that their own awareness of BC[1]grown fruits and vegetables increased because of their school's involvement in the BCSFVNP.
  - Just over half of all students agreed that it is better to eat and buy fruits, vegetables, and milk grown
    in BC. The longer a secondary school was enrolled in the BCSFVNP, the more likely students were to
    agree that it is better to eat and buy fruits and vegetables grown in BC, and to correctly identify
    fruits, vegetables and milk items as BC-grown.
