- · whether there is a sympathetic or compelling need to release materials;
- · whether previous orders of the Commissioner have ruled that similar types of records or information should or should not be subject to disclosure; and
- · when the policy advice exception is claimed, whether the decision to which the advice or recommendations relates has already been made.

#### 7. Farm Safety (C. Jackson/L. Neilson)

- Action item from December 4, 2017 AMC: <u>DAC will create a government agency attendee</u> list and bring to <u>AMC for review</u>
- Protests at salmon farm sites this summer have escalated and companies have raised concerns regarding the safety of their workers.
- Industry has approached DFO to see if the Department could coordinate a discussion with other government agencies to see if there are additional measures that governments can take, within our respective mandates, to help ensure farm worker safety.
- Industry used the example of clear markings of aquaculture tenures as a possible improvement that could be made. This would involve the Province and Transport Canada.
- DFO is willing to coordinate/facilitate a discussion on this but we are looking for support from the Province and ideas on who else we should engage.

#### 8. Integrated Geoduck Management Framework (C. Jackson)

 DFO has been reviewing aquaculture applications for geoduck and evaluating them under the new Integrated Geoduck Management Framework (IGMF) since March, 2017.

Since the release of the IGMF, the Project Review Team (PRT) has received 11 applications

- . 1 application was rejected as it fell outside the requirements of the IGMF
- · 1 application was withdrawn
- 6 applications remain under review at the PRT stage while DFO works with CSSP partners on an approach for ensuring adequate water quality and biotoxin monitoring.
- 3 additional applications are under review by PRT agencies for application deficiencies and/or major concerns.
- . None of the applications at the PRT stage are from First Nations.
- DFO is currently working with CSSP partners on an approach for ensuring adequate water quality and biotoxin monitoring to allow for harvest of Geoduck post licensing.
- The Department has received significant feedback from First Nations that the IGMF does not provide enough flexibility to meet their interests /aspirations related to geoduck (aquaculture and/or access to wild).
- DFO is currently examining options on how First Nations interests can be addressed through a variety of tools such as the IGMF, treaty negations, and other policies.

#### 9. Provincial Review of Discharge and IPM Permitting (MOE)

- Since the November 2017 release of video footage of blood and other effluent coming from the Brown's Bay Packing processing plant near Campbell River, the issue of effluent treatment and disease transmission has received significant public and media attention.
- In response to a request by provincial officials, DFO Science collected samples during the first week of December to test samples for the presence of pathogens, including PRV. All samples tested positive for PRV.
- A Rapid Science Response (RSS) has been completed and provided to the Province of BC.
- In November, the Province of BC began reviewing the current discharge permit for the Brown's Bay plant and referred a draft of an updated permit to DFO (Aquaculture Management Division, Pacific Region) for comment/input. No comments have been provided to date.
- On December 20, 2017, the Province of BC announced a broader review of the regulations and discharge permitting process related to fish plants and the use of pesticides to treat sea lice.
- The Province is responsible for the licensing of fish processing plants. Federally, ECCC is
  responsible for administering section 36 of the Fisheries Act. However, given DFO's and
  expertise related to aquaculture, fish health and minimizing impacts to wild salmon,
  DFO staff are prepared to work with the responsible federal and provincial agencies to
  support and inform this review by the Province, as appropriate (including coordination
  with ECCC).

#### 10. Integrated Pest Management (IPM) (L. Lavigne)

- The BC Salmon Farmers Association organized a workshop on Integrated Pest
  Management on January 10-11. The workshop highlighted the many tools required for
  pest management (area based management, management thresholds, theraputants, best
  management practices). If management thresholds are low, and there few treatment tools
  available, resistance will develop.
- An Integrated Pest Management (IPM) overview document, which describes the status of IPM in BC, was drafted by the Strategic Working Group (a DFO and industry working group) and discussed at our DAC meeting in October.
- The IPM document examines the core elements of an IPM for aquaculture and the treatments available for sea lice in the different salmon farming jurisdictions along with which of those treatments are available in BC.
- Federal and Provincial governments play a critical role in ensuring various treatment
  options are available for the aquaculture industry to use. DFO would like to explore with
  the Province how a longer term strategy for IPM can be developed, similar to IPM
  strategies for terrestrial farming.
- DFO is looking to work with industry and the Province to develop a work plan to outline next steps and identify short, medium and long term actions that can be taken to support IPM in BC.

#### 11. Freshwater Policies (D. Travia/C. Jackson)

- David Travia will discuss process of ongoing policy development on freshwater fish enhancement and access.
- DFO is currently reviewing the ONA application to add sturgeon to their licence. Provincial comments have been requested. The Department will begin reviewing their request to add rainbow trout in the near future.

# 12. Fisheries and Aquaculture Clean Technology Adoption Program (FACTAP) (L. Lavigne)

- The Fisheries and Aquaculture Clean Technology Adoption Program (FACTAP) officially launched on December 18, 2017
- · Shirley Choi is coordinating this program for the Pacific region
- The program will provide funding of up to \$20 million over four years to Canada's
  fisheries, aquaculture and processing companies to implement market-ready clean
  technologies, processes, and practices into their day-to-day operations.
- FACTAP can provide funding of up to 75% of eligible project costs, the applicant must also receive funding from provincial or territorial governments of at least 10% of the project cost in cash or in-kind.

#### 13. External Evaluations (C.Jackson)

- There are currently a number of evaluations going on related to Aquaculture management in B.C.
  - CESD/OAG audit is nearing completion. The final report is expected to be released in Spring 2018
  - A review of the DFO Fish Health Audit and Surveillance program has been completed and will be shared with the Province shortly
  - A review of the options for the provision of diagnostic services has been initiated. The option of conducting diagnostic testing internally within in DFO will be analyzed first.

- Members of the harmonized working group will name an IT representative who can assist with this project and share it with L. Fettes – R. Mayser to follow up
- 2. A discussion on IPM Next Steps to be added next DAC agenda Complete
- 3. David to check with Larry if Oyster/CSSP should be on the next AMC Agenda Complete

#### 3) Federal Update (C. Jackson)

- Corey Jackson has replaced Karen Calla as the Director of Aquaculture Management until the end of March 2018. A hiring process for the position will start shortly.
- Brenda McCorquodale has replaced March Klaver temporarily in the Aquaculture Resource Management Regional Manager position. A process is underway to staff the position on a long term basis.
- Quadrilateral Meeting This international meeting illustrated that the aquaculture industry faces similar challenges across countries.

BCSFA AGM – Discussed infrastructure, feed, sustainability, growth, and innovation.
 DFO's minister gave a speech on the topics of growth and innovation, importance of healthy fish stocks, transparency, and inclusion of indigenous partners.

# 4) Provincial Update (L. Neilson)

- Lesley Fettes is updating the Operational Land Use Policy. The project is currently
  waiting for input from the Minister's Advisory Council, which is expected sometime
  this fall. BC will engage DFO and others.
- The Province is working on filling the vacancy in Lesley's tenuring team. They are hoping to have the position staffed by November 2017.

# 5) Progress on Aquaculture Harmonization (B. McCorquodale)

# a) Harmonized Working Group Debrief

- The last Harmonized Working Group meeting took place on Sept 12, 2017.
- Topics discussed: acceptance of PRT applications, harmonization guide books, Integrated Geoduck Framework implementation, and the agreement to not accept multiple concurrent amendment applications.

- There are 9 new applications waiting for water classification issues to be resolved (6 of the 9 are geoduck).
- Review of Guidance Documents/ Manuals that accompany Front Counter applications

 The Front Counter application forms and guidance documents were recently updated. These materials were reviewed and approved by DAC and will be uploaded to the provincial website.

# 6) Atlantic Escape Plan (C. Jackson)

- DAC discussed activities since the Washington escapes event in August.
- Atlantic salmon sightings have been reported in BC waters; they are showing up individually in various locations as far as Tofino and Campbell River.
- DFO has come up with a 4 part plan to address Atlantic escapes: engage the help of others in reporting Atlantic salmon, swim key rivers, follow-up where required, and provide updates to the public and key groups.

### 7) Farm Safety (C. Jackson)

 Protests at salmon farm sites this summer have escalated and companies have raised concerns regarding the safety of their workers.

**DFO ACTION ITEM:** DFO to discuss at AMC the possibility of setting up a meeting with the Province, WorkSafe BC, Transport Canada, and others to discuss on farm worker safety.

#### 8) Integrated Pest Management (IPM) (C. Jackson / L. Lavigne)

- The IPM document was approved at FAIAP on July 21, 2017.
- DAC discussed the possibility of bringing someone in from MOE (Integrated Pest Management Committee) to collaborate on IPM issues moving forward.

**Action Item:** Keep this item on the agenda. Robyn Kenyon to connect with Myron Roth and MOE to determine next steps.

### 9) Integrated Geoduck Management Framework(IGMF) (C. Jackson)

- DFO is currently working with CSSP partners on an approach for ensuring adequate water quality and biotoxin monitoring to allow for harvest of Geoduck post licensing.
- DFO has also been examining ways that First Nations interests in geoduck could be met, either through the IGMF or through other tools.

**DFO Action Item:** Set up a call with BC and DFO representatives to discuss options for addressing First Nation interest in geoduck in more detail.

#### 10) Freshwater Policies (D. Travia)

- Development is still ongoing for freshwater fish enhancement and access.
- The final round of input is wrapping up; the Province will share the final document with DFO when it's complete.

**DFO Action Item:** Add Freshwater Policies to the next DAC meeting agenda.

### 11) Shellfish Debris Strategy / Beach Clean Up (C. Jackson)

- Approximately 2 metric tonnes of debris was removed from the beaches of Baynes Sound.
- A parallel clean-up effort on Denman Island saw a similar amount of debris removed from beaches. Up to 90% of the material collected will be reused or recycled.

# 12) Fisheries and Aquaculture Clean Technology Adoption Program (FACTAP) (C. Jackson/ L. Lavigne)

- The Fisheries and Aquaculture Clean Technology Adoption Program (FACTAP) is in the final stages of approval.
- The program will require the proponent to contribute a minimum of 10% and the Province to contribute a minimum of 10% per project in cash or in kind. DFO will contribute a maximum of 75%. The remaining 5% can come from other federal, provincial or municipal sources.

**DFO Action Item:** Make FACTAP a standing item on the agenda.

# 13) Minister of Agriculture Advisory Council on Finfish Aquaculture (MAACFA) debrief (D. Travia)

- Last MAACFA meeting was October 4-5, 2017. Next meetings are Nov 2 3, 2017, and Nov 22 - 23, 2017.
- The distinction between risk reduction and harm reduction is being examined.
- MAACFA is aiming to have the draft report by the end of the year.

# 14) Legislative Reform and Strategic Management Committee Meeting (SMC) updates (D. Travia / L. Neilson / C. Jackson)

 DFO will be undertaking a series of engagement sessions this fall with First Nations and stakeholders to discuss what an Aquaculture Act could look like.

- These engagement sessions will also discuss plans for amending the Fishery General Regulations to address overlap with the Health of Animals Regulations.
- DFO is also working on developing an Aboriginal Engagement Strategy for Aquaculture. DFO will be engaging on the development of this strategy with Aboriginal groups in the fall.

- Add Status of First Nation and Industry Communications at Different Levels of Government to the next AMC Agenda.

#### 6. Broughton Archipelago Plan (D. Travia)

- · Province to provide an update on the January Broughton meeting
- Reconciliation is a central component of the Government of Canada's commitment to developing a renewed, nation-to-nation relationship with Indigenous Peoples, and several processes have been established to support reconciliation efforts
- DFO will be following the averall direction and out through these processes to work towards
  reaching agreements with First Nations in BC around fisheries and aquaculture management
  and governance issues.
- Our Minister will not be engaging in this government to government process directly. There
  is no direct regulatory decision for the Department related to these sites—DFO has issued
  federal licences for the continued operation of these sites through June 30, 2022.
- Andy Thomson, Regional Director Fisheries Management, will participate in the process to provide input and support, as appropriate, as well as information regarding DFO management of aquaculture in BC.
- We do have some questions regarding the proposed government-to-government process:
  - does the Province have a sense of what range of options might be considered when entering into this government to government process?
  - would they consider setting the renures expire without renewal? This would have a significant impact on the industry and employment in small, coastal communities (including first Malions).

o what about the broader implications for other sectors/industries operating in territory claimed by First Nations?

#### 7. Farm Safety (C. Jackson/L. Neilson)

- Action item from December 4, 2017 AMC: <u>DAC will create a government agency attendee</u> list and bring to AMC for review
- Protests at salmon farm sites this summer have escalated and companies have raised concerns regarding the safety of their workers.
- Industry has approached DFO to see if the Department could coordinate a discussion with other government agencies to see if there are additional measures that governments can take, within our respective mandates, to help ensure farm worker safety.
- Industry used the example of clear markings of aquaculture tenures as a possible improvement that could be made. This would involve the Province and Transport Canada.
- DFO is willing to coordinate/facilitate a discussion on this but we are looking for support from the Province and ideas on who else we should engage.

#### 8. Integrated Geoduck Management Framework (C. Jackson)

- DFO has been reviewing aquaculture applications for geoduck and evaluating them under the new Integrated Geoduck Management Framework (IGMF) since March, 2017.
- Since the release of the IGMF, the Project Review Team (PRT) has received 11 applications
  - o 1 application was rejected as it fell outside the requirements of the IGMF
  - o 1 application was withdrawn
  - 5 applications remain under review at the PRT stage while DFO works with CSSP partners on an approach for ensuring adequate water quality and biotoxin monitoring.
  - 2 applications for new geoduck facilities have been accepted by the PRT and are currently in statussing with BC.
  - 1 applications for an amended geoduck facility has been accepted by the PRT and is currently in statussing with BC.
  - 1 application has been received by Klahoose FN but overlaps with another application already at PRT, so is being held at PRT while a solution to overlap is being considered.
  - None of the applications at the PRT stage are from First Nations for red areas.
- DFO is currently working with CSSP partners on an approach for ensuring adequate water quality and biotoxin monitoring to allow for harvest of Geoduck post licensing.
- The Department has received significant feedback from First Nations that the IGMF does
  not provide enough flexibility to meet their interests /aspirations related to geoduck
  (aquaculture and/or access to wild).

 DFO is currently examining options on how First Nations interests can be addressed through a variety of tools such as the IGMF, treaty negations, and other policies.

#### 9. Provincial Review of Discharge and IPM Permitting (MOE)

- Effluent Discharge from BC Processing Plants
- Since the November 2017 release of video footage of blood and other effluent coming from the Brown's Bay Packing processing plant near Campbell River, the issue of effluent treatment and disease transmission has received significant public and media attention.
- In response to a request by provincial officials, DFO Science collected samples during the first week of December to test samples for the presence of pathogens, including PRV. All samples tested positive for PRV.
- A Rapid Science Response (RSS) has been completed and provided to the Province of BC.
- In November, the Province of BC began reviewing the current discharge permit for the Brown's Bay plant and referred a draft of an updated permit to DFO (Aquaculture Management Division, Pacific Region) for comment/input. No comments have been provided to date.
- On December 20, 2017, the Province of BC announced a broader review of the regulations and discharge permitting process related to fish plants and the use of pesticides to treat sea lice.
- The Province is responsible for the licensing of fish processing plants. Federally, ECCC is
  responsible for administering section 36 of the Fisheries Act. However, given DFO's and
  expertise related to aquaculture, fish health and minimizing impacts to wild salmon,
  DFO staff are prepared to work with the responsible federal and provincial agencies to
  support and inform this review by the Province, as appropriate (including coordination
  with ECCC).

#### 10. Integrated Pest Management (IPM) (L. Lavigne)

- The BC Salmon Farmers Association organized a workshop on Integrated Pest
  Management on January 10-11. The workshop highlighted the many tools required for
  pest management (area based management, management thresholds, theraputants, best
  management practices). If management thresholds are low, and there few treatment tools
  available, resistance will develop.
- An Integrated Pest Management (IPM) overview document, which describes the status of IPM in BC, was drafted by the Strategic Working Group (a DFO and industry working group) and discussed at our DAC meeting in October.
- The IPM document examines the core elements of an IPM for aquaculture and the treatments available for sea lice in the different salmon farming jurisdictions along with which of those treatments are available in BC.
- Federal and Provincial governments play a critical role in ensuring various treatment options are available for the aquaculture industry to use. DFO would like to explore with

- the Province how a longer term strategy for IPM can be developed, similar to IPM strategies for terrestrial farming.
- DFO is looking to work with industry and the Province to develop a work plan to outline next steps and identify short, medium and long term actions that can be taken to support IPM in BC.

#### 11. Freshwater Policies (D. Travia/C. Jackson)

- David Travia will discuss process of ongoing policy development on freshwater fish enhancement and access.
- Work on a provincial paper outlining policies for freshwater enhancement, aquaculture and commercial access is ongoing
- DFO is currently reviewing the ONA application to add sturgeon to their licence. Provincial comments have been requested. The Department will begin reviewing their request to add rainbow trout in the near future.

#### 12. Fisheries and Aquaculture Clean Technology Adoption Program (FACTAP) (L. Lavigne)

- The Fisheries and Aquaculture Clean Technology Adoption Program (FACTAP) officially launched on December 18, 2017
- · Shirley Choi is coordinating this program for the Pacific region
- The program will provide funding of up to \$20 million over four years to Canada's
  fisheries, aquaculture and processing companies to implement market-ready clean
  technologies, processes, and practices into their day-to-day operations.
- FACTAP can provide funding of up to 75% of eligible project costs, the applicant must also receive funding from provincial or territorial governments of at least 10% of the project cost in cash or in-kind.

### 13. External Evaluations (C.Jackson)

- There are currently a number of evaluations going on related to Aquaculture management in B.C.
  - CESD/OAG audit is nearing completion. The final report is expected to be released in Spring 2018
  - ii. A review of the DFO Fish Health Audit and Surveillance program has been completed and will be shared with the Province shortly
  - A review of the options for the provision of diagnostic services has been initiated. The option of conducting diagnostic testing internally within in DFO will be analyzed first.

#### **Exercise of Discretion:**

The Freedom of Information and Protection of Privacy Act (FOIPPA) contains both mandatory and discretionary exceptions to disclosure. Sections 13 to 20 are the discretionary exceptions. Where Information Access Operations (IAO) has advised the head that a discretionary exception may apply, it is important that the head consider the possibility of releasing the information despite the fact that an exception may apply.

Factors relevant to the exercise of discretion include:

- the general purposes of the legislation: public bodies should make information available to the public; individuals should have access to personal information about themselves;
- the wording of the discretionary exception and the interests which the section attempts to balance;
- whether the individual's request could be satisfied by severing the record and by providing the applicant
- with as much information as is reasonably practicable;

- the nature of the record and the extent to which the document is significant and/or sensitive to the public body;
- whether the disclosure of the information will increase public confidence in the operation of the public body;
- the age of the record;
- whether there is a sympathetic or compelling need to release materials;
- whether previous orders of the Commissioner have ruled that similar types of records or information should or should not be subject to disclosure; and
- when the policy advice exception is claimed, whether the decision to which the advice or recommendations relates has already been made.
