It is sort of an absence from the Act that defines her role - i.e. as she explicitly has no role in law (i.e. no powers in the ALCA), she therefore should not be in the process by policy. Put another way, as the legislature has given decision making to the ALC, involving herself would be contrary to the will of the legislature (so to speak), and would be considered fettering the discretion of the ALC.

Yes, this situation has definitely raised that question and we have been discussing with the LUPs and RAs. The tricky part there is that we rely entirely on the information provided in the application by the applicant so for FNs, for example, we don't always know who the applicant is nor if there are specific FN interests involved. The other thing to consider is that even if we decide to do that (and it is entirely doable, acknowledging the potential limitations), it won't really impact anything unless we shift the decision making framework at the ALC end i.e. we can indicate FN considerations in our analysis but it is currently information that outside the scope of the commission decision making framework.

In the last year we have standardized and streamlined the referral response process, so it would be fairly straightforward to add other government interests, keeping staff capacity limitations in mind. We respond to 15-20 referrals per month so adding components beyond the expertise of the agriculture staff will increase the work required as most topics would likely require additional consultation. Not a show stopper, but a consideration.
