Issue: Quarterly reporting on First Nations land transfers and policy issues will provide a common baseline and understanding and can be used to brief the Minister's Office.

First Nations Considerations:

The current mandate letter states that all ministries follow the foundational principle of lasting and meaningful reconciliation, and that reconciliation is an ongoing process and shared responsibility. True reconciliation will take time and ongoing commitment to work with Indigenous Peoples as they move toward self-determination. Every ministry must remain focused on creating opportunities for Indigenous Peoples to be full partners in our economy and providing a clear and sustainable path for everyone to work toward lasting reconciliation.

Land selection and considerations of Indigenous uses of that land are a component of reconciliation. Economic interests of FNs can intersect primary production, fish and seafood, and food processing. AFF has advanced work with Fish and Seafood and the Indigenous Agriculture Programs area in Business Development Division. Through the LAT process and joint policy work, AFF can also provide advisory services to FNs who wish to pursue agriculture, food or fish and seafood related economic opportunities and reflect that commitment within resulting treaties or agreements.

Appendix C: Tsartlip First Nation Purchase in Fee Simple Woodwynn Farm

Tsartlip First Nation

Tsartlip First Nation is located in Brentwood Bay, Saanich Peninsula in the Vancouver Island region. The population is 1,009 members as of December 2020. Tsartlip First Nation is negotiating with the Province outside the BC treaty process.

On December 16, 2020, the BC government entered into a historic agreement with the Tsartlip First Nation. Tsartlip First Nation had purchased the former Woodwynn Farm, a 78-hectare property, from BC Housing through a \$7.7 million grant from the province.

The land is also called Máwueć and had been once used by the Tsartlip First Nation to gather medicines, hunt, fish, farm, and conduct ceremonial practices.

The lands gained (193 acres) are adjacent to the Tsartlip First Nation's sole reserve (196 acres) and nearly doubles the size of its territory.

The Tsartlip First Nation now owns the land, which is part of the ALR, as private property. BC Housing had been leasing the property to a local farmer, who is actively farming hay, grain, and produce. Tsartlip First Nation has extended the lease through to September 2021. Between now and then, the Tsartlip First Nation intends to engage with members and the District of Central Saanich on how best to use the land.

With over 1,000 members, Tsartlip First Nation is the fastest growing First Nation in southern Vancouver Island. They state that they have run out of space to address housing, recreational, and cultural needs and that they are excited to expand their land base.

Potential future issue:

Given their stated concerns over lack of land for housing, could the Nation use the land for residential use? This is incompatible with ALR unless there is farming.

- The 78 hectare former Woodwynn Farm (the Property) in Central Saanich is wholly within the Agricultural Land Reserve (ALR) and was used as a mixed-use farm for approximately 150 years; from the mid-1800s to the early 2000s.
- In July 2018, the B.C. provincial government purchased the Property and on December 16, 2020, the Property was transferred to the Tsartlip First Nation (TFN) whose Federal Indian Reserve (IR) land borders the Property.
- TFN has over 1,000 members and they have publicly stated that they have run out of space on their current reserve to address the housing, recreational and cultural needs of their growing population.
