RE: Operation & Transition Plan for 2015

The Nisga'a Nations purchase of Guide Outfitter Certificate #601036 will require a transition plan to allow for a smooth transition of ownership of the Guide Outfitting Area/Certificate to the Nisga'a Nation. To support a seamless transition, the below operating and transition plan for the 2015 season will be implemented.

Collier Azak, Chief Executive Officer will be named as the certificate holder in trust for the Nisga'a Nation.

Bob Milligan will hold the Guide Outfitter License until a person is trained for the position. A training plan has been developed to train Nisga'a individuals as assistant guides for 2015. A longer-term operational and training plan is being developed for Nisga'a to be implemented by Nisga'a to see Nisga'a individuals move into the position(s) of guides and fully trained assistant guides.

The seasons will be run no different as the previous years, to utilize the quota and Guidelines that are authorized by the Government of BC.

Depending upon seasonal conditions, following is a projected plan for the spring and fall of 2015:

Spring 2015 season will roughly run from May 1st to June 15th for Black and Grizzly Bear. In the early part of May hunts will take place in MU 611 (Ectall River). We will take 4-8 hunters per week on 5-day Black Bear hunts. The majority of these will be done in MU 614, 615 & 616.

Hunts will be conducted using roads, ocean & river access mainly in the North Area of the Certificate, specifically north of the Skeena River. Three Grizzly hunts will take place in the fall: one in MU611 (Lakelfe River), one in MU615 and MU616 (Bowser Lake).

Fall 2015 season will start on the 15th of August for Goat and will run until Feb 28th. Hunts are 9 days long consisting of Backpacking and Flying.

Fly-in hunts are done in the Southern and Northern areas. The general boundary will be Fosh Lake and Horse Shoe Lake (MU 611) in the southern area.

The general boundary of the northern area will be MU 614 (fly-in hunts), Bonanza Lake, Out Ram Lake and Kinscuch Lake (MU614). Given the remoteness of these lakes, there will no to minimum impact to local residents.

After November 15th the Goat quota will be used in the Management Units provided and authorized by the Government of BC.

From September 1st - November 15th there will be Grizzly hunts done that are 9 days long in the Management Units authorized by the Government of BC. Quota and guidelines will be followed as authorized by the Government of BC. There is no intention to hunt in the Kwall area in 2015.




