**ISSUE:** Treaty First Nations want to share their perspectives on BC treaty process

#### SUMMARY:

 The five Maa-nulth First Nations, Tsawwassen First Nation and Tla'amin Nation that signed an April 16, 2015 letter to the Minister (Treaty First Nations) have expressed concern over BC's future participation in the treaty process.

The Treaty First Nations will be looking for confirmation of BC's commitment to the treaty
process and an opportunity to share their perspectives and experiences to support
improvement of the process.

#### BACKGROUND:

Since 1993 BC Treaty Commission (BCTC) has allocated about \$627 million in negotiation support funding to First Nations. BC has contributed about \$53.6 million in non-repayable grants. BC also contributes approximately \$1 million per year to BCTC operating costs. In March 2015, Premier Clark announced that the Province would not support the appointment of a new chief commissioner to the BCTC. This announcement raised concerns among the BCTC, first nations and others about the future of the treaty process in BC. During subsequent debate in the legislature, the Minister clarified that after 22 years it was time for the Province to examine, with the Principals, how to improve the treaty process.


On March 30, 2015, Minister Rustad sent a letter (attached) to the treaty First Nations advising of the Province's decision not to support the chief commissioner's appointment, recognizing the benefits of the treaties and reaffirming its commitment to a government-to-government relationship. The Minister also stated the Province's intention to update the First Nations on any work the Province does with the Principals to improve the treaty process. The treaty First Nations, represented by the Maa-nulth and Tsawwassen First Nations and Tla'amin Nation (the Treaty First Nations) responded with a letter to Minister Rustad and Premier Clark, dated April 16, 2015. The Treaty First Nations requested a meeting to share their perspectives on the treaty process and to hear the Province's views.

#### DISCUSSION:

On August 19, 2015 MARR staff confirmed with the Treaty First Nations via conference call that the purpose and scope of the meeting should be limited to the requests in the April 16 letter. A proposed agenda (attached) has subsequently been shared with the Treaty First Nations for comment. Based on that conversation, the Treaty First Nations will likely expect the following key matters be addressed at the meeting:

#### 1. Assurance that BC remains committed to the treaty process

They have expressed concern that the Province's decision not to support the appointment of a new chief commissioner may signify the Province's desire to abandon the treaty process and consequently reduce the focus on and resources allocated to supporting the long term sustainability of existing Treaties. Recent A-I-P announcements with Kitsumkalum and Kitselas First Nations and Wuikinxv



Nation demonstrate that the negotiation and successful conclusion of treaty agreements continues to be a priority for the Province. The Minister should also be prepared to reiterate the Province's ongoing recognition of the value and importance of treaties for First Nations and all British Columbians.

The Treaty First Nations will also expect an update on the Province's commitment to improving the existing process. The Province is actively working with the First Nations' Summit and the federal government on ways to improve expedite and reduce the costs of the treaty process. The Province also remains committed to working with the Common Table on refining treaty mandates, and improving final agreements.
