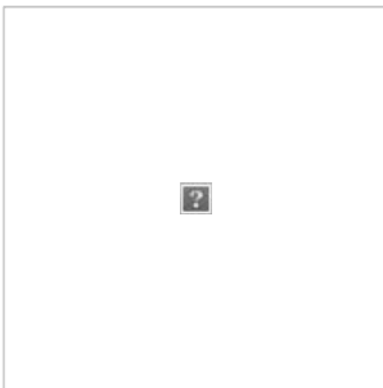

For a little background on mining leases, a mining lease is a form of mineral title that is required to engage in mine production. The decision to issue a mining lease is a statutory decision made by the Chief Gold Commissioner under Section 42(5) of the *Mineral Tenure Act*. Mining leases are issued according to a survey plan and for a pre-defined term of no more than 30 years, and on conditions the Chief Gold Commissioner considers necessary. A mining lease is maintained by payment of an annual rent of \$20 per hectare. There are no exploration work requirements to maintain a lease in good standing as exist for a mineral claim. The presumption is that the lessee will be engaged in mine production and/or mine reclamation. and incurring royalty payments for mine production under the *Mineral Tax Act*.

A lessee is entitled to a renewal of a mining lease for one or more further terms not exceeding 30 years each. A decision to renew a mining lease is made by the Chief Gold Commissioner, on conditions the Chief Gold Commissioner considers necessary.

I have attached copies of the two mining lease indentures^{s.16} as well as current title searches for each that provides current title information. Please note that the shape^{s.16} as currently displayed is not yet correct, this mining lease adjoins but does not overlap^{s.16} nor does it overlap the Park.

The permit for the mining leases will provide information related to approved activities. Permits are handled regionally and the person you will want to contact is Mr. Jim Dunkley, Inspector of Mines, who should be able to pull out a copy of the permit and any other relevant documents related to activities for you.
