Dear Chief Skii km Lax Ha:

I am writing to inform you that the Province has updated its Consultative Areas Database (CAD) to include the Tsetsaut Skii km Lax Ha's full asserted territory. The Province would like to take this opportunity to reiterate that the CAD is a repository for data that geographically depicts where a First Nation has established or is asserting treaty or Aboriginal rights and title, which informs government staff regarding where the duty to consult may be triggered. Inclusion or treatment of an asserted territory in CAD does not amount to recognition or determination of Aboriginal rights and title. CAD is one tool used by staff to identify which First Nation to consult.

In determining the appropriate approach to consultation, staff will be informed by assessments of the *prima facie* strength of any claims (SOC) of Aboriginal rights and title and seriousness of potential impacts of the proposed activity/project on those claimed or established rights. Such assessments may be revised during the consultation process as new information becomes available or if case law changes.

The Province's inclusion of any particular spatial boundary into CAD does not imply that the Province will share resource revenues or enter into agreements with the First Nation making the territorial assertion. The Province may consider a range of factors in determining when and how much revenues to share with First Nations, including strength of claims, nature of the entity asserting the claim, degree of impact of an activity, distance to project, and population of First Nation community.



Dear Darlene Simpson:

On behalf of the Honourable Michael de Jong, Minister of Aboriginal Relations and Reconciliation, and the other addressees, I am pleased to respond to your letter of April 1, 2008, regarding your request to enter the new Skii km Lax Ha asserted traditional territory boundary map into the provincial Consultative Area Database (CAD). I have also been asked to respond for our minister to your letter of May 7, 2008, on the same subject.

This letter is to acknowledge receipt of the new Skii km Lax Ha asserted traditional territory boundary map and to inform you that the Province will incorporate the new map into the CAD.

The CAD, as an internal database, depicts the provincial government's interpretation of geographic areas where First Nations have requested they be consulted on Crown activities involving land and resources. It is one of the resources available to provincial government employees to help them determine the boundaries of First Nations' traditional territories. The CAD is not accessible to outside agencies, and I recommend that you continue to communicate with the local agencies in your area.

Dear Ms. and Mr. Simpson:

The purpose of this letter is to propose an approach for provincial agencies to consult with the *Wilp* Skii km Lax Ha for proposed projects and activities and provincial government decisions that may potentially affect areas historically used by Skii km Lax Ha at the time of contact and at 1846 when the Crown asserted sovereignty.

First I would like to summarize a number of key factors which have been considered in the development of the proposed approach. These include:

- The Province takes its duty to consult seriously.
- Wilp Skii Km Lax Ha was previously a member of, and represented by the Gitxsan Chiefs Office.
- On May 20, 2003 a request was made by you, on behalf of the Skii km Lax Ha, for the province to consult with Skii km Lax Ha separately from the Gitxsan Hereditary Chiefs and this request included the assertion of a territory much larger than the house boundary depicted by the Gitxsan Hereditary Chiefs.
- Currently the Gitxsan Chiefs Office does not represent the wilp Skii Km Lax Ha.
- Over the past approximately six years the Province has engaged with you to develop a better understanding of the claims you assert including where and how wilp Skii km Lax Ha are to be consulted.

The research and information exchange has revealed that there are differing views and conclusions that can be drawn from the ethno historic records. The Provinces views are:

In conclusion, and for the purpose of finding a way to meaningfully consult with wilp Skii Km Lax Ha, it is proposed that the Province will consult directly with you on decisions and activities that may notentially affect aboriginal interests within the Awiiiii territory. s.16

To assist our CAD review process we request that TSKLH:

- Provide Brad Cope the primary source materials you reference.
- Provide a spatial file to myself depicting your asserted territory. While I do have previous spatial files I want to be certain we are using the most current version.
- Advise the Province whether TSKLH has discussed this territorial assertion with neighboring First Nations.
- Confirm if you would like your asserted territory to be publicly available (for example at the request of proponents).

Our next steps in the review process include:

- Reviewing the primary source materials and concerns raised at the December 29th meeting.
- Sharing our assessment and perspective with Tsetsaut Skii km Lax Ha on this new material including implications for previous Provincial reports and assessments.
- This updated information will inform our CAD review and update process including sharing information with Provincial staff.

I will be your primary point of contact through this process, and will continue to work with our provincial colleagues to ensure awareness and consistency within Provincial agencies.

Dear Darlene Simpson:

On behalf of the Honourable Michael de Jong, Minister of Aboriginal Relations and Reconciliation, and the other addressees, I am pleased to respond to your letter of April 1, 2008, regarding your request to enter the new Skii km Lax Ha asserted traditional territory boundary map into the provincial Consultative Area Database (CAD). I have also been asked to respond for our minister to your letter of May 7, 2008, on the same subject.

This letter is to acknowledge receipt of the new Skii km Lax Ha asserted traditional territory boundary map and to inform you that the Province will incorporate the new map into the CAD.

The CAD, as an internal database, depicts the provincial government's interpretation of geographic areas where First Nations have requested they be consulted on Crown activities involving land and resources. It is one of the resources available to provincial government employees to help them determine the boundaries of First Nations' traditional territories. The CAD is not accessible to outside agencies, and I recommend that you continue to communicate with the local agencies in your area.

Each statutory decision-maker will continue to be responsible for determining the appropriate level of consultation with the Skii km Lax Ha according to the circumstances of the decision in question.

Bobby Love, Strategic Issues Forester at the Integrated Land Management Bureau, will inform you when the CAD has been updated to include the Skii km Lax Ha asserted traditional boundary territory.
