Minister for Children and Families dated Sept. 26, 2017 Dear Minister Katrine Conroy Nick Simons said I should tell you our story. s.22 and I have been foster parenting on the Sunshine Coast s.22 s.22 s.22 we were asked to care for twc^{s.22} children, a girl (\$.22) and a boy s.22 The children s.22 Twice we were asked if we would consider adopting them -and we said yes without hesitation both times. Shortly after the Ministry's second request, the children's natural mother got a lawyer s.22 s.22 We had supported and coordinated visits with the children's mother throughout the years and respected the Ministry's decision to return them to her-who they referred to as "mom". But the Ministry's transition plan -especially for the boy who knew us as his only caregivers -was so sad and insensitive, and entirely unprofessional.

When the time came, the boy, s.22 stated quite clearly that he did not want to live with her (he said "not yet") but that he would visit as long as he didn't have to stay overnights.

The Ministry $^{s.22}$ family support worker arranged an overnight visit with his mother ir $^{s.22}$, which of course did not go well:

We have always been on board with the transition but we knew better than the Ministry that it would take time for this child to bond with his mother.

Despite repeated resistance and mostly unsuccessful visits, the Ministry set the transition date of we were told we had 10 minutes to bring the child out of the house to put into his mother's car. Incredibly, the RCMP accompanied the social workers for reasons we were never told.

We were told by the mother that we could text, email, phone the boy anytime. We were also given an official Ministry letter indicating the date and times that we could call him. We adhered to all directions. The Team Leader sent a note thanking us for making the transition go smoothly and indicating that they were looking forward to continuing to work together in the future.

It is now September. I have written letters asking for an explanation, with no response.

We are hoping you can give us some clarity to this issue. We are so disappointed with 2 issues...one is the fact that we were "model" foster parents for the Ministry for Children and Families s.22

Also...we raised this child be nown unfortunated that he not have any contact s.22

It doesn't seem right at all.

Subject: Foster children-solutions that save them!

Hello Minister Katrine Conroy, Welcome to your most important role.

s.22

Please consider the following issues that I have viewed as critical issues after fostering ^{s.2} children. In my experience, if these issues are addressed positively then children will manage much better.

- 1. Make sure foster parents are respected as an active and important members of the child's network or team. Make other workers accountable to foster parents just as they are to bio families, their supervisors and the child's team. We are not at the bottom of the totem pole. Take our concerns about child welfare and about possible protection risks as seriously as the bio family and community members. Give us extended healthcare and a fair income that we can claim for benefits. This level of respect and inclusion will generate a greater number of foster parents and less attrition. We are in desperate need of foster parents!
- 2. If you want to reduce the number of children in care, please begin by making children adoption-ready as soon as it's determined to be in their best interest. This requires man and woman power and funding for additional Social Workers. Our system has been hurting children and in crisis ever since the Liberals slashed numerous workers back in 2000 when I began fostering and even before that. s.22

 when we were under NDP and then when

the Liberals got in, everything froze. s.22

- 3. Don't avoid bringing children into care because they are not beaten or bleeding nor at immediate risk. Wounds of the mind and heart are large injuries too. And don't avoid protecting children who suffer borderline abuse or neglect. S. 22 I learned that that's what others see on the surface and family crisis lies just below the surface.
- 4. Prevent children coming into care by supporting families at no cost to them. Free therapy and parenting classes as soon as people decide to start a family. Then, a minimum of 1 year of therapy and parenting classes and other resources is provided if a child has been removed or a family is under supervision. I would like to think that children are being 'protected' but not necessarily 'removed'. If these programs are there from the start, you will find fewer children in care.
- 5. Please don't count on extended family or grandparents to do the work of parents unless you provide this help. Many other family members are also not safe. Intergenerational patterns exist. Please, please, don't deny that truth. s.22 I have seen this. These patterns of abuse or neglect or witnessing thereof only change after long-term treatment of the issues. By long-term I mean a minimum of 1 year of weekly therapy combined with parenting groups or classes. That's when I see progress that can be sustained.

Thank-you for your time.

P.S. I would be grateful if you can read my letter at the next fostering event you attend or the foster parent appreciation lunch.

Now you have more knowledge about our experiences as foster parents ^{s.22} needs fixing. My colleagues usually share these thoughts, at least in part.

I am a foster caregiver in the Cowichan Valley. In this capacity, I work with both MCFD and the delegated agency Lalumu tul Smuneem. I am aware of many issues in the delegated aboriginal agencies, some of which are directly impacting a child in my care, and in discussions with other caregivers, I am realizing that the issue is much broader. Many caregivers are witnessing first hand trauma with the children in their care due to policies and decisions being made. I am sure I speak for many in that we are frustrated with a lack of accountability, and oversight which is allowing decisions which are anything but "best practise" and are certainly not in the best interest of the children in our care. I realize this is a political hot potato, but I am sure that if there was an awareness of some of the actions being taken, there would be less damage being done.

I would appreciate a phone call by anyone who would be best able to hear and effect change.

Hello Katrine,

Thank you for your letter to all Foster Parents and we note that you mentioned that you are open to feedback.

We have been through a lot 's.22 MCFD.

due to our previous concurrent fostering contract with

MCFD.

We are happy we have finally got a positive outcome, but it hasn't been without untold stress and close to s.22 in legal bills.

We have been victims of inefficient systems and unfair processes. We would like work collaboratively with the Ministry, in order to ensure that firstly, no other family has to endure what we have, and also to help contribute to meaningful and positive change. Our son was repeatedly overlooked by those who really should know better, and we have seen first hand the affects of all this on another child.

Our input and suggestions for change are on the following subjects:

- **Concurrent planning**: when it's appropriate; family training, information and selection process; consideration of adopted siblings in a concurrent planning home
- Openness: MCFD staff following through to encourage openness between foster, adoptive and birth families
- this was not done
- Transitions: NO child should be moved without a transition unless there is a child protection concern
- Administrative Reviews: "nothing about us without us" An Administrative File Review was absolutely littered with inaccuracies and omissions. It was extensively about us without consulting us at all
- Foster parent inclusion: who knows the child better than the people bringing them up 24/7? Foster parents should be consulted during all stages of a child's time in care, including garnering feedback on how they are after birth family visits and so on. This did not happen MCFD social workers saw the child in question for a combined total of less than one hour through the 18 months she was in our care. They simply did not follow up they never asked about her care, needs, etc.
- **Social Worker conflict of interests:** A child should not share the same social worker as the birth parent. The birth parent can talk, convince and manipulate. A very young child does not have a voice. This is a huge imbalance of power.
- **Child Court Teams** this is the model used in the UK, and other parts of Canada and the US. A team is assigned to a child from the get-go including a judge. Regular meetings include their social workers, counsellors, judge, bio and foster families. BC needs this team child-centred approach.

There is no doubt there is need for real change, and we sincerely hope that the new government takes the opportunity to rid MCFD of the terrible reputation it has been gaining for the last several years.

We look forward to hearing from you, and really hope we can meet with you to provide our input from a first-hand perspective.
