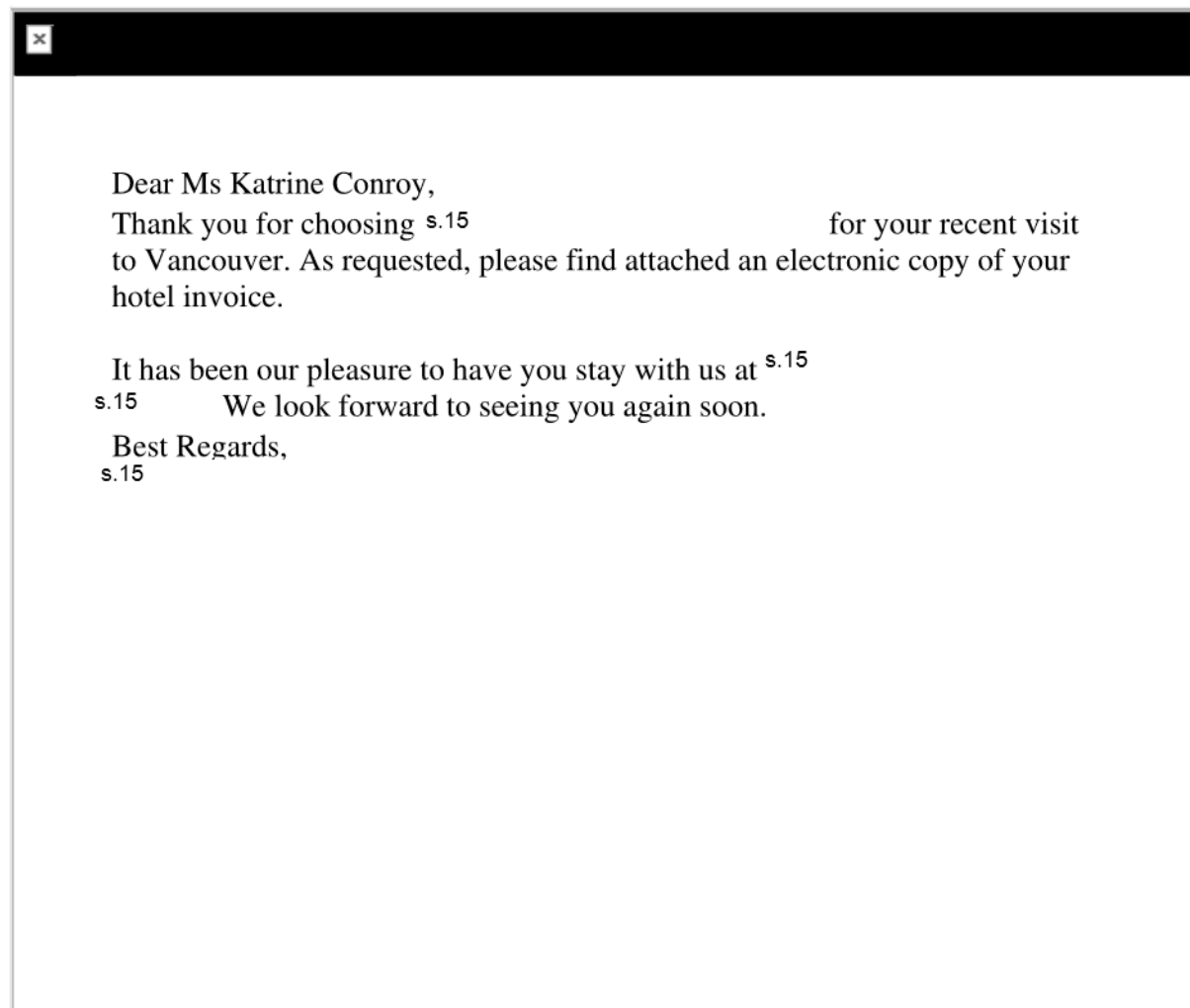

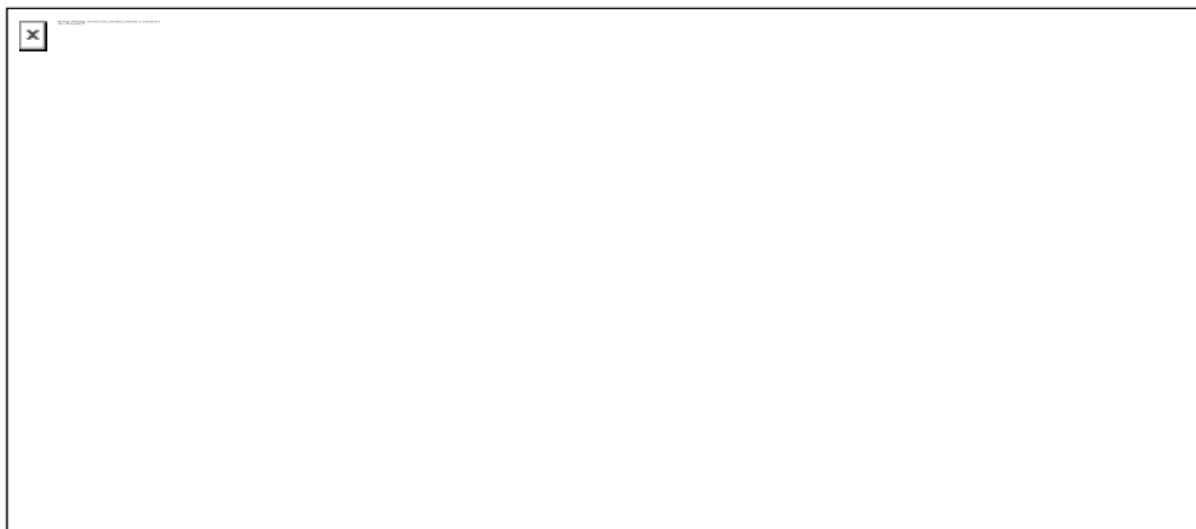

You had asked me for information about the increase in the AYA caseload last week at lock up. I am sorry it took me so long. I just did a quick query of our database. We announced changes to the tuition waiver at the end of the summer – you can see the impact. Take up on tuition waiver (as opposed to AYA) went from 189 to 229. That's probably where the 25% figure came from.

Two hundred more young people taking advantage of AYA over the course of one year is terrific! We have been making a concerted effort since 2015, so that table is below too – and it really shows change. From 517 in Jan 2015 to 924 today! I have shown it in graph form as well.

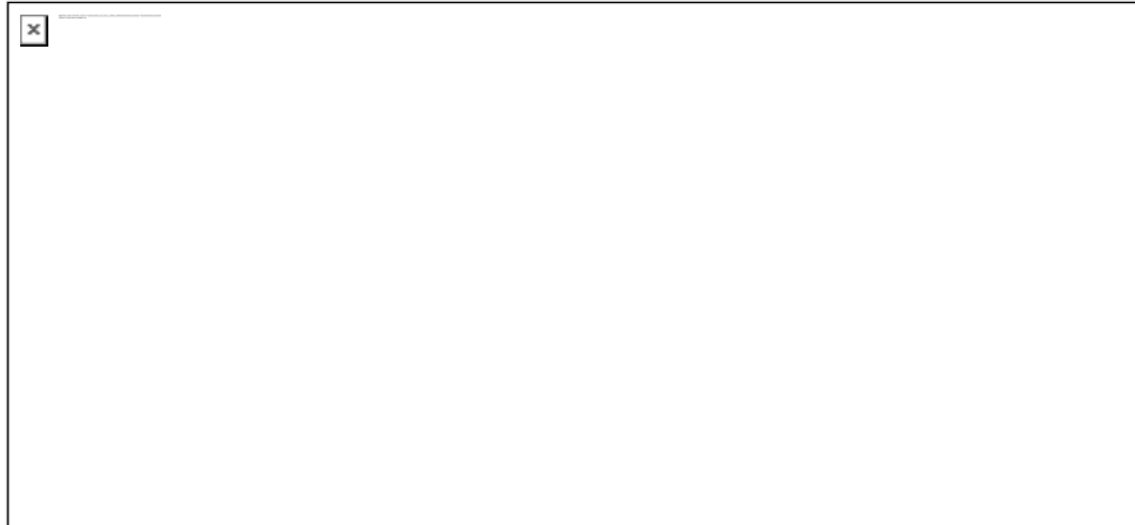
