Brett Trimble suggested I email this to you. Minister Conroy has her EA Edena Brown joining us on MO staff, but located in the constituency (Castlegar) and Edena had several questions that I am hoping your office can assist me with answering.

1. **Laptop** – we can order this but Edena wonders if it will it be set up by Govt IT and mailed to her? Should she come to Victoria to facilitate this? It would be best if her profile could be logged in once on BCGOV network so perhaps you or someone in office can do this before shipping out to her if she is not coming this way anytime soon.
2. **Cell Phone** - we can order one for her but she again wonders if it will it be set up and mailed to her? Same as above, this can be setup and tested before and shipped to her with the laptop.
3. **Printer** – Edena asks if she will be allowed to use the constit office printer scanner? It is a piece of equipment owned by the Legislature accessed by our Legislature email so possibly should not be used and unclear if government emails will be able to access it. So should we purchase a smaller printer/scanner for her from the MO to put in the constit office? Looking into this one, I would hope they could share the printer, but as you say there may be issues with FOI and etc.
4. **Internet connection?** Edena wonders about whether she would getting a government internet connection? Or should we be asking the Legislature IT if she can be hard wired onto their system or using the Leg wifi? Either hardwired into LEG or WiFi LEG and then use a VPN connection to securely connect to government servers, shared drives etc. this is standard already for all mobile clients.

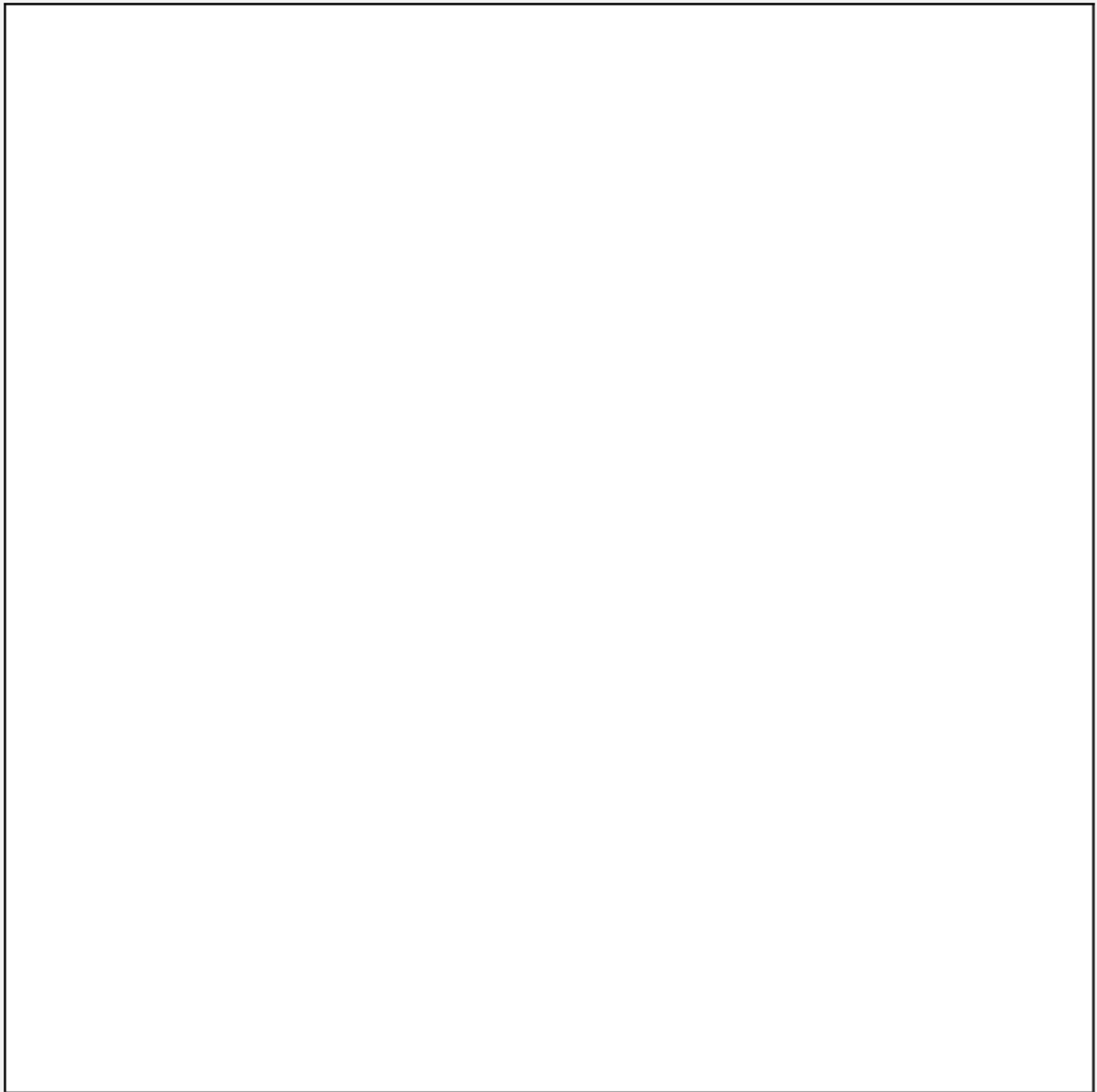

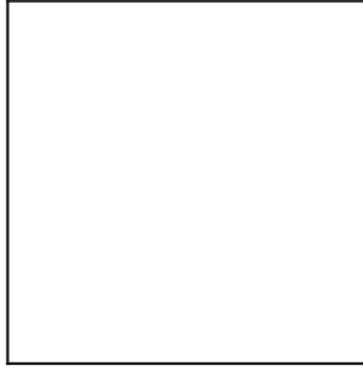
