We are getting close to the conclusion of the hiring process for Minister's offices, including Executive Assistants and Administrative Coordinators. Thank you again for your patience as we build the political staff team to support our new government.
The Premier's office will be reaching out to Ministers in the next couple of days with information about staff who are coming on board.
Once this happens, we will be able to fully share information with you on the remainder of the staff complement in your office.
Many of your new colleagues will be starting next Monday, September 11, a smaller group is coming on board this Friday.
In the meantime, I know many of you have questions about how the new staff will be brought on board and the logistics of getting them settled.

Please see below. Information will be sent to all new staff coming on board this week as well as on boarding packages, and information on travel and relocation expenses.

More details on orientation and regular meetings for Ministerial staff will be coming shortly as well.

Here are answers to top of mind questions we are getting so far, please let me know if there are others:

How will new Ministerial Assistants get set up with email, phone, etc.?

Once we have a start date confirmed for new staff, please work with your office administrative team to prepare for their arrival, including making sure they have a work station, a computer, a phone and a mobile device.

The administrative team will have to walk them through setting up their IDIR. Plus getting cards ordered and booking travel and accommodation and processing claims. If your office team is unsure of anything, please contact the Deputy Minister's office for support.

How will they get access to the Legislature?

Please make sure your office team has informed Legislative security of their arrival so they will know they are coming and can arrange to get their security pass right away.

What if our office doesn't have space for them?

Some offices currently don't have space for separate offices for incoming Ministerial staff. Until a longer term solution is found they will need a work station in the office, even if this means sharing an office with the current Ministerial staff or occupying a desk in the reception area. Layne Clark is working to address office space issues, please contact her directly if you have a problem at layne.clark@gov.bc.ca

Where will executive assistants be working from and how will they get set up?

The logistics of how they will be supported are being worked out and we should be able to let you know within the next couple of days.

Do I get reimbursed for travel?

We appreciate that some people moving to Victoria may not have permanent accommodation in place when their job starts. They can claim for travel and accommodation until they have made permanent arrangements, per the attached policy.

We have emphasized to new staff that we don't want them out of pocket for work expenses but to be mindful they are using public resources when making decisions about where to stay and how to travel. We expect that people will do their best to find permanent accommodation as quickly as possible.

What about moving expenses?

Expenses for staff relocating to Victoria are covered per government policy.

Again, we have emphasized that we don't want them out of pocket for work expenses but to be mindful they are using public resources when making decisions about relocation expenses.

Where can I get information on my pension and benefits?

Please see the attached pension and benefits guide for political staff. A more detailed guide with enrolment information will be sent to all new staff, and to you for your information if you don't have it already.

For those of you with specific questions about pensions, we have asked the PSA if they can designate someone to respond instead of having people call into to the Pension Corporation. I hope to be getting a contact shortly.

What about all the forms new staff have to fill out?

A separate email will be sent that includes all the necessary forms to get new hires into the payroll system and enrolled in benefits.

I am sending for your information, in case anyone in your office has questions. Please also share this with your administrative staff team so they can assist with this if needed.

When do new staff take the Oath?

All Order in Council appointees are required to take the Political Staff Oath of Employment. We will be setting up a swearing of the Oath here in the Legislature for new staff, dates and times will come shortly.

All staff have to take the Oath within 90 days of their start date but we would like for it to happen more quickly than that.
