We are asking for each of 10 key Ministries to identify a senior representative (Minister, Deputy Minister, ADM) to join youth, service providers and representatives from other Ministries for this provincially-supported event.

This issue is close to my heart as a young person who began experiencing the trauma of homelessness as a permanent ward of the government. Before the age of 19, I went through 28 different moves in the foster-care system where I toted all my belongings in garbage bags. When I aged out, I ended up living on the streets of Kamloops. My life touched all the ministries including health, mental health, public safety, social development, education and post-secondary. My trajectory of healing and out of homelessness was based on the support of your government to find a way home, which included more than the bricks and mortar. Today I reach out to you as a young person with lived expertise of youth homelessness. The need is urgent and we must respond as we all have a responsibility and role to play in ensuring

every youth has a way home. If one government ministry takes on the role of mom and dad, we need all the other ministries to be aunties and uncles, community to be sisters and brothers, and the private sector to be cousins. We need to be family for those youth who have none. Young people are dying without a home and there is an urgent need to develop the services they need to be successful. I know firsthand the change that can be made when young people's potential are invested in, they will dedicate their lives to making a difference in others' lives. Youth with lived experience have the solution and we need you to listen.

In 2017, we founded BC Coalition to End Youth Homelessness which now includes more than 25 agencies from across BC and is growing every day to ensure geographic and service diversity and Indigenous representation. Our purpose is to develop a provincial plan to end youth homelessness with strategies for prevention, supports, housing, and information-sharing. In February 2018, I had the opportunity to meet with Minister Robinson and Minister Simpson to share our strategy to develop a provincial plan to end youth homelessness. Funding was provided with the assistance of the Homeowner Protection Office, branch of BC Housing, to support us to bring together youth, BC communities, and inter-ministerial government partners to co-create priorities for a provincial plan to end youth homelessness. Please see details and deliverables on our attached one-pager.

We ask you to stand with us rooted in action to end youth homelessness in BC. Together we can make a difference in the lives of young people who are the future of our province. Warm Regards,

I hope this e-mail finds you well and that you have had the opportunity to enjoy being in your constituency before the current sitting days.

On April 9, UBC will formally open the Indian Residential School History and Dialogue Centre. The Centre will be a place for former students and survivors of Indian residential schools and their communities to access their records, for students and the public to explore the vast archival holdings and learn about the history and legacy of the schools through interactive technology, and for university and community members to meet in focused discussions about the uses of history and other collaborative projects.

This centre is affiliated with, but independent from, the national centre at the University of Manitoba, which was created in response to the Truth and Reconciliation Commission of Canada's call to establish a National Centre for Truth and Reconciliation to hold its records. UBC supported the bid of the University of Manitoba to become the national centre with the understanding that a west coast centre would also be created.

As part of the event on April 9, I will deliver a statement of apology for UBC's involvement in the system that supported the operation of Indian Residential Schools.

Unfortunately, the timing of this event coincides with the sitting of the Provincial Legislature, precluding MLAs from attending this important event at UBC. However, the event will be webcast and should you have the opportunity you can witness the apology on the <u>event</u>

Hello Paula,

My name is Trevor Zimmer and I am a Senior Development Officer at Kids Help Phone. I am reaching out in hopes of arranging a conversation with Minister Conroy, to share some alarming trends to share with the Minister regarding the challenges young people in BC are facing and how they are utilizing our service. In particular, we found that BC youth had a higher than average proportion of returning/repeat service users, at 40% of all counselling sessions in 2017. We also saw that older youth received counselling second most frequently of any province in Canada.

Kids Help Phone has solutions to the complex challenges facing youth in BC. Our CEO, Kathy Hay, and VP of Counselling, Alisa Simon, will be in Victoria on April 13th. Kathy and Alisa would be open to meeting with the Minister to discuss how we might work with the government on solutions to some of the child mental health challenges in the province. We have significant expertise and offer real value to the conversation, as we talk to thousands of young people a year, and could share the data of what we have discovered.




