MLA Thomson has a constituent who is a licensed preschool for children aged 3 to kindergarten but runs only a morning program. She does not understand why her preschool does not qualify for the new child care fee reduction initiative. I will copy the response that she received and ask if you can find out any more information as to why her operation is not eligible. She feels this is discrimination and that she can not be competitive with other day cares.

Here is the ministry response:

> At this time, the focus of the Child Care Fee Reduction Initiative is to assist parents by reducing fees in the most expensive child care types. As licensed "under 36 months" and "3 years to Kindergarten" care are the two child care types with the highest median fees in the province, the Ministry is currently restricting eligibility to these care types.

I am the owner and operator of Dragonfly Lane Family Daycare in Saanich, s. 22 s. 22 I opened my daycare two years ago because I love working with children and wanted an opportunity to have s. 22 s. 22

The child care initiative that has been brought in by our NDP has put child care operators like myself in a very difficult position. I want my clients to be able to have a fee reduction on their child care costs, but adding more work to my day is not helpful. I currently work a nine hour day without any real breaks. Those nine hours per day do not include the time spent outside of typical daycare hours to do planning, paper work, shopping for supplies, and communicating with parents. Now, if I opt in, add to this another administrative task for the fee reduction (completing paper work and liasing with the government on a regular basis). The 10 percent increase in CCOF is not an incentive for me as I would only receive approximately twenty dollars extra per month. I do not receive the CCOF for s.22 s.22

Why is the onus on the child care provider to do extra administrative work so the families can save money – especially with little to no incentive for us? Why doesn't the government just send the reduction directly to families who register and report child care expenses during income tax season? You may argue it is for the government to insure that child care costs don't increase in an unfair way for families, yet this practice only occurs in a small number of places. Most providers are fair and want to earn an honest income.

Another setback to the program is that government would heavily control pricing. With so many other expenses increasing, especially government run entities such as BC Hydro, it is a little hypocritical to deny any modest increases in costs to families. When you actually look closely at the number of hours s s.22

s 22 . It is difficult for owners to give up control of their own income, earned from their own business.

As a small business owner I have worked hard and spent a lot of money to open my centre. I do not wish to sign a contract with the government stating how many paid holidays I can take. As well, there is no funding for any sick days a provider may need, even though it could be dangerous to children when their

provider is ill. Child care providers deserve these days as much as any other working person. I truly hope the government can reevaluate this plan with the child care providers in mind, as well as the families. After all, child care is already hard to families to find, so adding the governmental regulation and extra work that comes with it is not encouraging for any potential child care owners who would create new spaces for the children of British Columbia.

The parents in my Licensed Family Daycare will receive far less of a reduction simply because they've chosen a small environment over a group centre. Why wouldn't the government support choice, and small businesses like my own. I have 25 years of proven success in my field, and I am so disappointed that the government does not recognize that.

For full-time enrolment, you must reduce parent fees by:

• Infant/toddler care (under 36 months) -

Group \$350/month

Family \$200/month

• 3 years to Kindergarten

Group \$100/month

Family \$60/month

The NDP have implemented the Universal Child Care plan, but if you look at the numbers I have provided, you can see it is far from universal.

As a small business owner, I had hoped the fees would be the same for all centres and all families would receive the same advantages, however, that is not the case.

I urge you to bring these figures forward to the next session of parliament. I believe the NDP need to be held accountable for bringing forth an unbalanced scale for families and childcare providers.

Re: At risk of losing established child care society after 20 years.

My name is Christine McGuinness and I am the founder and society coordinator of Steps to the Future Child Care Society which is the only not for profit charitable school age care in Sooke. In December 2016 our society managed to procure a mortgage to purchase 2.5 acres of land with 2 very large, wonderful homes the we operate out of. We are licensed for 30 children in each facility with 90 children registered, a waitlist of 25 school age children and 15 children waiting for our 3 - 5 year old program to open.

In February 2017 (after we had all approvals done for our Vancouver Island Health Authority license and ready to open our 2nd facility), the District of Sooke staff put a hold on our license to operate because we do not have a business license, siting "life & safety" concerns after the building inspector only spending 10 minutes in the building. We had 4 visits from the D.O.S. fire department with written approval to operate dated Jan. 30th, 2017 and a stamp sealed "Municipal Zoning Approval" signed November 29th, 2016. This approval also states "Important- Sign off of this form indicates the Municipality has approved the above location for the specified use. It is the responsibility of the Municipality to ensure all required departments are consulted". In the D.O.S. Business License Bylaw #301 it states that as a charitable society we are exempt from needing a business license.

V.I.H.A. held up our license and we had to hire an architect to prove that the buildings were structurally sound. This report was sent to the D.O.S. staff and then we were told that we needed to get an engineers report as well.

In the meantime, our society had to pay both mortgage & rent to the School District #62 who gave us final notice to remove our programs from all the schools we operated out of. We had been asked to leave for the past 10 years but, could not find appropriate accommodations to suit our size of operations.

The "Professionals" reports & inspections cost us \$7,000.00. We were close to ruin before we even got started. What we are questioning now is that both Mr. Howat (the staff calling our licensing) and Mr. Bastone the building inspector

My name is Carol Wiens and, along with my business partner, Evelyn, are independent business owner/operator of three Licensed Childcare Facilities in the Lower Mainland called, BrightStart Children's Academy. In total we have 227 licensed spaces and we are scheduled to open a fourth facility with 110 spaces.s.22

> Over the 9 years of operation, we have experienced firsthand, that it is one's teachers and staff that makes your service meaningful for families. New facilities and fancy webcameras are welcomed extras, but at the end of the day, it is the relationship of the family to their beloved teacher. Knowing that staff are our most important resource, we developed a 3 year plan (Starting January 2017) to slowly and methodically bring up the average wage of all our teachers to a "living wage" standard. We had fee increases Jan 2017 and Jan 2018; both were announced two months ahead of time and, most importantly, both indicated to our parents that 100% of the fee increase was going back to the teachers (in the form of wages or benefits). Parents were on-board with us, especially when our staff confirmed with them, that, yes they did get a raise and yes, our benefits were increased. Related to wages somewhat is the additional problem that the supply of qualified ECE teachers is in decline. In the childcare field, the biggest challenge facing both families and operators is a high staff turnover rate, as staff are jumping from facility to facility for higher pay. We have done our best to combat this challenge by increasing wages as much as possible and providing an inviting work environment complete with professional development opportunities, social events and unlimited vacation time.

> So, while staffing and wages are my burden, I can appreciate that families are feeling the financial burden of childcare. Some type of financial relief is appropriate; however the tax dollars will only go so far and not every tax payer would agree that subsidized childcare is an enshrined right for everyone.

> When I first heard of the idea of universally affordable Childcare plan, I was hopeful that the government would be wise in how the money is spent, with consideration given to both families and operators. What I am seeing now is a poorly thought out plan that ignores the plight of the employees, the lack of qualified staff, poorly planned handouts to parents, and a complete dismissal

of personal business owners. I feel marginalized and disposable. BrightStart

I am seriously concerned over the idea that if we choose to "opt-in" to this program I would be handing over the control of the one and only revenue source we have. There is a stigma today that small business owners including daycare owners are greedy; that the owners are sitting on piles of money, without any regard for our families and staff. It appears that the government has "bought" into this myth by suddenly requiring approval of our fees. The government has not been transparent as to what criteria they will use to approve/disapprove of a proposed fee increase and this has the potential to hinder our long term goal to bring our teachers average wage up to a "living wage". I am concerned the government will reject my plan to bring my staff's wages up. The government has not even provided a workable solution for the 2% payroll hike.

Nobody wants to raise fees, however I can not continue to absorb the ever increasing expenses; staffing, sky-rocketing leases and new taxes are the primary offenders.

The information from the government has been hastily put together and contradictory at times. Most importantly there seems to be a long-term agenda that I am not privy too, yet I have the distinct feeling that the agenda DOES NOT include independent owner/operators like myself. Business owners have been left to their own assumptions and with the few facts we have, it shows the government aggressively looking to perform a hostile takeover of our businesses.

I am not sure why the government has chosen to alienate this sector of childcare providers; we are the majority and BC parents will suffer if we all end up closing shop because the government is meddling too much.

I would ask that the NDP stop alienating small business; we are the backbone of the economy. Today I have decided to opt-out until I am satisfied that the government will not be taking away my business.
