

Dear Premier Horgan, Minister Conroy and Deputy Minister Bond,

I am excited to let you know about some positive news for youth in the Cowichan Valley. For many years I have been working with child, youth and family organizations to create a Child, Youth and Family Centre in the Cowichan Valley. I know that you, Premier Horgan are aware because you also worked on this project with me (prior to being the Premier) and I know you are supportive of this model and aware of the Cowichan Communities vast community need. Although I have not been able to bring the community together for the purposes of a larger Child, Youth and Family Centre, I thought you would be happy to hear that the seeds we planted years ago have grown and we are moving forward with the development of a Youth Centre in the City of Duncan. After 3 years of working with community, the Island Savings Commission has notified me that they would like to work together with our organization (CVYS) on a renovation of the old aquatic centre to build a Youth Hub for youth and their families. This is exciting news for the youth and families of the Cowichan Valley. I believe this is very timely as the Province is supporting the development of youth hubs in many major cities in BC. This could be an opportunity for yourself and the Province to have a visible presence in the Cowichan Community and possibly could help us engage some larger stakeholders such as Children's Foundation or Foundry to get involved and invest in our community as well? We have the services, the facility and the partnerships now we will just need to raise the funds for the renovation to create a legacy of healthy youth in the Cowichan Valley.

Cowichan Valley Youth Services is a MCFD contracted agency. As you know, the Cowichan Valley has the highest rate of kids in care and highest child poverty in BC. Last year at our agency, we saw approximately 200 youth for mental health support, 34 for suicidal ideations, and 20 disclosed experiencing a significant trauma. This month alone, we have 7 youth that are experiencing unstable housing. The Cowichan community is struggling and our children and youth are experiencing the impacts. Being able to partner with local government, provincial government and community partners to provide wrap around care for youth and their families is something for us all to celebrate!

I have attached some information about our organization, Cowichan Valley Youth Services and the vision for the Youth Hub. I would like to invite you, Minister Conroy and/or Deputy Minister Bond to come and visit our organization, discuss the current situation in Cowichan Valley for children and youth and tour our new Youth Centre location. If you are able to make it to Cowichan or you would like to discuss this further, please contact me at your convenience.
